## ***Opinion***

**NOTE A - DESCRIPTION OF PLAN**

The following brief description of the Grand Lake Mental Health Center Money Purchase Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*General*

The Plan is a defined contribution plan covering all employees of Grand Lake Mental Health Center, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

*Eligibility*

Eligible employees may begin participation on the first day of each month. Employees are eligible to participate in the Plan if they have completed one year of service and are at least 21 years of age. A year of service for purposes of eligibility is a consecutive 12-month period during which the employee has 1,000 or more hours of service.

*Contributions*

The Plan provides for (a) Company contributions, equal to 6% of eligible compensation; and (b) discretionary Company contributions, which the employer will designate as qualified non-elective contributions.

Voluntary contributions by participants are not permitted by the Plan. However, participants may contribute amounts representing distributions from other qualified plans (rollovers).

*Vesting*

Participants are immediately vested in their rollover contributions plus or minus any earnings or losses thereon. Vesting of employer contributions is based upon years of service. A participant is 100% vested after 3 years of credited service. Participants are credited with one year of service after the completion of 1,000 hours during the calendar year. Participants are fully vested in employer contributions at age 55 and upon disability or death, regardless of credited service.

*Forfeited Accounts*

Forfeitures of employer contributions resulting from participant withdrawals prior to full vesting are, in accordance with the plan document, used to reduce future company contributions and to pay administrative expenses. During the years ended December 31, 2024 and 2023, forfeitures of approximately \$223,648 and \$106,859, respectively, were applied to reduce company contributions, while \$99,896 and \$36,307, respectively, were used to pay plan expenses. As of December 31, 2024 and 2023, the Plan had forfeitures available of \$10,784 and \$32,731, respectively, to be used for these purposes in accordance with the plan document.

*Participant Accounts*

Each participant's account is credited with the Company's contributions and any applicable rollover contributions, as well as allocations of the Company's discretionary contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the plan. Allocations are based on participant's compensation, account balances or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Payment of Benefits*

Participants may elect to receive either a lump-sum amount equal to the vested value of their account, a deferred annuity benefit equal to the vested value of their account, installment payments equal to the vested value of their account or leave their account balance in the Plan until age 70 ½ years. Upon separation from service other than retirement, participants may elect to receive a lump-sum equal to the value of their account or maintain their account in the Plan until age 65 (if the account is greater than \$5,000).

*Administrative Expenses*

Administrative expenses incurred in connection with the Plan are paid through the Plan or by the Plan sponsor.

**NOTE B - SIGNIFICANT ACCOUNTING POLICIES AND USE OF ESTIMATES**

*Basis of Accounting*

The financial statements of the Plan are prepared using the accrual basis of accounting. The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to use estimates and assumptions that affect the accompanying financial statements and disclosures. Actual results could differ from these estimates.

*Receivables*

Employer contributions receivable represent amounts due from the employer as of December 31, 2024 and 2023, for contributions earned by employees but not yet remitted. As of December 31, 2024 and 2023, the receivables totaled \$1,626,419 and \$2,327,599, respectively. The Plan recognizes these amounts when a formal commitment to fund exists and does not maintain an allowance for credit losses, as all amounts are considered fully collectible.

*Investment Valuation and Income Recognition*

Investments are stated at fair value. Securities traded on a national securities exchange are valued at the last reported sales price on the last business day of the year. Investments traded in an over-the-

counter market and listed securities for which no sale was reported on the last day of the plan year are valued at the last reported bid price. All employer and employee contributions are invested under the direction of the participant. The board of directors determine the Plan's valuation policies utilizing information provided by the investment custodians. See Note D for discussion of fair value measurements.

Interest and dividends are recorded on an accrual basis. Gains and losses resulting from the sale of investments are differences between the average cost of specific investments sold and proceeds received. Transactions are recorded on the settlement date basis.

*Payments of Benefits*

Benefits are recorded when paid.

*Administrative Expenses*

Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Investment related expenses are included in net appreciation of fair value of investments.

*Uncertain Tax Positions*

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements as of December 31, 2024 or 2023. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE C - CUSTODIAN CERTIFICATIONS**

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Life Insurance Company and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company ("Principal"), the custodians of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

- Investments at fair value
- Net appreciation in fair value of investments
- Dividends and interest
- Schedule of assets (held at end of year)

The Plan's independent public accountant did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

**NOTE D - FAIR VALUE MEASUREMENTS**

FASB ASC 820-10-50-2 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820-10-50-2 are described below:

*Basis of Fair Value Measurements*

- Level 1 Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2 Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3 Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Guaranteed Interest Accounts:* Valued at fair value by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer. The guaranteed interest accounts promise contract value for a benefit event (termination, death, disability, and retirement); however, there is a possible market value adjustment when funds are withdrawn prior to maturity. Therefore, the guaranteed interest accounts are not considered benefit-responsive and are valued at estimated fair value as determined by Principal.

*Mutual Funds:* Valued at quoted market price per share of the fund on the last business day of the Plan year.

*Pooled Separate Accounts:* Valued at the net asset value ("NAV") of units of the separate account. The NAV, as provided by the custodians, is used as a practical expedient to estimating fair value.

The NAV is based on the fair value of the underlying investments held by the account less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the separate account, the investment advisor reserves the right to temporarily delay withdrawal from the account in order to ensure that securities liquidations will be carried out in an orderly business manner.

The following tables present by level, within the fair value hierarchy, the Plan investment assets at fair value, as of December 31, 2024 and 2023. As required by FASB ASC 820-10-50-2, investment assets are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement.

**NOTE E - TAX STATUS**

The Plan has adopted a pre-approved plan document sponsored by Principal Life Insurance Company. The Plan has received an opinion letter dated March 31, 2014, from the Internal Revenue Service as to the Plan's qualified status. The volume submitter plan opinion letter has been relied upon by the Plan. Although the Plan has been amended since receiving the opinion letter, the plan administrator and tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax exempt.

**NOTE F - CONTRACT WITH INSURANCE COMPANY**

The Plan entered into investment contracts with Principal Life Insurance Company. Principal Life Insurance Company maintains a portion of the contributions in guaranteed accounts. The accounts are credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Principal Life Insurance Company. The guaranteed accounts are included in the financial statements at fair value.

**NOTE G - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate participation in the Plan at any time subject to the provisions of ERISA. In the event of full or partial termination of the Plan, the participants will become fully vested in the Company's contributions to their account.

Effective January 1, 2025, subsequent to year end, the Plan Sponsor approved a change in the Plan's structure from a Money Purchase Pension Plan to a 401(k) Plan. This change represents a continuation of the Plan in a different qualified plan form and does not constitute a plan termination. Accordingly, no full or partial termination of the Plan occurred during the years ended December 31, 2024 or 2023. See Note J for discussion of plan change.

#### **NOTE H - RISKS AND UNCERTAINTIES**

The Plan provides for investments in various investment securities, which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is possible that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### **NOTE I - RELATED-PARTY TRANSACTIONS**

Certain Plan investments are shares of pooled separate accounts and guaranteed interest accounts managed by Principal. Principal is a custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in the fair value of investments, as they are paid through revenue sharing rather than direct payment.

As described in Note B, the Plan made direct payments to the third-party administrator of \$115,736 and \$53,098 for the years ended December 31, 2024 and 2023, respectively, which were not covered by revenue sharing. In addition, the Plan made direct payments to an investment advisor of approximately \$99,145 and \$52,514 for the years ended December 31, 2024 and 2023, respectively. The Plan also made payments to the plan recordkeeper of \$8,796 and \$6,109 for the years ended December 31, 2024 and 2023, respectively. The Company pays directly any other fees related to the Plan's operations.

#### **NOTE J - SUBSEQUENT EVENTS**

Effective January 1, 2025, the Plan Sponsor approved a change in the Plan's structure from a Money Purchase Pension Plan to a 401(k) Plan. This change was made to increase employee participation and reduce administrative burden. The financial statements as of and for the year ended December 31, 2024, do not reflect the impact of this change, as it occurred subsequent to the balance sheet date. Management has evaluated subsequent events through February 25, 2026, the date the financial statements were available to be issued, and has determined that no other events require disclosure.
