INDEPENDENT AUDITOR'S REPORT

Board of Trustees
SEIU Local 2015 Long Term Care Workers Health Trust Fund

Opinion

We have audited the accompanying financial statements of SEIU Local 2015 Long Term Care Workers Health Trust Fund (the Fund), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits and benefit obligations of SEIU Local 2015 Long Term Care Workers Health Trust Fund as of May 31, 2025 and 2024, and the changes in its net assets available for benefits and changes in its benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.


Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTES TO FINANCIAL STATEMENTS

YEARS ENDED MAY 31, 2025 AND 2024

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the SEIU Local 2015 Long Term Care Workers Health Trust Fund (the Fund) provides only general information. Participants should refer to the Trust Agreement, Summary Plan Description, and the respective Memorandums of Understanding, collective bargaining agreements, or Participation Agreements with participating employers for a complete description of the Fund's provisions.

General

The Fund provides health benefits to participating employees in the In-Home Supportive Services industry of California, whose employers are required by contract to pay contributions to the Fund, as well as certain dental and other benefits to other bargaining unit members in the In-Home Supportive Services industry who make employee contributions. The Fund was established on June 1, 2006. The Fund is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Fund provides benefits (Dental, Vision, Life, Accidental Death and Dismemberment (AD&D), Accident, and Legal) to all eligible members. Eligible members include all SEIU Local 2015 (Local 2015) dues-paying members in good standing with the union with a signed membership card on file. Through August 31, 2024, eligibility included both Regular and Associate Members. Effective September 1, 2024, the Board of Trustees approved a motion to eliminate benefits for Associate Members.

Coverage commences on the first of the following month after enrollment submission, so long as the member enrolls between the first and the fifteenth of the month. Coverage commences on the first of the second month if the member enrolls from the fifteenth through the thirty-first of the month.

Employees working in certain counties become eligible for employer-paid Dental and Vision benefits on the first day of the calendar month which follows two consecutive months with at least 25 paid hours of work for a contributing In-Home Supportive Services employer during each month. Eligibility terminates as of the last day of the second consecutive month in which an employee does not have at least the required hours paid.

Dental claims of active participating members are processed and paid by MetLife under group insurance contracts with the Fund. Vision claims of active participating members are provided through MetLife.



NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Life and AD&D insurance claims of active participating members are processed and paid by Anthem Blue Cross. Standard accident claims are processed and paid by MetLife. Legal advice and representation for members in good standing is provided by Hyatt Legal Plans, Inc.

Contributions

Participating employers contribute to the Fund and related Trust pursuant to memorandums of understanding and/or participation agreements between the employers and the SEIU Local 2015. During the year, bargaining unit members participating in the dental benefit who did not participate in the vision benefit offered through the Fund made contributions through payroll deductions, except in certain circumstances where those contributions were waived by the Fund.

Other

It is the intent of the Fund's sponsor, Local 2015, to continue the Fund in full force and effect. The Fund sponsor has the right to terminate the Fund or benefit programs offered by the Fund. In the event of termination of the Fund, the assets of the Fund shall first be used to satisfy or to make provisions to satisfy the obligations of the Fund. Any assets remaining must be used or paid for the continuance of one or more of the benefits provided by the Fund until such monies have been exhausted or distributed to the participants.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Fund are prepared using the accrual method of accounting in accordance with U.S. generally accepted accounting principles. Under this basis, revenue is recognized when earned and expenses are recognized when incurred, except for the payment of benefits.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments - Investments are carried at fair value. The fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recognized on a trade-date basis. Interest income is recognized on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation in fair value of investments includes the Fund's gains and losses on investments bought and sold during the year, as well as on investments held at year-end.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Employer and Participant Contributions Receivable - These line items represent amounts due from participating employers and participants for contributions owed to the Fund for health benefit coverage. No allowance for expected credit losses is considered necessary at May 31, 2025 and 2024.

Benefits - Benefits are recognized when paid.

Administrative Expenses - Administrative expenses are all paid directly by the Fund.

New Accounting Pronouncement Adopted - During the year ended May 31, 2025, the Fund adopted the provisions of Accounting Standards Update 2025-05, *Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses for Accounts Receivable and Contract Assets* (the Update). The Update provides (1) all entities with a practical expedient and (2) entities other than public business entities (PBEs) with an accounting policy election when estimating expected credit losses for current accounts receivable and current contract assets arising from transactions accounted for under Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 606, Revenue from Contracts with Customers. The Fund adopted the new standard effective June 1, 2024, using the prospective approach. The Fund has elected to use the practical expedient to assume that current conditions as of the statements of net assets available for benefits date do not change for the remaining life of the asset and the accounting policy election to consider subsequent collection activity after the balance sheet date but before the Fund's financial statements are available to be issued.

NOTE 3. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Fund had a receivable of \$977,719 and \$918,493 at May 31, 2025 and 2024, respectively, from Local 2015, which consisted of insurance premiums received by Local 2015 and not yet remitted to the Fund.

The Fund also pays certain investment and administrative fees directly to service providers. These transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules of ERISA.

NOTE 4. TAX STATUS

The Fund is intended to qualify under Section 501(c)(9) of the Internal Revenue Code (IRC) and, therefore, is not subject to income tax. The Fund obtained a favorable tax determination letter from the Internal Revenue Service on January 4, 2008, stating that the Fund, as then designed, was in compliance with the applicable requirements of the IRC. The Fund has also received a favorable tax determination letter from the state of California. The Fund has been amended since receiving the determination letters. The Fund sponsor believes that the Fund, as amended, continues to qualify and to operate in accordance with applicable provisions of the IRC. Therefore, no provision for federal or California income taxes has been included in the Fund's financial statements.

NOTE 5. INVESTMENTS AND FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Fund has the ability to access.

Level 2 Inputs to the valuation methodology include other significant observable inputs including:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 7. UNISURED CASH

The Fund maintains its cash and cash equivalents primarily with one financial institution. Total cash balances are insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per bank. At times, the balance held by the Fund may exceed the balance insured by the FDIC. At May 31, 2025, total uninsured cash balances were approximately \$828,000.
