## Report of Independent Auditors

The Board of Directors, Plan Administrator and Participants  
The National Hockey League Pension Society

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the National Hockey League Pension Plan for United States Off-Ice Employees (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes (collectively referred to as the “financial statements”).

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the years then ended, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **1. Description of the Plan**

The National Hockey League Pension Plan for United States Off-Ice Employees (the Plan) is a multiple employer non-contributory defined contribution plan sponsored by the National Hockey League and its Member Clubs (together, the Sponsors) that covers certain off-ice employees of the Sponsors residing in the United States (the Participants). The Plan was established effective May 1, 1966, and commenced operations on that same date. The Plan was last amended and restated on July 1, 2024. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA) and is administered by the National Hockey League Pension Society (the Society).

An eligible employee other than a scout can participate in the Plan as of the first day of a Plan year after completing an hour of service. A scout can participate in the Plan after completing at least 1,000 hours of service. An eligible employee includes coaching staff employee, hockey executive, scout, assistant coach, assistant trainer, head trainer, director of sports performance or minor league staff employee who is not a highly compensated employee and not a leased employee.

Employer contributions are specifically defined and based on the Participant's job classification and years of participation. Contributions are made on a monthly basis, and are subject to limitations imposed by the Internal Revenue Code (the Code).

Prior to December 31, 2020, participant may borrow from their participant accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. No more than two loans may be outstanding at any time. Loan terms may not exceed five years. The loans bear interest at a rate commensurate with local prevailing rates at the date of issuance. Loan principal and interest are repaid not less frequently than quarterly.

The Participants' interests in the Sponsors' contributions are payable upon retirement, death or cessation of employment, all subject to the terms of the Plan. Participants become vested on the earliest of: the completion of a two-year period of service; the normal retirement date, if such date occurs during a period of service; and death, if the participant dies during a period of service. Effective November 1, 2024, a vested participant who has reached his severance from service date may elect to receive his or her account balance as a single lump sum payment as soon as administratively practicable. A participant whose vested account balance does not exceed \$1,000 and have not commenced payments following his or her severance from service date or death will automatically receive a lump-sum distribution equal to his or her vested account balance. A participant whose vested account balance is between \$1,000 and \$7,000 will be automatically paid

in a lump-sum distribution or as a direct rollover to an eligible individual retirement account in the participant's name.

Forfeited accounts under the Plan may, at the discretion of the Society, be used to pay expenses incurred in the administration of the Plan and, to the extent not so used, shall reduce future Sponsors' contributions under the Plan.

Each participant's account is credited with the Sponsors' contributions and allocations of Plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of his or her respective elected investment options. Participants can elect to have their accounts invested amongst any of the available funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Although it has not expressed any intent to do so, the Board of Directors of the Society has the right under the Plan to discontinue contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination, each participant shall be fully vested and the Sponsors shall not be required to make further contributions to the Plan.

Participants should refer to the Plan document for a more complete description of the Plan's provisions. The foregoing description of the Plan provides only general information.

### **2. Significant Accounting Policies**

#### **Basis of Presentation**

The accompanying financial statements have been prepared on the accrual basis of accounting.

#### **Investments**

##### *Valuation*

In accordance with Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, investments are stated at fair value. See Note 3 for further discussion of fair value measurements.

#### *Investment Income*

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net realized and unrealized appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Use of Estimates**

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

#### **Cash**

Cash is held at a TD Bank that earns interest income.

#### **Notes Receivable From Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned.

### 3. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

*Level 1:* Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

*Level 2:* Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability.

Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the asset or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

*Level 3:* Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measure in its entirety.

The mutual funds of this Plan (except for the Stable Value Fund) are considered Level 1. The fair value is based on unadjusted quoted prices in an active market.

The primary investment objective of the Stable Value Fund is to seek the preservation of principal and to provide dividend income reasonably obtained under prevailing market conditions and rates. The fund is valued at Net Asset Value (NAV), which is based on the value of the underlying securities, and such NAV is deemed to have a readily determinable fair value. There is a daily published price for the fund, and accordingly, the Stable Value Fund is presented at Level 1 within the fair value hierarchy.

### **4. Investments**

All investment information disclosed in the accompanying financial statements and supplemental schedule including investments and notes receivable from participants at June 30, 2025 and 2024, and net realized and unrealized appreciation in fair value of investments, interest and dividend income, and other income, for the years then ended, was obtained or derived from information provided to the Society and certified as complete and accurate by Empower Trust Company, LLC (the custodian of the Plan).

### **5. Income Tax Status**

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated September 8, 2013, stating that the Plan is qualified under Section 401(a) of the Code, and therefore, the related trust is exempt from taxation. Subsequent to this determination by the IRS, the Plan was amended and restated. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Any necessary steps to bring the Plan's operations into compliance with the Code will be executed by the Plan administrator. The Society believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan, as amended and restated, is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **6. Administration Expenses and Party-in-Interest Transactions**

The expenses of administering the Plan may be paid out of the Plan assets if the Sponsors do not pay such expenses directly. The Society also charges to the Plan other expenses relating to the administration of the Plan, but only to the extent at which they may be funded by forfeitures from the Plan. Certain expenses of the Plan have been paid by the Sponsors and, accordingly, are not included in the financial statements of the Plan. Each quarter, certain investment options pay revenue credits to the Plan recordkeeper, Empower Retirement, LLC, which are then allocated to the participants who invested in those specific investment options. Occasionally, net expenses can

become negative if the revenue credits are greater than the administration fees. Revenue credits received in excess of administration fees incurred are presented as other increase in the statements of changes in net assets available for benefits.

### **7. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect Participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **8. Subsequent Events**

The Society has evaluated subsequent events through January 21, 2026, the date the financial statements were available to be issued.
