Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the accompanying financial statements of Hornblower Puerto Rico Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note A to the financial statements, is complete and accurate.

Opinion on the 2024 Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of Hornblower Puerto Rico Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the 2024 financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTE A – DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of Hornblower Employees Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement and Summary of Plan Description (SPD) for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with cash or deferred arrangement covering all full-time employees of HMS Ferries Puerto Rico LLC (the Employer) residing in Puerto Rico who have three months of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Hornblower Group Retirement Committee is responsible for oversight of the Plan.

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that may affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities and of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Financial Information Certified as permitted by 29 CFR 2520.103-5

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, and was obtained and derived from information supplied to the plan administrator and certified as complete and accurate Banco Popular de Puerto Rico (the Trustee and Custodian) following Section 29 CFR 2520.103-5. The following information included in the accompanying financial statements and supplemental schedules was obtained or derived from data that has been prepared and certified as complete and accurate:

- Investments at fair value
- Notes receivable from participants
- Net appreciation (depreciation) in fair value of investments
- Fair value measurements included in Note B
- Schedule of Assets (Held at End of Year)

**NOTE A – DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING
POLICIES (CONTINUED)**

Contributions

Each year, employees can contribute on a pretax basis up to the maximum amount allowed under Puerto Rico Treasury Code. The maximum pre-tax participant contributions for the year ended December 31, 2024 was \$15,000. Participants aged 50 years or older are allowed to make additional pre-tax catch-up contributions over any other regulatory limit in amounts up to \$1,500. The plan provides for Employer discretionary Matching Contributions, determined annually, but contributed on each payroll. Effective January 1, 2022, the Employer makes matching contributions equal to 100% of the first 4% of eligible compensation as defined in the Plan document. Additional profit-sharing amounts may be contributed at the option of the Employer, not to exceed the lesser of the Employer's Net Profits or 25% of Participant's compensation in any Plan Year. The Employer did not make any profit sharing contributions for the year ended December 31, 2024. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan as presented in the 2024 Schedule H, Line 4i – Schedule of Assets (Held at End of Year).

For the year ended December 31, 2024, total annual contributions made by the Employer and participants are limited to the lesser of \$66,000 or the total compensation paid by the Employer to the participant during the Plan year, as provided in the Code, Section 1081.01 (a)(11)(B)(i).

Vesting

Participants are immediately vested in their contributions, rollover contributions plus actual earnings thereon. Vesting in the Employers' matching contribution portion of their accounts plus actual earnings thereon is based on years of continuous service since plan inception. A participant is 33% vested after one year of credited services, 66% vested after two years of credited services, and 100% vested after three years of credited services.

Participants' Accounts

Individual accounts are maintained for each of the Plan's participants to reflect participant and matching contributions as well as the participants' share of the Plan's income and any related expenses. Allocations are based on the proportion that each participant's account balance bears the total of all participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participants' vested accounts. Forfeited balances will be reallocated to participants in the same manner as employer contributions or used to cover plan expenses.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is lower. The notes are secured by the balance in the participants' accounts and bear interest at prime rate plus 1% on the date of the loan. The notes are payable over a period not to exceed 5 years, or 10 years if used for the purchase of primary residence. Participants may have only one note outstanding at any time. Principal and interest are paid ratably through payroll deductions.

**NOTE A – DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING
POLICIES (CONTINUED)**

Notes Receivable from Participants (Continued)

Notes that are not repaid to the plan within 60 days will be classified as in default and as deemed distribution. The defaulted note could then either be declared distributed to the participant, which involves payment of taxes or offset against future distributions.

Notes receivable are presented in the statement of net assets available for benefits at their unpaid principal balance plus accrued interest. Interest revenue on the notes is fully recorded at the time of the disbursement and presented in the statement of changes in net assets available for benefits.

Forfeited Accounts

Forfeitures of employer contributions may be (i) allocated to participants' accounts for the plan year, in proportion to each participant's compensation relative to the total compensation of all participants for that year, or based on the ratio of each participant's account balance to total plan assets; (ii) used to reduce future employer contributions; or (iii) applied to offset plan administrative expenses, as determined annually by the Employer. There were no forfeitures during the years ended December 31, 2024, and 2023.

Payment of Benefits

The Plan provides for normal retirement benefits upon reaching the age of 65 and has provisions for in-service, hardship, disability, death, and termination benefits for those participants who are eligible to receive such benefits. The normal form of benefit under the Plan is a lump sum distribution, however, the participants may elect periodical payments (monthly, quarterly, semiannual or annual installments of substantially equal amounts over a period of not to exceed 10 years) as an optional form of distribution. In addition, if the participant terminates employment with the Employer before reaching the normal or early retirement age, becoming disabled or dying, participants shall be allowed to apply for an early distribution of the plan benefits, equal to the value of the participants vested interest in their account as a lump-sum distribution or on an installment basis if the participant reached retirement age. Benefits to participants are recorded when paid.

Investment Valuation and Income Recognition

Shares of registered investment companies are valued at quoted market prices, which represent the net asset value of shares held by the Plan for each investment fund at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded when earned.

Net appreciation or depreciation in the value of investments includes realized gains or losses on investments sold as well as the change in appreciation from one year to the next.

NOTE A – DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Administrative Expenses

Administrative expenses include participant notes receivable fees, monthly and quarterly assets fees, quarterly contract charges and withdrawal charges. Participants who take loan from the Plan incur a one-time fee for establishing the note receivable as well as a quarterly administration fee. Expenses that are paid and absorbed by the Employer are excluded from these financial statements.

NOTE B – FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (FASB) Accounting Standard Codification (ASC) (Topic 820): *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement).

The three levels of the fair value hierarchy under FASB ASC Topic 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value.

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The fair value information included in the table below and in the supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the Trustee and Custodian for the year ended December 31, 2024.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1. There have been no changes in the methodologies used at December 31, 2024, and 2023.

The carrying amounts of investments and notes receivable from participants approximate their fair values because of the relatively short-term maturities of these financial instruments.

NOTE D – RISK AND UNCERTAINTIES

The Plan provides various investment options exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the statement of net assets available for benefits.

NOTE E – RELATED PARTY TRANSACTIONS

Banco Popular de Puerto Rico, as custodian, record keeper and trustee, and CAPTRUST Financial Advisors, as plan advisors, are each a party-in-interest as defined by ERISA. Therefore, these transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

NOTE F – NONDISCRIMINATION TEST

The Plan passed the Average Deferral Percentage (ADP) test during the year ended December 31, 2024, and 2023; therefore, no corrections were necessary.

NOTE G – PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become 100% vested in the employer contribution.

NOTE H – INCOME TAXES

The Plan, as qualified under Section 1081.01 (a) of the 2011 Puerto Rico Internal Revenue Code, as amended, is exempt from income and other taxes.

The Puerto Rico Treasury Department has determined and informed the Employer under a letter dated July 20, 2022, that the Plan and related trust are designed in accordance with the applicable sections of the PR Code and therefore is exempt from income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I – CONTRIBUTIONS REMITTANCE

During the year ended December 31, 2024, several remittances were considered delinquent and will be reported in the appropriate schedule of Form 5500. Management is in the process of taking all required corrective as well as preventive actions including but not limited to the payment of lost earnings.

NOTE J – SUBSEQUENT EVENTS

The Plan evaluated subsequent events through December 17, 2025, the date on which the financial statements were available to be issued, and no additional material subsequent events were identified requiring disclosure or adjustments in the financial statements of the Plan.
