Opinion

We have audited the financial statements of Multifamily Insurance Trust Health and Welfare Benefits Wrap Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA). The financial statements comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended May 31, 2025, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of the Plan as of May 31, 2025 and 2024, and the changes in its net assets available for benefits for the year ended May 31, 2025, in accordance with accounting principles generally accepted in the United States of America (GAAP).

Basis for Opinion

Notes to Financial Statements

1. Description of Plan

The following description of the Multifamily Insurance Trust Health and Welfare Benefits Wrap Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a fully insured, multiple-employer welfare plan established by the Multifamily Insurance Trust (the Company). The Plan provides certain health and medical benefits to eligible employees of GoldOller Management Services, LLC; SueHope Realty; Goldstein Management Inc.; Madison Parke, LLC; Multifamily Management Philadelphia, LLC; Multifamily Management Services, LLC; Rittenhouse Realty Advisors, LLC; and Rittenhouse Funding Associates, LLC (collectively, the Participating Employers). The Plan was established as a Voluntary Employee Benefits Association (VEBA) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility

Full-time employees of the Participating Employers who are employed an average of at least 30 hours of service per week are eligible for coverage.

Funding and Contributions

Plan participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. The Company makes contributions to the Plan as needed to fund premiums in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

Plan Benefits

The Plan provides for covered medical, dental, vision, long-term disability, life insurance, and accidental death and dismemberment benefits. The aforementioned benefits are subject to applicable deductibles, co-payments, and other limitations and restrictions. The Plan also provides for coverage of participants' spouses, dependents, and beneficiaries.

The Plan fully insures all benefits. The Company provides medical benefits via a minimum premium funding arrangement and purchases annual insurance contracts for all other insured benefits. Premiums for all insured benefits were paid to the insurance companies from the assets of the VEBA trust.

Administrative Expenses

All administrative expenses are paid for by the Plan.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment

securities will occur in the near term and such changes could materially affect the amounts reported in the statements of benefit obligations and net assets available for benefits. The benefit obligations are reported based on certain assumptions pertaining to estimated reports of claims incurred but not reported, and all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the Plan's management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities in the financial statements. Accordingly, actual results could differ from those estimates.

Concentration of Credit Risk

Cash and cash equivalents are maintained at financial institutions, and, at times, balances may exceed federally insured limits. All of the Plan's noninterest-bearing accounts were insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000 per depositor at each financial institution. Amounts on deposit in excess of federally insured limits as of May 31, 2025 and 2024 totaled \$368,675 and \$0, respectively. The Plan has not experienced any losses related to these balances.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its custodian. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Cash and Cash Equivalents

The Plan treats money market accounts and all highly liquid investments, purchased with maturities of three months or less, as cash equivalents. The cash and cash equivalents are used for operational purposes and are not considered to be short-term investments.

Premiums Paid

Premiums paid by either the Company or the Plan are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Premiums payments due to the insurance companies that have not been reimbursed by the Plan are recorded as claims payable in the Plan's benefit obligations.

5. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

U.S. Treasury Obligations - U.S. Treasury obligations are valued based on quoted market prices of identical instruments in active markets.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify the benefits provided to, and contributions required of, participants to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform manner toward the provision of benefits for or on account of the participants. Each Participating Employer may cease to participate in the Plan with respect to its employees or former employees by resolution of its governing body.

7. Related Party Transactions

Certain employees and officers of the Company, who are also participants in the Plan, perform administrative services for the Plan at no cost. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

8. Tax Status

The Internal Revenue Service (IRS) issued an exemption letter dated August 17, 2017 that the Plan meets the requirements of Section 501(c)(9) of the Internal Revenue Code (the Code) and, therefore, is exempt from federal income taxes under Section 501(a) of the Code. The Plan is required to operate in conformity with the Code to maintain its tax-exempt status. The Plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal, state, and/or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Subsequent Events

For purposes of determining the effect of subsequent events on these financial statements, Plan management has evaluated events through March 2, 2026, the date on which the financial statements were available to be issued.

Effective June 1, 2025, the Plan switched service providers and all Plan benefits are now self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by either the Plan's VEBA trust or the general assets of the Company. Despite the Plan's utilization of third-party claim's processors, ultimate responsibility for payments to providers and participants is retained by the Plan.
