## Independent Auditor's Report

To the Trustees  
Plumbers Local Union No. 200 Welfare Fund

### **Opinion**

We have audited the financial statements of Plumbers Local Union No. 200 Welfare Fund, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits - modified cash basis as of June 30, 2025 and 2024 and the related statements of changes in net assets available for benefits - modified cash basis for the years then ended and the statements of plan's benefit obligations - modified cash basis as of June 30, 2025 and 2024 and the related statements of changes in plan's benefit obligations - modified cash basis for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits - modified cash basis as of June 30, 2025 and 2024 and the changes in net assets available for benefits - modified cash basis for the years then ended and the benefit obligations - modified cash basis as of June 30, 2025 and 2024 and the changes in benefit obligations - modified cash basis for the years then ended, of Plumbers Local Union No. 200 Welfare Fund in accordance with the modified cash basis of accounting described in Note 2.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Plumbers Local Union No. 200 Welfare Fund and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Emphasis of Matter - Basis of Accounting**

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2, and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Plumbers Local Union No. 200 Welfare Fund's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***



### 1. DESCRIPTION OF PLAN

The following description of the Plumbers Local Union No. 200 Welfare Fund (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**General** - The Plan was established on January 1, 1993. The Plan is a health and welfare plan established under the provisions of an Agreement and Declaration of Trust between Plumbers Local Union No. 200 (the Union) and various employers in Nassau and Suffolk counties of New York (Employers). An employee is eligible to participate in the Plan on the first date an employer becomes obligated to make a contribution to the Plan on the employee's behalf, based on collective bargaining agreements. All employees of Employers under a collective bargaining agreement with the Union, subject to that agreement, are eligible to participate in the Plan, which is considered covered employment.

Certain plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of ERISA, as amended.

**Benefits** - The Plan provides health benefits (medical, prescription, dental, vision, and life insurance) and disability benefits to eligible participants that their eligible covered dependents. Additionally, retired participants of the Plan are entitled to similar health benefits (in excess of Medicare coverage), provided they have satisfied eligibility requirements, as defined by the Plan. In addition, the Plan offers COBRA to members separated from employment.

All plan benefits, except for life insurance and retiree prescription benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processors under administrative services-only arrangements. The Plan pays claims directly to or on behalf of participants with assets of the Plan's VEBA trust. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

The Plan fully insures life insurance benefits and retiree prescription benefits. The Plan purchases annual insurance contracts for these insured benefits. Premiums for life insurance benefits and retiree prescription benefits are paid to the provider by the Plan. Premiums for all insured benefits are paid from assets of the VEBA trust.

**Stop loss coverage** - The Plan has entered into a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

**Contributions** - In accordance with labor agreements in effect, Employers are required to contribute from \$10.35 to \$21.25 per hour worked based on the participant's title and class of work performed.

**Termination** - The trustees expect and intend to continue the Plan indefinitely, but reserve the right to amend or terminate it as provided by the applicable Trust Agreement and plan provisions. If the Plan is terminated, plan assets will be allocated to provide benefits to those eligible under the terms of the Plan in the order of priority specified in the Plan and as otherwise required by law.

**Benefit obligations** - The Plan's excess of benefit obligations over net assets available for benefits relates primarily to the postemployment and postretirement benefit obligations. The funding of this obligation is not covered by the contribution rate provided by the collective bargaining agreements. It is expected that the excess will be funded through future increases in the collectively bargained contribution rates and possible future amendments to benefits provided under the Plan.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of accounting** - The accompanying financial statements of the Plan have been prepared on a modified cash basis, which is a comprehensive basis of accounting other than accounting principles generally accepted in the United States of America (U.S. GAAP).

The modified cash basis used by the Plan is the cash receipts and disbursements basis of accounting modified to report investments at fair value. This basis of accounting differs from U.S. GAAP, because (i) contributions are recorded when received rather than when earned, (ii) administrative expenses are recorded when paid rather than when incurred, and (iii) right-of-use assets and lease liabilities are not recognized.

**Investments** - Investments are stated at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value (see Note 9). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest and dividend income is recorded as received. The cost of the investments sold is determined on the specific identification method, and realized gains or losses are reflected in net appreciation in fair value of investments. Refer to Note 3 for a discussion of fair value measurements.

**Tax status** - The VEBA trust funding certain benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS), dated July 6, 1978, stating that the trust is tax exempt under the provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time, the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2025 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the organization has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of June 30, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Use of estimates in financial statement presentation** - The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and the disclosure of contingencies, if any, at the date of the financial statements, and additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Postretirement benefits** - Although the Plan has calculated and reported a postretirement benefit obligation, this amount is based on the assumption that the Plan will continue in its current form and that the trustees will continue to provide benefits to retired participants. However, such benefits do not vest, and the trustees reserve the right to amend the Plan to modify or discontinue any benefits. The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to an employee's service rendered to the date of the financial statements, reduced by actuarial present value of contributions expected to be received in the future from the current plan participants. Postretirement benefits include future benefits expected to be paid to or for (i) currently retired or terminated employees and their beneficiaries and dependents, and (ii) active employees, and their beneficiaries and dependents, after retirement from service with the participating employers. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Plan's participating employers and from existing plan assets. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by the Plan's benefit actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

For measurement purposes, a 7.0% annual rate of increase in the per capita cost of covered health care benefits was assumed for June 30, 2025; the rate was assumed to decrease gradually over a five-year period to a long-term rate of 5%, and to remain at that level thereafter. These assumptions are consistent with those used to measure the benefit obligation for the preceding year.

The Plan and its actuaries considered the impact, if any, of the new mortality tables issued in November 2014, the RP-2014, adjusted annually, on the Plan's benefit obligation. It was determined that the Plan will not change to the RP-2014 table. The Plan and its actuaries are assessing these tables and will determine at a later date whether this will change. Currently, however, any impact is not considered to be material. The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation. The weighted-average health care cost trend rate assumptions have a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increased by one percentage point in each year, they would increase the obligation as of June 30, 2025 and 2024 by approximately \$17,691,800 and \$17,424,000, respectively.

**Medicare Part D** - To encourage employers and union plans to continue providing high-quality prescription drug coverage to their eligible retiree participants, Medicare created the Retiree Drug Subsidy Program (the RDS Program). The RDS Program provides sponsors of qualified retiree prescription drug plans, including union health funds, retiree drug subsidies if they provide coverage that is at least actuarially equivalent to the standard Medicare Part D drug benefit. The RDS Program provides plan sponsors with a tax-free subsidy payment of a percentage (28%) of allowable retiree prescription drug costs attributable to gross prescription drug costs between the cost threshold (\$295) and the cost limit (\$6,000) per qualifying covered retiree. The Plan is qualified under the RDS Program. The Plan received no Medicare Part D subsidies during the years ended June 30, 2025 and 2024.

**Jurisdiction** - Under current reciprocal agreements, employer contributions are, for the most part, returned to the home area for members working outside their "home jurisdiction." For financial statement purposes, contributions paid to other jurisdictions are reflected against contributions received when paid, and contributions received from other jurisdictions are recorded as income when received.

**Subsequent events** - The Plan has evaluated subsequent events after June 30, 2025 through February 24, 2026, the date the financial statements were available to be issued.

### 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. Based on the observability of the inputs used in the valuation techniques, the Plan is required to provide the following information according to the fair value hierarchy. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3). Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

Level 1 - Valuation is based upon quoted prices for identical instruments traded in active markets.

Level 2 - Valuation is based upon quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs supported by little or no market activity for financial instruments whose value is determined using pricing models, discounted cash flow methodologies, or similar techniques, as well as instruments for which the determination of fair value requires significant management judgment or estimation; also includes observable inputs for nonbinding single-dealer quotes not corroborated by observable market data.

The asset or liability fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

*Common stocks* - Valued at the closing price reported in the active market in which the individual security is traded.

*Real estate investment trust* - Valued at the closing price reported in the active market in which the individual security is traded.

*Mutual funds* - Valued at the closing price reported in the active market in which the individual security is traded.

### 5. COMMITMENTS

The Plan entered into a lease agreement, from July 1, 2024 through July 1, 2025, with County Plumbers, Inc. (a building corporation wholly owned by the Union) to rent office space. Under the terms of the lease, the Plan will pay \$26,890 annually. Upon termination date of the lease, it can be renewed on an annual basis. The lease has been renewed through July 1, 2026. Rent expense was \$26,890 for each of the years ended June 30, 2025 and 2024, respectively.

### 6. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan operates in a jointly administered office with the Union and other related plans. Certain administrative expenses that are common among the Union and the plans are allocated annually based upon payroll-based and agreed-upon ratios. The Plan's share of the common expenses was approximately \$433,179 and \$361,289 for the years ended June 30, 2025 and 2024, respectively. Included in such amounts are reimbursements for office space, computer services, and administrative services.

As discussed in Note 5, the Plan leases office space from County Plumbers, Inc. on an annual basis.

Certain plan investments are shares of mutual funds managed by Bank of America. Bank of America is the custodian for the Plan and, therefore, these transactions are considered as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to \$5,817 and \$5,659 for the years ended June 30, 2025 and 2024, respectively.

### 7. RISKS AND UNCERTAINTIES

At various times throughout the year, the Plan had on deposit in banks amounts in excess of Federal Deposit Insurance Corporation (FDIC) limits. The Plan has \$5,263,971 in excess of FDIC limits as of June 30, 2025.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying statements of net assets available for benefits.

For the years ended June 30, 2025 and 2024, approximately 32% and 13%, respectively, of the contribution income was received from two and one employers, respectively.

### 8. MULTIEMPLOYER PLANS

The Plan participates in the Plumbers & Pipefitters National Pension Fund (National Pension). National Pension is a multiemployer, noncontributory defined benefit pension plan. This pension plan is administered by a joint board of trustees, consisting of union trustees and employer trustees, and operates under EIN 52-6152779. The pension plan year runs from July 1st to June 30th. Employers contribute to National Pension at a fixed rate on behalf of each covered employee. Separate actuarial information regarding such pension plans is not made available to the contributing employers by the union administrators or trustees, since the plans do not maintain separate records for each reporting unit. However, the actuary certified that for the plan year beginning July 1, 2024 the Plan was not in endangered nor critical status. As discussed in Note 6, the affiliated funds reimburse the Plan their allocable share of contributions.

The Plan participates in the Plumbers Local Union No. 200 Pension Fund (the Pension Fund). The Pension Fund is a multiemployer, noncontributory defined benefit pension plan. This pension plan is administered by a joint board of trustees, consisting of union trustees and employer trustees, and operates under EIN 11-3125387. The pension plan year runs from July 1st to June 30th. Employers contribute to Pension Fund at a fixed rate on behalf of each covered employee. Separate actuarial information regarding such pension plans is not made available to the contributing employers by the union administrators or trustees, since the plans do not maintain separate records for each reporting unit. On September 28, 2024 and 2023, the actuary of the Plan certified that, for the plan years beginning July 1, 2024 and 2023, respectively, the Plan was not in endangered nor critical status. As discussed in Note 6, the affiliated funds reimburse the Plan their allocable share of contributions.

The health plan was established under the terms of participant agreement between the Union and certain other employers. The health plan provides health and other benefits to eligible participants employed in the building trades, metal trades, and pump and tank trades industries who are covered under written agreements with the Union. The health plan is administered by a board of trustees, with equal representation by the employers and the Union, and operates under EIN 11-3124836. The health plan receives contributions in accordance with collective bargaining agreements or participation agreements. Generally, these agreements provide that the employers contribute to the health plan at a fixed rate on behalf of each covered employee. As discussed in Note 6, the affiliated funds reimburse the Plan their allocable share of contributions.

The annuity plan was established under the terms of participant agreements between the Union, and certain other employers. The annuity plan provides annuity benefit disbursements to eligible participants employed in the building trades, metal trades, and pump and tank trades industries, based on work performed and contributions from employers. The annuity plan is administered by a board of trustees, with equal representation by the employers and the Union, and operates under EIN 11-3124801. The annuity plan receives contributions in accordance with collective bargaining agreements or participation agreements. Generally, these agreements provide that the employers contribute to the annuity plan at a fixed rate on behalf of each covered employee. As discussed in Note 6, the affiliated funds reimburse the Plan their allocable share of contributions.

### 9. GUARANTEED DEPOSIT CONTRACT WITH INSURANCE COMPANY

The Plan holds a portfolio of investment contracts that comprises a traditional investment contract. This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount that would be received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract's issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- (i) The Plan's failure to qualify under Section 401(a) of the IRC;
- (ii) Premature termination of contracts;
- (iii) Plan termination or merger;
- (iv) Changes to the Plan's prohibition on competing investment options; and
- (v) Bankruptcy of the plan sponsor or other plan sponsor events that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

- (i) An uncured violation of the Plan's investment guidelines;
- (ii) A breach of material obligation under the contract;
- (iii) A material misrepresentation; and
- (iv) A material amendment to the agreement without the consent of the issuer.
