Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Class 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2023 and 2022, and the related statement of changes in net assets available for benefits for the year ended December 31, 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of December 31, 2023 and 2022, and for the year ended December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the *Auditor’s Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Note 1—Description of the Plan

The following description of the Class 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution profit-sharing plan established on October 1, 2021 by Class Technologies, Inc (the “Company” or “Employer” or “Plan Sponsor”) covering substantially all members and full-time employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Administrative Committee, appointed by the Company, has the responsibility for administration of the Plan. The assets of the Plan are held by Principal (the “qualified institution”).

Eligibility – All employees excluding collective bargaining (union) employees are eligible to participate in the Plan upon attaining age 21 and completion of 90 days of service. Participants must be employed by the Employer on the last day of the Plan year to be eligible for any profit-sharing contributions.

Contributions – The Plan allows for employee contributions under Section 401(k) of the Internal Revenue Code (“IRC”). Employees can contribute up to 100% of eligible compensation, not to exceed IRC limits, which is \$22,500 for 2023. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also elect to defer Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. The Company can also make a discretionary match contribution, profit-sharing and nonelective contributions. No discretionary match contributions, profit-sharing or nonelective contributions were made by the Company during the years ended December 31, 2023 and 2022.

Participant Accounts – Each participant’s account is credited with participant contributions and Employer matching, if applicable, and an allocation of Employer profit-sharing and nonelective contributions and Plan earnings and charged with payment of benefits and an allocation of Plan losses, and expenses based on account balances, as defined. Each salaried participant who is employed by the Company as of the end of the Plan year and meets the eligibility requirements participates in the allocation of the Company’s profit-sharing contributions and of forfeitures of terminated participants’ nonvested accounts.

Investment Options – Participants direct the investment of contributions into various investment options offered by the Plan. As of December 31, 2023, the Plan offers pooled separate accounts, mutual funds, collective trust funds, and a guaranteed investment fund as investment options for participants. Participants may change or transfer their investment options at any time via telephone or the Internet.

Vesting – Participants are immediately vested in their contributions, rollover contributions, and the earnings thereon. Participants are vested in Employer contributions based on years of continuous service. A participant is 100% vested after four years of credited service or upon death or attainment of their normal retirement date, as defined by the Plan document. Vesting percentages are based upon the following schedule:

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to the IRS maximum loan amount equal to the lesser of \$50,000 or 50% of their vested account balance unless 50% of the vested account balance is less than \$10,000, in such case, the participant may borrow up to \$10,000. Participants may have up to one note outstanding at one time and the notes are secured by the balance in the participant's account. The notes bear fixed interest rates commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions. Loan terms range from 1 to 5 years or up to 10 years for the purchase of a primary residence. As of December 31, 2023, interest rates on participant loans ranged from 9.00% to 10.25%.

Payment of Benefits – Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum distribution or installment payments equal to the value of the participant's vested account balance. If the participant's vested balance does not exceed \$5,000, the Plan requires a lump-sum distribution. Upon termination of service for other reasons, distribution of the value of the participant's vested interest in his or her account will begin as soon as possible after the participant's request. Withdrawals prior to attaining age 59½ are not permitted, except in the event of disability. Certain income tax penalties may apply to withdrawals or distributions prior to age 59½.

Note 2—Summary of significant accounting policies

Basis of Presentation – The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Use of Estimates – The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and changes therein. Accordingly, actual results could differ from those estimates.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Investment Valuation and Income Recognition – The Plan's investments (other than the fully benefit-responsive investment) are stated at fair value. The net appreciation in the fair value of investments, as reflected in the statement of changes in net assets available for benefits, consists of the gains and losses of those investments.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Administrative Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

Payment of Benefits – Benefit payments to participants are recorded upon distribution.

Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.

Fair Value Measurements – U.S. GAAP defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction value hierarchy which requires an entity to maximize the use of observable inputs when measuring fair value.

U.S. GAAP describes three levels of inputs that may be used to measure fair value:

Level 1 – Inputs to the valuation methodology are quoted prices available in active markets for identical investments as of the reporting date;

Level 2 – Inputs to the valuation methodology are other than quoted prices in active markets, which are either directly or indirectly observable as of the reporting date, and fair value can be determined through the use of models or other valuation methodologies; and

Level 3 – Inputs to the valuation methodology are unobservable inputs in situations where there is little or no market activity for the asset or liability and the reporting entity makes estimates and assumptions related to the pricing of the asset or liability including assumptions regarding risk.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The following are descriptions of the valuation methodologies used for instruments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy. There have been no changes in valuation methodologies during the years ended December 31, 2023 and 2022.

Pooled Separate Accounts – The pooled separate accounts are stated at fair value, as reported to the Plan by the Plan trustee, and based on quoted market prices of the underlying mutual funds. The unit values of the separate accounts are calculated by dividing the total value of assets of the separate accounts by the number of units in the separate accounts. For separate accounts that invest directly in mutual funds, the total value of the assets of the separate accounts are based on the net asset value (“NAV”), or the price per share, of the underlying mutual funds. The mutual funds calculate its NAV by dividing the mutual fund's net assets by the mutual fund's outstanding number of units. The methods and significant assumptions used result in a measure of fair value appropriate for financial measurement and disclosure purposes.

Mutual Funds – These investments are public investment vehicles valued using NAV provided by the administrator of the fund. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

Collective Trust Funds – The Plan invests in collective trust funds for which quoted prices are not available in active markets for identical instruments. The Plan utilizes NAV per share provided by the qualified institution as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the stable value collective trust funds, the issuer reserves the right to require 12 months' notification in order to ensure securities liquidations will be carried out in an orderly business manner.

The Plan believes its valuation methods are appropriate and consistent with other market participants; however, the use of methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Delaware Charter Guarantee & Trust Company dba Principal Trust Company, the qualified institution, has certified the following data included in the accompanying financial statements and supplemental schedule as complete and accurate:

- Investments, at fair value, guaranteed investment contract and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2023 and 2022.
- Net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2023.
- Schedule of Assets (Held at End of Year) – Form 5500, Schedule H, Part IV, Line 4i as of December 31, 2023.

The Plan’s independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

Note 5—Party-in-interest transactions

Certain Plan investments are held by the qualified institution, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. However, these transactions are exempt from the prohibited transaction rules under ERISA. Fees paid to the qualified institution amount to \$36,104 for the year ended December 31, 2023. Notes receivable from participants also qualify as party-in-interest transactions.

Note 6—Fully benefit-responsive investment contract

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with principal totaling \$18,685 and \$458 as of December 31, 2023 and 2022, respectively. The qualified institution maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the qualified institution, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Note 7—Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become fully vested in their accounts and the accounts shall be distributed to the participants or their beneficiaries under the terms of the Plan document.

Note 8—Tax status

The Company has adopted a non-standardized form for a prototype Plan sponsored by the qualified institution. The Internal Revenue Service (“IRS”) informed the prototype Plan by a letter dated June 30, 2020, that the prototype Plan and related trust constitutes a qualified plan and trust under the applicable sections of the IRC. The prototype Plan has been amended since receiving the opinion letter. However, the Plan Sponsor believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and has no income subject to business income tax and, therefore, the Plan and related trust continue to be tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2023 and 2022, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to audit by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 10—Voluntary compliance

As required by ERISA Section 2510.3-102, the Company is required to segregate and remit employee contributions to the Plan from its general assets as soon as the funds can be reasonably segregated. For the year ended December 31, 2023, there were pay periods in which contributions were not remitted on a timely basis. Contributions for these pay periods are considered prohibited transactions. Subsequent to year end, the Company intends to correct and fund the Plan for late contributions and related lost earnings from the 2023 delay in contributions.

Note 11—Partial plan termination

During 2023, the Plan experienced a partial plan termination where more than 20% of the Plan sponsor’s employees eligible under the Plan were terminated from employment, resulting in a partial plan termination. There were no employer contributions made to the Plan and all participant accounts were 100% vested resulting in no impact to the participant’s vested balances.
