This communication is to inform you that we will be unable to issue our audit report by October 15, 2025, the Form 5500 regulatory filing deadline, due to difficulties encountered in performing the audit. We consider this a serious matter because the Department of Labor's Rules and Regulations under the Employee Retirement Income Security Act of 1974 includes specific reporting requirements, and noncompliance with those requirements may have significant ramifications for Charlotte Tilbury Beauty, Inc. 401k & PS Plan.

This communication documents the matters we discussed with Nicole Porter, Director – People Operations, during a telephone conversation on September 23, 2025. We are available to meet with Plan governance to further discuss these matters and answer your questions since two-way communication between those charged with governance and our firm can provide valuable information to the audit process.

Difficulties encountered in performing the audit

We have encountered difficulties in completing our audit. We have discussed these matters with Nicole Porter, Director – People Operations. The difficulties encountered include the following:

- It was communicated during the meeting on September 23, 2025 with Nicole Porter, Director – People Operations, that CLA would be unable to complete the audit by the regulatory filing deadline due to only being engaged on September 12, 2025 to complete multiple year audits and not having sufficient evidence to complete the audits before the regulatory deadline.

Based on discussions with management, we expect to complete the audit and issue our report as soon as possible, once management and the recordkeeper provides the requested items to us.

Interim communication

This interim communication is provided pursuant to auditing standards generally accepted in the United States of America (U.S. GAAS), which requires auditors to communicate on a timely basis significant findings or issues identified during the audit. Accordingly, this communication is based on our audit procedures performed through September 24, 2025, an interim period. Because we have not completed our audit, additional findings and material weaknesses may be identified and communicated in a written communication at the conclusion of our engagement. We are providing this early communication to those charged with governance because of the significance of the matters identified and the urgency for taking appropriate timely remedial action to minimize the effects of such matters. The above matters are significant and relevant to your responsibility to oversee the financial reporting process.
