### Opinion

We have audited the financial statements of Zealandia Holding Company, Inc. Employee Stock Ownership Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Zealandia Holding Company, Inc. Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the year ended December 31, 2024, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Opinion

The information has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying supplemental schedules is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA

#### **1. Description of Plan**

The following description of the Zealandia Holding Company, Inc. Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a leveraged employee stock ownership plan (ESOP) established effective January 1, 2010, as restated January 1, 2024. The Plan covers all employees, excluding collective bargaining, union, non-resident aliens, and leased employees employees, of Zealandia Holding Company, Inc (the Company or Employer) who have completed 1 year of service and are age 21 or older. The Plan is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The Plan is administered by the Company's Board of Directors, which has appointed a Plan Committee. The Plan Committee is responsible for the performance of administrative duties required by the Plan. The Plan's assets are held in the Zealandia Holding Company, Inc. Employee Stock Ownership Trust (the "Trust"). Trustees of the Trust (the "Trustees") invest and reinvest Trust assets in Company stock or other investments as directed by the Plan Committee in accordance with the terms of the Plan agreement and Trust agreement.

##### **Contributions**

The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loans. Employee contributions are not permitted. Participants who are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year. Additional discretionary amounts may be contributed by the Company at the option of the Board of Directors. The Company made discretionary contributions of \$346,958 for the Plan year ended December 31, 2024.

##### **Dividends**

The Board of Directors may also declare dividends paid to shareholders of the Company's common stock. There were no dividends paid out for the year ended December 31, 2024.

##### **Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect a cash distribution but are limited to the amount of cash or marketable securities allocated to the participant's account or the amount of cash available for distribution. Distributions that exceed the amount of cash or marketable securities allocated to the participant's account or otherwise available for distribution will be made in the form of Company stock. If a terminated participant's vested balance is \$7,000 or less, the benefit will be distributed in the form of a lump sum payment or a direct rollover in the Plan Year following the Plan year that includes the termination date. If the value of the participant's account is greater than \$7,000, the benefit will be evenly distributed commencing with the Plan year following the Plan year that includes the termination date in annual installments. Distributions are made in cash or, if the participant elects, in the form of Company common stock plus cash for any fractional share of common stock. The amount to be distributed is based upon the immediately preceding valuation date.

##### **Voting Rights**

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by Fifth Third Bank, the custodian, prior to the time that such rights are to be exercised. The custodian is not permitted to vote any allocated share for which instructions have not been given by a participant. The Trustee is required, however, to vote any unallocated shares on behalf of the collective best interests of Plan participants and beneficiaries.

#### **Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with an allocation of the Company's discretionary contributions and, on the last day of each Plan year, an allocation of the Company's common stock shares released from the unallocated account, as well as forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated, as defined in the Plan agreement, to each participant's account based on the ratio of the participant's account balance to all participants' account balances.

#### **Vesting**

If a participant's employment with the Company is terminated for any reason other than retirement, permanent disability, or death, vesting in their contributions is based on years of continuous service. A participant is 20% vested after two years of credited service and continues to vest in increments of 20% until 100% vested after six years of credited service.

#### **Put Option**

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

#### **Forfeited Accounts**

Plan forfeitures are allocated to each participant's account based upon their proportion of the participant's units to the total units of all participants for that year. Forfeitures of terminated nonvested account balances allocated to remaining participants at December 31, 2024 and 2023, totaled \$239,296 and \$399,630, respectively.

#### **Diversification**

Diversification is offered to participants who are at least 55 years old and have participated in the Plan for at least 10 years (a Qualified Participant). During each of the first five years of eligible diversification, a Qualified Participant may withdraw up to 25% of the value of their investment in Company common stock, less any shares previously diversified, and transfer the amount as a rollover into another qualified plan or as a cash withdrawal. In the sixth and subsequent years, the percentage amount that can be withdrawn increases to 50%. The election to diversify is made subsequent to year-end based upon the shares of Company stock in the participant's account at year-end. For the year ended December 31, 2024, \$135,049 was transferred from the Plan to another qualified contribution plan sponsored by the Company.

#### **Stock Purchase**

At the end of December 31, 2016, the Plan owned 582,930 shares of Company stock, of which no shares were unallocated. In 2017, the Plan purchased 879,192 shares of Company stock for \$17,803,638 (\$20.25 per share). The purchase was funded by \$5,450,000 of cash in the Plan, \$3,550,000 in the form of a loan from the Company, and \$8,803,638 borrowed from certain lenders. See Note 4 for additional information on the loans

## **2. Summary of Accounting Policies**

#### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principal generally accepted in the United States of America ("GAAP").

#### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Cash and Cash Equivalents**

The Plan considers all cash and other highly-liquid investments with an initial maturity of three months or less to be cash equivalents.

#### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Dividends are recorded on the ex-dividend date. Cash dividends may be accumulated in the Trust or may be paid to participants. The Company shall be allowed a deduction with respect to any dividends paid on allocated shares of Company stock. Also, the Company shall be allowed a deduction for any dividends used to make payments on securities acquisition indebtedness, provided that in the case of dividends paid on allocated shares, employer securities in an amount equal to such dividends are allocated to participants. The Company shall be allowed a deduction for dividends paid only in the taxable year in which the dividends are either paid to a participant or held to make payments on securities acquisition indebtedness.

#### **Payment of Benefits**

Benefits payments to participants are recorded upon distribution. Due to lump-sum payments, installments, and accrued distributions, \$4,587, and \$955,746 remains owed to participants who had previously requested distributions as of December 31, 2024 and 2023, respectively.

#### **Expenses**

Normal brokerage charges and bank fees shall be paid by the Trust. The Company shall pay all expenses in connection with the design, establishment, or termination of the Plan. The Trust shall pay all costs of administering the Plan and the Trust unless such expenses are paid by the Company.

Certain administrative functions are performed by employees of the Company and a third-party service provider. No such employee receives compensation from the Plan. Administrative expenses paid by the Plan were \$74,377 in 2024.

#### **Subsequent Events**

Subsequent events were evaluated through February 19, 2026, the date the financial statements were available to be issued.

### **3. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

*Level 1* - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

*Company Common Stock* - Valued at estimated fair value based on an independent third-party appraisal using a combination of widely used valuation approaches, including the market and income valuation techniques. The appraiser considered inputs such as historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities, along with a discount for lack of marketability where appropriate.

The Plan recognizes transfers between the levels as of the actual date of the event or change in circumstances that caused the transfer. There were no gross transfers between the levels for the years ended December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**4. Notes Payable**

A leveraged ESOP borrows money from banks or other lenders to finance its acquisition of employer securities. Tax rules provide that employer's stock is the only collateral that the Plan may use on debt. The collateralized stock must be placed in a loan suspense account and released for allocation to participants' accounts as the loan is repaid through Company contributions to the trust fund. As the Plan makes each payment of principal and interest, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC. At December 31, 2016, the Plan had no outstanding debt.

On March 31, 2017, the Plan purchased 879,192 additional shares of the Company common stock from Chandler C. Prosser, Larry N. Prosser, and Alexandra Gritta Clayton (the "Lenders") for \$17,803,638 (\$20.25 per share). These individuals are shareholders of the Company and Clayton is a Trustee of the Trust. To fund the purchase price, the Plan used cash-on-hand of \$5,450,000, entered into a term loan agreement with the Company for \$3,550,000 (the "Company Loan"), and entered into a term loan agreement with the Lenders for \$8,803,638 (the "Lenders Loan"). Unallocated shares are collateral for the loans.

The Company Loan agreement, as amended, provided for the loan to be repaid in monthly principal and interest payments of \$19,230 over the period ending April 2037. In September 2017, the Company converted \$3,148,935 of the Company Loan to contributions into the Plan. The remainder of the loan was paid in full as of December 2018.

The Lenders Loan agreement, as amended, provides for the loan to Chandler C. Prosser of \$2,451,613 to be repaid in monthly principal and interest payments of \$27,034; the loan to Larry N. Prosser of \$2,292,822 to be repaid in monthly principal and interest payments of \$25,283; and the loan to Alexandra Gritta Clayton of \$4,059,203 to be repaid in monthly principal and interest payments of \$44,760, over the period ending April 2027. The remainder of the Alexandra Gritta Clayton loan was paid in full as of September 2020. The remaining Lenders' loan bears interest at an annual rate of 5.85%.

**5. Related-Party and Party In Interest Transactions**

The Plan's assets, which consist principally of Company common stock, are held by the Trustee of the Plan. Company contributions are held and managed by the Trustees, which invest cash received, interest, and dividend income and makes distributions to participants. All transactions between the Company and the third-party service provider are considered exempt party-in-interest transactions.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Zealandia Holding Company, Inc directs the Trustee to pay all liabilities and expenses of the Plan and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan agreement and the IRC. In the event of Plan termination, participants would become 100% vested.

**7. Tax Status**

The IRS has determined and informed the Company by a letter dated September 24, 2013, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving this letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**8. Risks and Uncertainties**

The Plan investments consist primarily of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
