*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Project Genesis, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. *Opinion*

### **Notes to Financial Statements June 30, 2025**

#### **Note 1 - Description of Plan**

The following description of the Project Genesis, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement, and any amendments thereto, for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution retirement plan covering all eligible employees of Project Genesis, Inc. (the "Organization") who have completed one year of service, as defined by the Plan. Participants may enter the Plan on the first day of January or July coinciding with or next following the date eligibility requirements are met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Board of Directors and Trustee are responsible for oversight of the Plan. The 401(k) Plan Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors and Trustee.

#### **Contributions**

Each year, participants may make salary deferral contributions to the Plan equal to a percentage of their pre-tax annual compensation, as defined by the Plan, up to Internal Revenue Code ("IRC") limits. Participants who have attained age 50 before the end of the calendar year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Organization makes safe harbor matching contributions to the Plan equal to 100% of a participant's elective deferrals that do not exceed 4% of the participant's eligible compensation, as defined by the Plan. Participants must complete a year of service with a minimum of 1,000 hours, as defined by the Plan, to be eligible for any safe harbor matching contributions. For the year ended June 30, 2025, the Organization made safe harbor matching contributions to the Plan totaling \$90,601 (before the application of any available forfeitures) on behalf of all eligible employees. Additional profit sharing amounts may be contributed to the Plan at the option of the Organization's Board of Directors. Participants must also complete a year of service with a minimum of 1,000 hours, as defined by the Plan, to be eligible for any discretionary profit sharing contributions. For the year ended June 30, 2025, the Organization elected not to make any discretionary profit sharing contribution to the Plan. Participants also direct the investment of the Organization's contributions. All contributions are subject to certain IRC limitations.

#### **Participant accounts**

Each participant's account is credited with the participant's contributions and safe harbor matching contributions, as well as allocations of any Organization discretionary profit sharing contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions, the Organization's safe harbor matching contributions and former safe harbor nonelective contributions, plus actual earnings thereon. In the event of death, total and permanent disability or normal retirement, participants shall become 100% vested in the Organization's discretionary profit sharing contribution portion of their account.

For all other participants, vesting in the Organization's discretionary profit sharing contribution portion of their account is based on credited years of service, as defined by the Plan, according to the following schedule:

#### **Payment of benefits**

On termination of service due to death, disability or normal retirement, a participant will receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. If terminated employees with vested balances of less than \$7,000 do not elect to withdraw their balance, it will automatically be distributed to them within a reasonable period of time after their termination. Participants with a vested account balance greater than \$7,000 may defer payment of benefits until a later date.

Participants who are at least 59½ years of age may withdraw all or a portion of their vested account balance prior to termination. Withdrawals from a participant's pre-tax elective deferral account may also be made in the event of a financial hardship, in accordance with the provisions specified in the Plan.

#### **Forfeited accounts**

At June 30, 2025 and 2024, forfeited nonvested accounts totaled \$10,252 and \$4,084, respectively. These accounts may be used to pay Plan expenses or to reduce future employer contributions. For the year ended June 30, 2025, the Plan utilized \$862 from forfeited nonvested accounts to reduce the Organization's safe harbor matching contribution.

### **Note 2 - Summary of accounting policies**

#### **Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### **Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The 401(k) Plan Committee determines the Plan's valuation policies utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date and are included in the net appreciation in fair value of investments. Net appreciation also includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Payment of benefits**

Benefits are recorded when paid.

#### **Contributions**

Contributions from Plan participants and the safe harbor matching contributions from the Organization are recorded in the year in which the employee contributions are withheld from compensation. Any discretionary profit sharing contributions from the Organization are recorded in the year in which the contributions are earned.

#### **Expenses**

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the processing of distributions are charged directly to the participant's account and are included in administrative expenses. Also included in administrative expenses are certain custodial and third-party administrator fees. Indirect investment-related expenses are included in the net appreciation in fair value of investments.

#### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Subsequent events**

The Plan has evaluated subsequent events through February 3, 2026, the date the financial statements were available to be issued.

#### **Note 3 - Certified investments**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments held at June 30, 2025 and 2024, and investment income for the year ended June 30, 2025, that are disclosed in the accompanying financial statements and supplemental schedule were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by John Hancock Life Insurance Company (U.S.A.), the custodian of the Plan.

#### **Note 4 - Fair value measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

*Pooled separate accounts:* Valued using the accumulation unit value, which is based on the fair value of the underlying assets of the account. The accumulation unit value is deemed equivalent to net asset value ("NAV"), which is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

*Guaranteed interest accounts:* Valued based upon cumulative contributions to the John Hancock general account. The guaranteed interest accounts guarantee the return of principal, plus compound interest earned over a defined 3, 5 or 10-year term, less any applicable contract or participant-level recordkeeping charges. The compound interest rate is a combination of a new money regular rate on regular ongoing contributions made to the guaranteed interest accounts and a separate rate for other amounts contributed and allocated under the participant account. These accounts are not considered fully benefit-responsive.

In the event of Plan termination, participants would become 100% vested in their employer profit sharing contributions.

#### **Note 6 - Tax status**

The Plan has been designed using a pre-approved defined contribution plan document sponsored by Pension Consultants, Inc. ("PCI"). PCI received an opinion letter dated May 26, 2021 in which the Internal Revenue Service ("IRS") stated that the pre-approved defined contribution plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is deemed to be tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7 - Related party transactions and party-in-interest transactions**

The Plan's investments in pooled separate accounts and guaranteed interest accounts are managed by John Hancock Life Insurance Company (U.S.A.). John Hancock Life Insurance Company (U.S.A.) is the custodian, as defined by the Plan; therefore, these transactions qualify as party-in-interest transactions. Indirect fees incurred by the Plan for investment management services are included in the net appreciation in fair value of investments. Direct fees paid by the Plan directly to the custodian amounted to \$805 for the year ended June 30, 2025. Direct fees paid by the Plan directly to the third-party administrator amounted to \$2,940 for the year ended June 30, 2025. The Plan sponsor pays directly any other fees related to the Plan's operations.

#### **Note 8 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
