## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Merchants Grocery 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended July 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ### Notes to Financial Statements

#### Note 1. Plan Description

The following description of the Merchants Grocery 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering employees of Merchants Grocery Company, Inc. (the "Company" or "Employer") who have completed 90 days of service and are not leased employees. The Plan is subject to the provisions of ERISA. The Company is the Plan Sponsor. The Board of Directors is responsible for oversight of the Plan. The Board of Directors determines the appropriateness of the Plan's investment offerings and monitors investment performance.

##### Contributions

Each year, participants may contribute on a pre-tax basis up to the maximum allowed by law, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan provides for a discretionary matching contribution and a discretionary non-elective profit-sharing contribution. For the year ended July 31, 2025, the Company provided a matching contribution equal to 50% of the participant's contribution up to 4% of eligible compensation. For the year ended July 31, 2025, the Company made a \$100,000 profit sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

##### Participant Accounts

Each participant's account is credited with the participant's contributions and related Company matching contributions and allocations of (a) the Company's nonelective profit-sharing contributions (if any) and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Payment of Benefits

On termination of service, a participant will generally receive a lump sum distribution equal to the value of the participant's vested interest in his or her account.

## Notes to Financial Statements

### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contribution portion of their accounts is based on years of continuous service as follows:

### Forfeited Accounts

As of July 31, 2025 and 2024, forfeited nonvested accounts totaled \$1,715 and \$1,944, respectively. These accounts will be used to reduce future employer contributions or pay Plan expenses. For the year ended July 31, 2025, employer contributions were reduced by \$8,677 from forfeited nonvested accounts.

## Note 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

## **Notes to Financial Statements**

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Non-elective profit-sharing Company contributions are recorded in the year in which the participant compensation is earned.

### **Payment of Benefits**

Benefit payments are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

### **Subsequent Events**

The Plan has evaluated subsequent events through March 2, 2026, the date the financial statements were available to be issued.

### **Note 3. Certification**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at July 31, 2025 and 2024, net appreciation in fair value of investments, interest, and dividends for the year ended July 31, 2025, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company LLC, the custodians of the Plan.

## Notes to Financial Statements

### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. ### **Note 5. Group Annuity Contract with Insurance Company**

The Plan has entered into a group annuity contract with Great-West Life & Annuity Insurance Company (Great-West), which invests in a guaranteed investment contract, totaling \$84,634 and \$61,638 as of July 31, 2025 and 2024, respectively. Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

## Notes to Financial Statements

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### **Note 6. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are managed by Empower Advisory Group, LLC, a subsidiary of Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Empower Annuity Insurance Company of America (Empower) provides certain administrative services to the Plan, pursuant to an agreement, and receives revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to the party-in-interest for administrative services to the Plan. If the revenue received by Empower from such mutual fund service providers exceeds the amount owed under the agreement, excess amounts are remitted to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to participant accounts. During the year ending July 31, 2025, there were no excess amounts allocated to participants based on their respective account balance. The Plan or Plan Sponsor may make direct payments to Empower for administrative expenses not covered by revenue sharing.

Cetera Investments Advisers LLC provided investment advisory services to the Plan. Fees paid for these services qualify as party-in-interest transactions.

### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

## Notes to Financial Statements

### **Note 8. Tax Status**

The Plan uses a pre-approved document for its original plan documents and amendments sponsored by Qualified Retirement Plan Consultants Inc. The pre-approved plan provider has received an opinion letter from the IRS dated June 30, 2020, as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan has been amended since the opinion letter was received; however, the Plan Administrator believes the Plan is designed (including all amendments to the Plan) and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator  
Merchants Grocery 401(k) Plan  
Culpeper, Virginia

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Merchants Grocery 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of July 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended July 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of July 31, 2025 and 2024 and for the year ended July 31, 2025, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements***

### Notes to Financial Statements

#### Note 1. Plan Description

The following description of the Merchants Grocery 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan covering employees of Merchants Grocery Company, Inc. (the "Company" or "Employer") who have completed 90 days of service and are not leased employees. The Plan is subject to the provisions of ERISA. The Company is the Plan Sponsor. The Board of Directors is responsible for oversight of the Plan. The Board of Directors determines the appropriateness of the Plan's investment offerings and monitors investment performance.

##### Contributions

Each year, participants may contribute on a pre-tax basis up to the maximum allowed by law, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The Plan provides for a discretionary matching contribution and a discretionary non-elective profit-sharing contribution. For the year ended July 31, 2025, the Company provided a matching contribution equal to 50% of the participant's contribution up to 4% of eligible compensation. For the year ended July 31, 2025, the Company made a \$100,000 profit sharing contribution to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

##### Participant Accounts

Each participant's account is credited with the participant's contributions and related Company matching contributions and allocations of (a) the Company's nonelective profit-sharing contributions (if any) and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### Payment of Benefits

On termination of service, a participant will generally receive a lump sum distribution equal to the value of the participant's vested interest in his or her account.

## Notes to Financial Statements

### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company contribution portion of their accounts is based on years of continuous service as follows:

### Forfeited Accounts

As of July 31, 2025 and 2024, forfeited nonvested accounts totaled \$1,715 and \$1,944, respectively. These accounts will be used to reduce future employer contributions or pay Plan expenses. For the year ended July 31, 2025, employer contributions were reduced by \$8,677 from forfeited nonvested accounts.

## Note 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are stated at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

## **Notes to Financial Statements**

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded as earned on the accrual basis. Dividend income is recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation. Non-elective profit-sharing Company contributions are recorded in the year in which the participant compensation is earned.

### **Payment of Benefits**

Benefit payments are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

### **Subsequent Events**

The Plan has evaluated subsequent events through March 2, 2026, the date the financial statements were available to be issued.

### **Note 3. Certification**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at July 31, 2025 and 2024, net appreciation in fair value of investments, interest, and dividends for the year ended July 31, 2025, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company LLC, the custodians of the Plan.

## Notes to Financial Statements

### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at July 31, 2025 and 2024.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. There were no transfers between levels during the year ended July 31, 2025.

### **Note 5. Group Annuity Contract with Insurance Company**

The Plan has entered into a group annuity contract with Great-West Life & Annuity Insurance Company (Great-West), which invests in a guaranteed investment contract, totaling \$84,634 and \$61,638 as of July 31, 2025 and 2024, respectively. Great-West maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Great-West, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

## Notes to Financial Statements

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

### **Note 6. Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are managed by Empower Advisory Group, LLC, a subsidiary of Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Empower Annuity Insurance Company of America (Empower) provides certain administrative services to the Plan, pursuant to an agreement, and receives revenue from mutual fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to the party-in-interest for administrative services to the Plan. If the revenue received by Empower from such mutual fund service providers exceeds the amount owed under the agreement, excess amounts are remitted to the Plan's trust. Such amounts may be applied to pay Plan administrative expenses or allocated to participant accounts. During the year ending July 31, 2025, there were no excess amounts allocated to participants based on their respective account balance. The Plan or Plan Sponsor may make direct payments to Empower for administrative expenses not covered by revenue sharing.

Cetera Investments Advisers LLC provided investment advisory services to the Plan. Fees paid for these services qualify as party-in-interest transactions.

### **Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

## Notes to Financial Statements

### **Note 8. Tax Status**

The Plan uses a pre-approved document for its original plan documents and amendments sponsored by Qualified Retirement Plan Consultants Inc. The pre-approved plan provider has received an opinion letter from the IRS dated June 30, 2020, as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan has been amended since the opinion letter was received; however, the Plan Administrator believes the Plan is designed (including all amendments to the Plan) and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
