For a non-active participant, the normal cost is zero.

The actuarial accrued liability is the sum of the individual accrued liabilities for all plan participants. For an active participant, the individual accrued liability is the product of the normal cost and the total years of credited service at the current age. For non-active participants, the individual accrued liability is the present value at the current age of future benefits. The unfunded actuarial accrued liability equals the actuarial accrued liability less the valuation assets.

1. Effective Date: November 1, 1976, amended and restated effective October 1, 1997
2. Plan Year: October 1<sup>st</sup> to September 30<sup>th</sup>

B. Participation: An employee will become eligible on the earliest date in which he or she is an Eligible Employee. Effective May 8, 2014, no additional employees will enter the plan.

C. Eligible Employee: Any Employee of the Employer whose employment classification with the Employer is the following: Represented for collective bargaining purposes by International Union of Electronic, Electrical, Salaried Machine and Furniture Workers, AFL-CIO, Local No. 667.

D. Retirement Date:

1. Normal: The date the Participant reaches age 65
2. Disability: 10 Years of Continuous Service
3. Early: Age 60 and 5 Years of Continuous Service
4. 40/15 Retirement: Age 40 and 15 Years of Continuous Service and the Participant is either (a) laid off and not recalled to work within two years or (b) ceases to be an Employee due to a permanent shutdown of a plant, department or subdivision.
5. 75/80 Retirement: Participant ceases to be an Employee due to a permanent plant shutdown, layoff or sickness which results in a Period of Severance and either (a) has attained age 55 and combined age and Continuous Service equals or exceeds 75 or (b) combined age and Continuous Service equals or exceeds 80.

D. Benefits:

1. Normal: \$15.00 times Years of Accrual Service (not to exceed 35 years) Prior to January 1, 2014 the multiplier was \$13.00.
2. Early, 40/15 or 75/80 Retirement: The Accrued Benefit reduced per schedule of factors stipulated in the Plan:

3. Late: Accrued Benefit as of late retirement date
4. Death: Pre-Retirement Survivor Annuity (no pre-retirement death benefit is payable to an unmarried participant)
5. Disability: Immediate benefit equal to the actuarial equivalent of the Accrued Benefit calculated at the date of disability or \$100 if greater
6. Accrued Benefit: The monthly benefit amount earned by a Participant as of a particular date of determination based on the benefit formula as of that date.

2. Continuous Service: total of an Employee's Periods of Service, expressed as whole years and fractional parts of a year (to two decimal places) on the basis that 365 days equal one year. Such total shall be equal to the period from his or her Employment Commencement Date to the date of determination.
