Report of Independent Auditors

To the Plan Administrator and Participants of the
Oil City Iron Works 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Oil City Iron Works 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of October 1, 2024 (in liquidation), and December 31, 2023 (ongoing), and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to October 1, 2024 (in liquidation), and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Oil City Iron Works 401(k) Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained a certification from a qualified institution as of October 1, 2024, and December 31, 2023, and the related statement of changes in net assets available for benefits for the period from January 1, 2024 to October 1, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors’ Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditors’ Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Oil City Iron Works 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.



Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal controls relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Oil City Iron Works 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Emphasis of Matter—Plan Termination and Liquidation Basis of Accounting

As discussed in Note 1 to the financial statements, the governing body of the Oil City Iron Works 401(k) Plan approved the termination and plan of liquidation on May 9, 2024, and management determined liquidation is imminent. As a result, the Plan has changed its basis of accounting from the going concern basis used in presenting the 2023 financial statements to the liquidation basis used in presenting the 2024 financial statements. Our opinion is not modified with respect to this matter.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental schedule, including the Schedule H, Line 4a— Schedule of Delinquent Participant Contributions for the period from January 1, 2024 to October 1, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or are derived from the certified investment information, we compared such information to the related certified investment information.

1. Description of Plan

The following description of the Oil City Iron Works 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General

The Plan was a defined contribution plan sponsored by Oil City Iron Works, Inc. (the “Company” or “Plan Sponsor”) for the benefit of the employees. The Plan was established December 1, 1994. The Plan was subject to the provisions of the Employee Retirement Income Security Act (“ERISA”) of 1974.

SECURE 2.0 Act

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included the Setting Every Community Up Retirement Act (“SECURE”) 2.0 Act. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2033. Since the provisions of SECURE Act 2.0 include both required and optional elements, applicable provisions will be evaluated and implemented in accordance with accompanying regulations and guidance prior to the deadline, December 31, 2026. Effective January 1, 2023, the age requirement for minimum distributions was raised to 73 from 72 for any participant who turns 72 on or after January 1, 2023. Certain provisions became effective for 2024, including changes to long-term part-time eligibility. These changes had no material impact on the Plan’s 2024 financial statements.

Plan Termination and Transfer of Assets

Effective May 9, 2024, the Plan Administrator resolved to terminate the Plan. As part of the termination, participants retained all benefits they would have been entitled to receive prior to the termination. In conjunction with the resolution made above, on October 1, 2024, all assets totaling \$6,456,732 were transferred to the Manufacturers Retirement & Savings Plan (the, “Successor Plan”), a multi-employer plan.

Eligibility

Employees of the Company who were at least 18 years of age and had completed 60 days of service were eligible to participate in the Plan on the first day of the month following meeting the eligibility requirements.

Contributions

Participant Contributions

Each year, participants could contribute up to 100% of pretax annual compensation, as defined by the Plan, not to exceed limits as set by the Internal Revenue Service (“IRS”). Participants who had attained age 50 before the end of the Plan year were eligible to make catch-up contributions. Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollover”). Participants had the option of designating a portion of their elective deferral contributions as after-tax “Roth” contributions. Participants directed the investment of their contributions into various investment options offered by the Plan. Newly eligible participants of the Plan were automatically enrolled at a pretax deferral rate of 3%. Participants enrolled at the automatic deferral percentage experienced a 1% automatic increase at the beginning of each plan year, up to a maximum of 15%.

Contributions (continued)

Employer Matching Contributions

At the discretion of the Board of Directors, the Company could elect to contribute a discretionary matching contribution. During the period from January 1, 2024 to October 1, , the Company authorized discretionary matching contributions equal to 50% of each participant’s deferrals, up to 6% of eligible compensation, for a total of \$157,574 in employer matching contributions.

Non-Elective Employer Contributions

At the discretion of the Board of Directors, the Company could choose to contribute an employer contribution equal to a uniform percentage of plan compensation. During the period from January 1, 2024 to October 1, , the Company authorized no non-elective employer contributions.

Contributions from plan participants and the associated matching contributions from the Company were recorded in the year in which the employee contributions are withheld from compensation.

Participant Accounts

Each participant’s account was credited with the participant’s contributions and Company’s contributions. Plan earnings were allocated based on participant account balances. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that can be provided from the participant’s vested account. Participant accounts were valued daily to reflect income earned.

Vesting

Participants were always fully vested in their deferral contributions and any earnings thereon. Participants were fully vested in the Company’s previous safe harbor contributions and any earnings thereon. Participants vested in any other employer contributions according to the table below. The Plan allowed for amounts forfeited by participants to be used to reduce the Company’s matching and employer contributions or to pay expenses associated with the operation and administration of the Plan.

Notes Receivable from Participants

Participants could borrow from their fund accounts up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Participants could not have more than one loan outstanding at any time. The loans were secured by the balance in the participant’s account. The interest rates for loans were equal to one percent above the Prime rate. The loans were repaid ratably through payroll deductions over a period of five years or less, unless such loan was for the purchase of a participant’s primary residence.

Payment of Benefits

Upon termination of service due to death, disability, retirement or termination of employment, a participant could elect to receive an amount equal to the value of the participant's vested interest in his or her account in the form of a lump sum payment. A participant could withdraw part of the vested interest in his or her account upon attainment of age 59 ½, subject to the Plan's provisions. For account balances less than \$5,000, a single lump sum payment would be made automatically into an individual retirement account upon termination. The Plan also permitted hardship distributions to participants that could demonstrate an immediate and heavy financial need.

Forfeited Accounts and Unallocated Accounts

During the period from January 1, 2024 to October 1, 2024, participants forfeited \$11,374 in prior employer contributions. At December 31, 2023, forfeited nonvested accounts totaled \$15,959. These amounts could be used to reduce future expenses incurred by the Plan or employer contributions.

2. Significant Accounting Policies

Basis of Accounting

The accompanying 2024 financial statements have been prepared on the liquidation basis of accounting in accordance with Accounting Standards Codification (ASC) 205-30, *Liquidation Basis of Accounting*. The Plan adopted the liquidation basis effective May 9, 2024, when the Plan Sponsor approved the termination of the Plan and it became remote that the Plan would continue as a going concern. Under the liquidation basis of accounting, assets are measured at the estimated amount of cash or other considerations the Plan expects to collect in settling those assets, and liabilities are stated at the estimated amount of cash or other considerations the Plan expects to pay in settling those obligations as the Plan winds up its affairs. The 2023 financial statements of the Plan were prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Prior to the transfer of assets to the Successor Plan, Investments were reported at fair value (except for the guaranteed investment contract, a fully benefit-responsive investment contract ("FBRIC"), which was reported at contract value). The common collective trust funds were stated at net asset value ("NAV") as determined by the trustee at the end of the plan year. The NAV, as provided by the trustee, was used as a practical expedient to estimate fair value. Fair value was the price that would be received to sell an asset or paid to transfer a liability (an exit price) in an orderly transaction between market participants at the measurement date. Under the liquidation basis, these investments were measured at the estimated amounts expected to be realized upon redemption with the respective funds, which approximated their NAVs at the dates of liquidation. The Plan's investment committee determined the Plan's valuation policies utilizing information provided by the investment advisers, trustee, custodian, and insurance company. Because all assets and liabilities were fully settled during the year, no assets, liabilities, or related estimates remain as of October 1, 2024. Refer to Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (continued)

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the period.

Notes Receivable from Participants

Notes receivable from participants represented loans and were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recognized on the accrual basis. No allowance for credit losses has been recorded as of October 1, 2024, and December 31, 2023. If a participant ceased to make loan repayments and the plan administrator deemed the participant loans to be in default, the participant loan balance was reduced, and a benefit payment was recorded.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Certain investment and administration fees were deducted directly from participant's investment returns. Transaction costs borne by the Plan were charged to the individual participant who initiated the transaction to which the charge relates by reducing the participant's account balance.

Recently Adopted and New Accounting Principles

In June 2016, the Financial Accounting Standards Board ("FASB") issued Accounting Standards Update ("ASU") No. 2016-13, *Financial Instruments - Credit Losses (Topic 326): Measurement of Credit Losses on Financial Instruments*, and subsequent amendments to the initial guidance, ASU 2019-10. This accounting standard changes the methodology for measuring credit losses on financial instruments and the timing of when such losses are recorded. ASU No. 2016-13 is effective for fiscal years, and interim periods within those years, beginning after December 15, 2022. The Plan adopted the provisions of ASU 2016-13 for the year ended December 31, 2023. The adoption of this standard did not have a material impact on the Plan's financial statements.

Subsequent Events

Subsequent events have been evaluated through the date of the report of independent auditors, which is the date these financial statements were available to be issued. There were no other material subsequent events that required recognition or additional disclosure in these financial statements.

3. Information Prepared and Certified by the Trustee and Custodian (unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2023, and net appreciation (depreciation) in fair value of investments, interest, dividends, and interest from notes receivable from participants for the period from January 1, 2024 to October 1, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Annuity Insurance Company of America ("EAIC") and Empower Trust Company, LLC, collectively, the custodian and trustee of the Plan.

4. Fair Value Measurements

The fair value hierarchy prioritizes the inputs used to measure fair value, giving the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB accounting guidance are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2023:

Money market fund: Valued at the daily closing price as reported by the fund. The money market fund held by the Plan is an open-end money market fund that is registered with the Securities and Exchange Commission. This fund is required to publish its daily NAV and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trust funds: Valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate the fair value of the common collective trust. The NAV is based on the fair value of the underlying investments held by the trust less its liabilities. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require a 12-month notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully Benefit-Responsive Guaranteed Investment Contract

Plan entered into a traditional FBRIC with Massachusetts Mutual Life Insurance Company (“MMLI”). MMLI maintains the contributions in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer was contractually obligated to repay the principal and a specified interest rate that was guaranteed to the Plan. The crediting rate was based on a formula established by the contract issuer. The crediting rate was reviewed on a quarterly basis for resetting. The guaranteed investment contract did not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract met the FBRIC criteria and therefore was reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by MMLI, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due was dependent on the issuer's ability to meet its financial obligations. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants. In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

6. Related-Party and Party in Interest Transactions

The Plan invested in a guaranteed investment contract managed by MMLI, an affiliate of Empower Trust Company, the Trustee of the Plan. Therefore, these transactions qualified as a party in interest transactions.

Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment. The Plan also made direct payments to the trustee, custodian, and third-party administrator totaling \$44,652. These costs incurred by the Plan are included in administrative expense on the statement of changes in net assets available for benefits. The Plan Sponsor pays directly any other fees related to the Plan's operations.

7. Income Tax Status

The Plan has adopted a volume submitter 401(k) and profit-sharing plan with cash or deferral arrangement sponsored by Empower Trust Company (formerly, Great-West Trust Company, LLC), which received a favorable opinion letter from the IRS dated June 30, 2020, stating that the Plan, as then designed, was acceptable under Section 401(a) of the IRC, and therefore, the related trust is exempt from taxation. The Plan itself has not received a determination letter from the IRS and has been amended since. However, Plan management believes the Plan, as adopted and amended, is operating within the guidelines of the IRC. Accordingly, no provision for federal income taxes has been provided in the accompanying financial statements.

U.S. GAAP requires Plan Management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by IRS. The Plan is subject to routine audits taken by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8. Termination of the Plan

On May 9, 2024, the Company resolved to merge and terminate the Plan into the Manufacturers Retirement Savings Plan (the "Successor Plan"). All assets were merged into the Successor Plan as of October 1, 2024. As a result of this decision, liquidation of the Plan became imminent, and the Plan's financial statements are presented on the liquidation basis of accounting. Upon termination, all participants became 100% vested in their entire account balance.

9. Risks and Uncertainties

The Plan invested in various mutual funds, common collective trust funds, and a guaranteed investment contract. Investments in general were exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it was at least reasonably possible that changes in the values of investments will occur in the near term and that such change could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

10. Administrative Failure

Delinquent Participant Contributions

During the period from January 1, 2024 to October 1, 2024, the Company failed to remit certain participant contributions and loan repayments to the Plan within the time frame required by the Department of Labor's Regulation 29 CFR 2510.3-102, thus constituting a non-exempt (prohibited) transaction between the Plan and the Company. Delinquent remittances of participant contributions, including loan repayments, amounted to \$29,240. The delinquent participant contributions and loan repayments were remitted to the Plan during the period from January 1, 2024 to October 1, 2024. Additionally, the Plan Sponsor calculated the applicable lost earnings and credited participant accounts with any lost earnings, as applicable. As Plan management corrected this administrative failure by calculating the lost earnings outside the IRS Voluntary Fiduciary Correction Program ("VFCP") during the year, the amounts are considered corrected as of October 1, 2024.
