## Independent Auditor's Report

To the Plan Administrator and Participants

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the LifeStore 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements ("financial statements").

### 1. Description of Plan

The following description of the LifeStore 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan covering substantially all employees of LifeStore Financial Group (the “Company” or “Employer”) who have completed 3 months of service and are age 21 or older. Employees may begin participation as of the first day of the month subsequent to meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

#### **Contributions**

Eligible employees are automatically enrolled at a 6% pre-tax deferral percentage, which will increase by increments of 1% annually up to a maximum of 10%, unless they elect an alternative deferral percentage or decline participation. Participants may otherwise contribute up to the maximum amount of their pre-tax and/or after-tax (“Roth”) annual compensation allowable by the Internal Revenue Service (“IRS”). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (“rollovers”). The Company makes safe harbor matching contributions equal to 100% of the first 4% of compensation contributed by participants. The Company may also make a discretionary profit sharing contribution as determined annually by the Board of Directors, which is allocated to eligible participants based upon the percentage of their compensation to total compensation of all eligible participants. The Company made discretionary profit sharing contributions of \$230,000 and \$215,000 for 2025 and 2024.

Upon enrollment in the Plan, a participant may direct contributions into any of the investment options offered through the Plan. Participants may change their investment options and deferral percentages at any time.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s and Company’s contributions and an allocation of the Plan’s net earnings and administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Participants are immediately vested in their voluntary contributions and the Company’s safe harbor matching contributions, plus any income or loss thereon. Vesting in the Company’s discretionary profit sharing contributions plus actual income (loss) thereon is based on years of continuous service according to the following schedule:

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement, or separation, a participant may elect to receive a lump-sum amount or installment payments equal to the value of the participant's vested interest in his or her account. In-service distributions may be made to participants who have reached age 59½. Withdrawals may also be made upon circumstances of financial hardship in accordance with provisions specified in the Plan.

#### ***Forfeitures***

Forfeitures from non-vested participant accounts may be used to offset plan expenses or to reduce Company matching contributions. During 2025 and 2024, forfeitures of approximately \$17,000 and \$6,000 were utilized to reduce Company matching contributions. As of June 30, 2025 and 2024, available forfeitures were approximately \$1,500 and \$2,600.

#### ***Notes Receivable from Participants***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms are generally up to five years and two notes may be outstanding at a time. The notes are secured by the participant's vested account balance and bear interest at rates charged by commercial lending institutions for similar notes under similar circumstances. Principal and interest are paid ratably through payroll deductions.

#### ***Administrative Expenses***

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Certain plan expenses, such as fees for recordkeeping and advisory services, are permitted to be paid from the Plan's assets. Distribution and note receivable fees are paid from the affected participant's account.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accompanying financial statements have been prepared under the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of June 30, 2025 and 2024. Delinquent notes receivable are reclassified as distributions based upon the terms of the plan document.

#### **Payment of Benefits**

Benefits are recorded when paid.

#### **Subsequent Events**

Management has evaluated events occurring subsequent to the date of the financial statements through January 22, 2026, the date the financial statements were available to be issued, and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended June 30, 2025 and 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company ("Fidelity") and Principal Trust Company ("Principal"), the respective trustees of the Plan. See Note 7.

### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Income Tax Status

The Plan has adopted a prototype plan document sponsored by FMR LLC. The IRS has determined and informed FMR LLC on June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants' accounts will become fully vested and nonforfeitable.

### 7. Party-in-Interest Transactions

In July 2023, the Plan changed its primary trustee and recordkeeper from Principal to Fidelity. As of June 30, 2023, the Plan had liquidated the majority of its investments in preparation for the change. As of June 30, 2024, approximately \$266,000 remained with Principal due to transfer restrictions associated with the Real Estate Fund, which were transferred to Fidelity during 2025.

Certain plan investments are managed by Fidelity. Fidelity is the trustee and recordkeeper as defined by the Plan and, therefore, those transactions qualify as party-in-interest.

Fees paid by the Plan to Fidelity for trustee and recordkeeping services were approximately \$22,000 and \$15,000 in 2025 and 2024.

Fees paid by the Plan to Kestra Investment Services for investment advisory services were approximately \$43,000 and \$26,000 in 2025 and 2024.

### 8. Fair Value Measurements

The Plan adopted Accounting Standards Codification, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

#### ***Basis of Fair Value Measurements***

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024.

*Mutual and money market funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Common collective trust funds:* Valued at NAV as determined by the issuer using the estimated fair value of the underlying assets, minus liabilities, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

*Pooled separate accounts:* Valued at unit value as reported by the issuer based on quoted market prices of the underlying assets, which is then adjusted for dividends and separate account fees. As the value of these investments is readily determinable, these investments are classified within Level 2 of the valuation hierarchy.

### 8. Fair Value Measurements (Concluded)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
