### REPORT ON THE AUDIT OF THE FINANCIAL STATEMENTS

#### OPINION ON THE 2024 FINANCIAL STATEMENTS

December 31, 2024

NOTE A -- GENERAL DESCRIPTION OF THE PLAN

The following description of the IMMEC, Inc. (the “Employer” or “Company”) 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General: The Plan, established on October 15, 2012, then amended and restated effective January 1, 2023, is a defined contribution plan covering all eligible employees of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan continues to operate under all of the same terms and conditions.

Contributions: Employees are eligible to participate in the Plan upon attainment of age 18 and 6 months of service. The Plan provides for participant-elective pre-tax and Roth deferral contributions, employer-matching contributions and employer-discretionary contributions. Plan participants may elect to defer a percentage of their annual compensation subject to certain limitations. There was an amendment to the Plan subsequent to year end regarding service requirements. See Note J.

The Company operates under a safe harbor provision whereby participants in the Plan receive matching contributions equal to 100% of each participant’s elective deferrals that do not exceed 4% of the participant’s compensation. Additional amounts may be contributed of discretionary matching employer contributions. There were no additional discretionary employer contributions to the Plan by the Company for the years ended December 31, 2024 or 2023.

Participant Accounts: Each participant’s account is credited with the participant’s contributions, employer safe harbor matching contributions, allocations of the Company’s employer-discretionary and non-elective contributions and earnings (losses) thereon, less an allocation of administrative expenses. Allocations for employer-discretionary and non-elective contributions, if applicable, are allocated to each participant based on that participant’s annual compensation relative to the annual compensation of all participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Vesting: Participants are vested immediately in their contributions and safe harbor matching contributions, plus actual earnings thereon. The Company’s discretionary and non-elective contributions to the participant’s accounts become 20% vested after one year of service and 20% vested for each year of service thereafter until the participant is 100% vested. An amendment to the Plan was made subsequent to year end. See Note J.

Payment of Benefits: Under the terms of the Plan, participants are entitled to receive the vested portion of their account balance at normal or early retirement age, retirement due to permanent disability or termination of employment. Withdrawals from the Plan may also be made upon circumstances of financial hardship or attainment of age 59.5. The participant, or the participant’s designated beneficiary, will receive the value of his accumulated Plan benefits in a lump-sum distribution.

NOTE A -- GENERAL DESCRIPTION OF THE PLAN – Continued

Forfeited Accounts: At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,457 and \$0, respectively. Forfeitures of terminated participants' non-vested accounts can be used to reduce the future non- elective and discretionary matching contributions of the Company. During the years ending December 31, 2024 and 2023, forfeiture amounts were used for matching contributions were \$25,436 and \$13,560, respectively.

Plan Termination: Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE B -- SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from Plan participants and the safe harbor matching contributions from the Company are recorded in the year in which the contributions are withheld from compensation.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Certain Plan expenses are paid by the Plan as determined by the service agreement. Investment related expenses are included in the net appreciation (depreciation) of the fair value of investments.

NOTE C -- INFORMATION PREPARED AND CERTIFIED BY THE PLAN TRUSTEE (2023 Year Only)

For the year ended December 31, 2023, the Plan administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the custodian, Principal, certified that the following data included in the accompanying 2023 financial statements was complete and accurate:

- Investments and notes receivable from participants as shown on the statements of net assets available for benefits as of December 31, 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2023;
- Investment information included in the footnotes for the years ended December 31, 2023.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the 2023 financial statements.

On December 28, 2024, the Plan switched custodians, from Principal to Voya. There was no certification over investments for the time period between the switch to Voya and the end of the Plan Year. As such, the Plan Sponsor elected to have an ERISA Audit (non-103(a)(3)(C)) for the year ended December 31, 2024.

NOTE D -- RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE E -- FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Mutual funds represent investments with various investment managers. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds traded on national securities exchanges are valued at the net asset value (NAV). It is not probable that the mutual funds will be sold at amounts that differ materially from the NAV of shares sold.

*Pooled Separate Accounts:* The fair values of the Plan's pooled separate accounts are determined by reference to the separate accounts' underlying assets, which are principally marketable equity and fixed income securities. These underlying assets are traded on national securities exchanges and are valued at NAV. It is not probable that marketable securities funds would be sold at amounts that differed materially from the NAV of shares held.

*Money Market Funds:* Money market funds are valued using quoted market prices in active markets and are classified within the Level 1 of the fair value hierarchy.

NOTE F -- RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Plan. These parties include investment advisory, recordkeeping and accounting services.

Certain Plan investments were managed by Principal and Voya. Principal was the custodian of the Plan from January 1, 2024 through December 27, 2024, at which time the Plan Sponsor switched to Voya. These transactions are therefore qualified as party-in-interest.

NOTE G -- TAX STATUS

The Plan adopted the Volume Submitter Defined Contribution Plan sponsored by Principal, which received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating the Prototype Plan was designed in accordance with the provision of the Internal Revenue Code (IRC). Accordingly, the trust's net investment income is exempt from income taxes. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I -- PROHIBITED TRANSACTIONS

During 2014, employee withholdings of \$62 were not remitted by the Company within the appropriate time period as stated by the Department of Labor (DOL). The Company remitted \$62 of the delinquent contributions to the Plan during 2015. These transactions constituted prohibited transactions as defined by ERISA. The Company remitted the lost earnings for the 2014 late deposits during 2024 but elected not to do so through the Voluntary Fiduciary Correction Program (VFCP) given the immaterial amount. These transactions constitute nonexempt prohibited transactions under ERISA and the Internal Revenue Code because they were not corrected under the Department of Labor's Voluntary Fiduciary Correction Program (VFCP) and did not qualify for exemptive relief under Prohibited Transaction Exemption 2002-51 and will continue to be reported in the Schedule of Delinquent Participant Contributions as nonexempt prohibited transactions.

During 2023 and 2022, employee withholdings of \$147,657 and \$55,206 were not remitted by the Company within the appropriate time period as stated by the DOL. The Company remitted \$147,657 and \$55,206 of the delinquent contributions to the Plan during 2023 and 2022, respectively. The Company has not fully remitted the lost earnings for the 2023 late deposits but will do so in 2025. The Company remitted the lost earnings for the 2022 late deposits during 2024 but elected not to do so through the Voluntary Fiduciary Correction Program (VFCP) given the immaterial amount. The remitted lost earnings for the 2022 late deposits constitute nonexempt prohibited transactions under ERISA and the Internal Revenue Code because they were not corrected under the Department of Labor's Voluntary Fiduciary Correction Program (VFCP) and did not qualify for exemptive relief under Prohibited Transaction Exemption 2002-51 and will continue to be reported in the Schedule of Delinquent Participant Contributions as nonexempt prohibited transactions.

During 2024, employee withholdings of \$489,103 were not remitted by the Company within the appropriate time period as stated by the DOL. The Company remitted \$489,103 of the delinquent contributions to the Plan during 2024. The Company has not fully remitted the lost earnings for the 2024 late deposits but will do so in 2025. The DOL considers late deposits to be non-exempt transactions and will be reported in the Schedule of Delinquent Participant Contributions as nonexempt prohibited transactions.

NOTE J -- SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through February 23, 2026, the date the financial statements were available to be issued.

Ownership Change:

In August of 2025, the Plan Sponsor, IMMEC Inc., was acquired by a private equity firm, effectively changing its name to IMMEC Holdings, LLC.

Eligibility Requirements:

In September of 2025, the Plan was amended to change the service requirement for participation in the Plan from 6 months to no minimum service.

Vesting:

In September of 2025, the vesting percentages were changed for discretionary and non-elective contributions. These contributions become 50% vested after one year of service and 100% after two years of service.
