Report on the Audit of the Financial Statements

Opinion

NOTE 1 DESCRIPTION OF PLAN

The following description of the American Asphalt Employee Stock Ownership Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

American Asphalt Repair & Resurfacing Company, Inc. (American Asphalt) (the Company) established the Plan on January 1, 2018. The Plan is a defined contribution plan intended to constitute an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC). The Plan covers all employees of the Company who have completed 12 months of employment with the Company during which the employee is credited with at least 1,000 hours of service. The Plan excludes employees who are classified as leased employees and employees whose employment is governed by a collective bargaining agreement. An eligible employee will begin participation on January 1 or July 1 following the completion of the eligibility requirements. The Plan is designed to invest primarily in securities issued by the Company and is authorized to borrow money for such investments. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan purchased Company common stock using the proceeds of notes payable to the Company and holds the stock in a trust established under the Plan (see Note 5). As the Plan makes debt payments, an appropriate percentage of stock will be allocated to eligible employees' accounts in accordance with applicable regulations under the IRC.

The Company's borrowings are collateralized by the Plan's unallocated shares of American Asphalt common stock. As the Plan makes principal and interest payments, an appropriate percentage of stock is allocated to eligible participant's accounts. Shares are allocated to each participant's account based upon the individual participant's annual compensation, as defined, in relation to the total compensation for all participants. The lender has no rights against shares once they are allocated under the Plan. Accordingly, the financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to:

- (a) The account of employees with vested rights in allocated common stock (Allocated) and
- (b) Common stock not yet allocated to employees (Unallocated)

All shares were allocated to Plan participants as of December 31, 2024.

Contributions

Each year, the Company may contribute to the Plan up to 25% of covered compensation as determined annually by the Company's board of directors. Contributions may be in the form of shares of common stock or cash. Contributions for each year are never less than the amount required to enable the Plan to discharge its current obligations, without regard to whether some or all of such contribution may fail to qualify for an income tax deduction by the Company. In order to receive an allocation of Company contributions, a participant must be employed on the last day of the Plan year unless termination is due to death, disability or retirement (age 65). Contributions by Plan participants are not permitted by the Plan. Contributions are subject to Internal Revenue Service (IRS) limitations.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Participant Accounts

Each participant's account is credited with the Company contributions and investment income or losses. Company contributions are allocated proportionately based on eligible compensation of all eligible participants. Income is allocated annually based on each participant's share of the fund. The benefit to which a participant is entitled is the benefit that can be provided by the participant's account.

Vesting

Vesting of participant's accounts is based on years of credited service with the Company. A participant's account attributable to Company discretionary contributions becomes fully vested after six years of credited service with the Company, under a graded vesting schedule. Notwithstanding the above, participants shall, however, become 100% vested in the account upon attaining normal retirement (age 65), their death, or becoming permanently disabled.

Distributions

Distributions from the Plan will be made after a participant retires, dies, becomes disabled, or otherwise terminates employment. If a participant terminates employment and the participant's vested benefit under the Plan does not exceed \$1,000, then the benefit must be distributed in a single lump-sum payment as soon as administratively practicable commencing after the close of the Plan year in which termination occurs. If a participant terminates employment and the participant's vested benefit under the Plan exceeds \$1,000 but is less than \$5,000, and no election is made for distribution, then the benefit will be distributed in a single lump-sum payment to an IRA established by the Plan sponsor. If the vested benefit under the Plan exceeds \$5,000, then the benefit will be paid in a lump sum or annual installments (based on the participant election) no later than the end of the sixth Plan year following the Plan year in which termination occurs.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation service in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. Participants who elect to diversify receive a cash distribution. Participants will be eligible to diversify following the December 31, 2028 plan year-end.

Voting Rights

The Trustee at the direction of the Company's board of directors or a committee appointed by the Board, usually votes shares of Company Stock held by the ESOP. In certain important corporate matters presented to Company shareholders for a vote, however, such as any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all assets of a trade or business under applicable state law, you will have the right to instruct the Trustee how you would like the Trustee to vote shares of Company stock allocated to the participant account.

Put Option

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Forfeited Accounts

Forfeitures of nonvested accounts are allocated to participants in the same manner as contributions. There were no unallocated forfeiture accounts as of December 31, 2024 and 2023. Allocation of forfeitures during the years ended December 31, 2024 and 2023 totaled \$21,307 and \$59,160, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are reported at fair value. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Allocations

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (allocated) and (b) stock not yet allocated to employees (unallocated), including shares that are committed to be released. Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

The Company pays all administrative expenses on behalf of the Plan.

Subsequent Events

The Plan has evaluated subsequent events through January 20, 2026, the date the financial statements were available to be issued.

NOTE 3 INVESTMENTS

The Investment in Company Securities

The Plan's initial investment in Company securities consisted of 700,000 shares of the outstanding common stock of American Asphalt. The shares were acquired on December 20, 2019 for \$6,100,000 (\$8.71 per share) at estimated fair market value. In addition, based on a final valuation of the Company's common stock sold to the ESOP on the closing date described in the stock purchase agreement for the transaction dated December 20, 2019, the value of the shares sold to the ESOP increased by \$926,000 for a total value of the sale of \$7,026,000. The estimated fair market value, determined by an independent appraisal as of December 31, 2024 and 2023 was \$7.43 and \$8.17 per share, respectively. The Plan released 167,237 and 160,591 shares to participants during the years ended December 31, 2024 and 2023. NOTE 4 FAIR VALUE OF INVESTMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the assets or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used as of December 31, 2024 and 2023.

Company Common Stock: The fair value of the Company common stock held by the Plan is valued at fair value based on an independent third-party appraisal. This appraisal is based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities.

NOTE 5 NOTE PAYABLE

On December 20, 2019, the Plan entered into a \$6,100,000 term loan agreement with the Company. Also, on December 20, 2019, the Plan amended the promissory note to increase the note by \$926,000 to total \$7,026,000 (for the final stock price adjustment). The proceeds of the loan were used to purchase the Company's common stock. The Plan has a note payable related to the purchase of Company common stock on December 31, 2024 and 2023 as follows:

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 7 PARTY-IN-INTEREST TRANSACTIONS

The Plan's assets, which consist primarily of Company common shares, are held by the Plan's trustee. Company contributions are held and managed by the trustee, who invests cash received as a result of cash contributions and interest income, and makes distributions to participants.

The Plan is administered by the Company and certain administrative functions are outsourced to a third-party administrator. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan provides for investment primarily in Company common stock. In general, these investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. The stock of the Company is valued annually by an independent third-party valuation specialist. Because of the inherent subjectivity in any valuation, those estimated values may differ significantly from the values that would have been used had a ready market for the securities existed, and the differences could be material. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 PLAN TAX STATUS

The Plan is placing reliance on a determination letter dated September 24, 2021, received from the IRS on the Plan indicating that the Plan is qualified under Section 401 of the IRC and, therefore, the related trust is exempt from taxation. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
