Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Amerapex Corporation 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1 – Plan Description

The following description of the Amerapex Corporation 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan Document or Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution 401(k) benefit plan that provides retirement savings benefits to eligible employees of Amerapex Corporation, Amerapex NDT, LLC, and Amerapex Services Group (collectively, the “Company” or “Employer”). The Plan commenced effective January 1, 2008, and was amended and restated effective August 1, 2022, to comply with the latest rules and regulations. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) and the Internal Revenue Code (“IRC”).

Plan Custodian and Trustee

The Plan’s assets are held by Reliance Trust Company (the “Custodian” or “Trustee”), the Custodian and Trustee of the Plan. Among other duties, the Trustee receives contributions, holds and invests fund assets in accordance with the directions of participants, and makes distributions as directed by the Employer. ADP Retirement Services serves as the Plan’s recordkeeper.

Eligibility

Employees become eligible to participate in the Plan upon reaching 21 years of age and completing one month of service. Certain employees are not eligible to participate in the Plan, including those under collective bargaining agreements and nonresident aliens who receive no United States source income. Effective November 1, 2022, the Plan was amended, and temporary, seasonal, and part-time employees are not eligible to participate in the Plan. The Plan provisions define part-time employment as regularly scheduled service of less than 1,000 hours in the relevant computation period.

Contributions

The Plan permits eligible employees to contribute, on a pre-tax or Roth basis, up to 90% of eligible compensation as defined by the Plan, subject to the amount allowed annually by the IRC, which was \$23,000 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions up to the amount allowed annually by the IRC, which was \$7,500 for 2024. Participants direct the investment of their contributions into various investment options offered by the Plan.

Rollover contributions represent funds transferred to the Plan from other qualified plans. Participants may rollover balances from certain individual retirement accounts and qualified plans of former employers.

The Plan provides for Employer matching contributions. In the 2024 Plan year, the Employer made matching contributions to the Plan on behalf of participants in an amount equal to 100% of the first 5% of participant’s eligible compensation contributed to the Plan as employee contributions. The maximum match is \$1,500 per year.

Note 1 – Plan Description (continued)

Participant Accounts

Each participant account is credited with the participant's contributions, Employer contributions, an allocation of Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant-Directed Investments

All assets of the Plan are participant-directed investments. The Plan has selected various investment options, as more fully described in the Plan Document, to which participants may designate the allocation of their account balances. Participants may direct their account balances to one or more of these investment options, which vary in types of investments, rates of return, and investment risk.

Vesting

Participants are 100% vested immediately in their pre-tax deferred and after-tax contributions, rollovers, and any income or loss thereon. Vesting in Employer matching contributions is based on years of service, with participants becoming 100% vested after two years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined monthly, is set at 1% above Prime, as defined. Principal and interest are paid ratably through payroll deductions and are due in equal installments not less frequently than quarterly.

Payment of Benefits

Upon separation of service due to death, disability, or retirement, a participant receives a lump sum amount equal to the value of the participant's vested interest in their account. The participant may elect whether to receive the distribution directly or to roll over the distribution into another retirement plan. If the vested account balance is less than or equal to \$5,000, the Plan permits involuntary lump sum cash distributions. A participant may withdraw all or a portion of their vested account balance in the event of a financial hardship, as defined by the Plan. Additionally, in-service withdrawals are permitted upon attainment of age 59½.

Forfeited Accounts

Per the Plan provisions, forfeited nonvested amounts are to be used to reduce future Employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$19,155 and \$4,639, respectively. During the year ended December 31, 2024, forfeitures of \$32,804 were used to reduce Employer contributions.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Note 2 – Summary of Significant Accounting Policies (continued)

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought, sold, and held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Agreement.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Administrative Expenses

Certain expenses incurred by maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1), and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

- **Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access at the measurement date.
- **Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
- **Level 3** – Inputs that are unobservable inputs for the assets or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- **Mutual Funds** – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified within level 1 of the fair value hierarchy.
- **Common Collective Trust Funds** – Primarily comprised of fully benefit-responsive investment contracts that are valued at the NAV of units of the collective trust. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets and liabilities of the trust. Participant transactions (purchases and sales) may occur daily. There were no unfunded commitments as of December 31, 2024 and 2023, and no redemption restrictions for the years ended December 31, 2024 and 2023. The redemption notice period is twelve months.

Note 5 – Related Party and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds and units of common collective trusts managed by the Trustee, which qualify as party-in-interest transactions as defined by ERISA. Such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to service providers.

The Plan has notes receivables from participants at December 31, 2024 and 2023. These receivables and all related transactions qualify as party-in-interest transactions and are exempt from being prohibited by ERISA.

Note 6 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

Note 7 – Tax Status

The Plan operates under a non-standardized, preapproved profit-sharing plan sponsored by ADP, LLC. The Internal Revenue Service (“IRS”) has determined and informed ADP, LLC, by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. While the Plan has not filed individually with the IRS for a letter regarding the Plan’s qualified tax status, the Plan Administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC, and thus believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rates, market, and credit risks. Because of the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participant account balances and the amounts reported in the statement of net assets available for benefits.

Note 9 – Prohibited Transactions

The Employer failed to remit to the Plan’s Custodian certain participant contributions and loan repayments totaling \$160,968 within the period prescribed by the DOL’s Rules and Regulations. Delays in remitting contributions and loan repayments to the Custodian were due to unintentional administrative errors. During 2025, the Company is in the process of correcting contributions to the affected participants’ accounts to compensate those participants for potential lost earnings due to the delays.
