## **INDEPENDENT AUDITOR'S REPORT**

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed an audit of the financial statements of Alternative Services, Inc. 403(b) Plan an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTE 1 – DESCRIPTION OF THE PLAN**

*The following description of Alternative Services –, Inc. 403(b)Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and any amendments thereto, for a more complete description of the Plan’s provisions.*

*General*

The Plan is an Internal Revenue Code ("Code") Section 403(b) defined contribution retirement plan covering all employees of Alternative Services, Inc., Carpe Diem Foundation, Inc, and Community Living Concepts, Inc., (the "Organization"). All employees are immediately eligible to participate in the Plan upon their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

*Contributions*

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their salary deferral contributions and employer matching contributions into various investment options offered by the Plan. The Plan currently offers a variety of mutual funds, and a fixed annuity contract (Stable Asset Fund) as participant-directed investment options for participants.

The Organization may, at its discretion, make matching and nonelective contributions. Nonelective contributions are allocated to participant accounts based on the ratio of each participant's eligible compensation, as defined by the Plan, to the total eligible compensation of all eligible participants in the Plan. Participants must have completed one year of eligibility service (with a minimum of 1,000 hours) and be actively employed on the last day of the Plan year to share in an allocation of nonelective contributions. For the year ended December 31, 2024, the Organization elected to make a nonelective contribution of \$175,000 to the Plan. Contributions are subject to certain limitations. Nonelective contributions are invested in a portfolio of investments as directed by the Organization.

*Participant Accounts*

Each participant's account is credited with the participant's contributions, an allocation of the Organization's contributions and Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan.

Investment expenses charged by the exchange traded funds, mutual funds and variable annuity contracts in which the Plan invests are paid directly from the underlying assets of the respective investments and are included in the net appreciation (depreciation) in fair value of investments in the statement of changes in net assets available for benefits. Certain advisory fees are paid by the Plan. All other charges related to the administration of the Plan are paid by the Organization.

*Vesting*

Participants are vested immediately in their salary deferral contributions and rollover contributions plus actual earnings thereon. In the event of termination due to death, total and permanent disability, normal or early retirement, participants shall become 100% vested in the Organization contribution portion of their account. For all other participants, vesting in the Organization contribution portion of their account is based on credited years of service, as defined by the Plan, according to the following schedule:

*Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their account balance. The notes are secured by the vested balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest payments are made directly by participants to the custodian. Outstanding notes receivable from participants were \$36,687 and \$28,881 as of December 31, 2024 and 2023.

*Payment of Benefits*

On termination of service due to death, disability, normal or early retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installment payments for a specified term or through the purchase of an annuity contract available under the terms of the Plan. For termination of service for other reasons, a participant may receive the value of his or her account as a lump-sum distribution. Participants with a vested account balance less than \$5,000 will receive a lump-sum distribution as soon as it is administratively practicable immediately following their separation from service with the Organization.

Withdrawals from a participant's salary deferral account balance may be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Withdrawals from a participant's rollover account may be made at any time. Additionally, in-service withdrawals are allowed in accordance with the provisions specified in the Plan for participants who have attained age 59 ½.

**NOTE 1 – DESCRIPTION OF THE PLAN - CONTINUED**

*Forfeited Accounts*

The Plan Administrator will allocate a Participant forfeiture attributable to nonelective contributions or to matching contributions to first pay reasonable plan expenses and then to allocate to fixed nonelective contributions. During the year ended December 31, 2024, approximately \$35,000 was used to pay plan expenses.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting*

The financial statements of the Plan are prepared under the accrual basis of accounting.

*Investment Valuation and Income Recognition*

The Plan's investments, except for the fixed annuity contracts, are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sale of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in fair value of each type of investment, which includes gains and losses on investments bought and sold, as well as held during the year.

*Notes receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

*Payment of Benefits*

Benefits are recorded when paid.

*Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Subsequent Events*

The Organization has evaluated events and transactions for potential recognition or disclosure through February 24, 2026, which is the date the financial statements were available to be issued.

**NOTE 3 – FAIR VALUE MEASUREMENTS**

The fair value framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include; quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds* Valued at the closing price reported on the active market on which the individual securities are traded (Level 1).

**NOTE 4 – INVESTMENT AT CONTRACT VALUE**

The plan holds an annuity contract in a Schwab Stable Value Fund totaling \$80,701 and \$170,024 at December 31, 2024 and 2023, respectively. This contract meets the fully benefit-responsive investment contract criteria and is reported at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The plan sponsor evaluates the general financial condition of the issuer of the annuity contract that is owned by the plan as a component of validating whether the calculated contract value of the guaranteed contract is an accurate value.

Schwab is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the plan. The crediting rate is based on a formula established by Schwab but may not be less than 1%. The crediting rate is reviewed on a quarterly basis for resetting.

Certain events might limit the ability of the plan to transact at contract value with Schwab. Examples of such events include the following: 1) the plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code, 2) premature termination of the contract, 3) plan termination or merger, 4) changes to the plan's prohibition on competing investment options or 5) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the plan's normal operations. No events are probable of

occurring that might limit the ability of the plan to transact at contract value with Schwab and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events may allow Schwab to terminate the contract with the plan and settle at an amount different from contract value. Examples of such events include the following: 1) an uncured violation of the plan's investment guidelines, 2) a breach of material obligation under the contract, 3) a material misrepresentation, or 4) a material amendment to the agreement without the consent of Schwab.

**NOTE 5 – CERTIFICATION BY CUSTODIAN**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, net appreciation in fair value of investments, interest and dividends and participant loan interest for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Charles Schwab Trust Bank (custodian of the Plan).

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Organization contribution portion of their account.

**NOTE 7 – TAX STATUS**

The Internal Revenue Service has previously not provided plans established under Section 403(b) with a determination or opinion letter indicating that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (the "IRC"). The Plan was amended and restated on January 1, 2020. Although the Plan has never received a determination or opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan had no uncertain tax positions as of December 31, 2024.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 8 – PARTY-IN-INTEREST TRANSACTIONS**

The Plan's investments are managed by Charles Schwab and the Third-Party Administrator is Sentinel Benefits Group, Inc. Transactions conducted with these entities are considered exempt party-in-interest transactions. Total advisory and investment fees paid to Sentinel were \$35,549 for the year ended December 31, 2024.

Due to the level of risk associated with certain investment securities, it is at least reasonable that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
