## Independent Auditor's Report

To the Board of Trustees  
Shopmen's Local Union No. 508  
Health and Welfare Fund

### **Opinion**

We have audited the financial statements of Shopmen's Local Union No. 508 Health and Welfare Fund (the "Fund"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits as of May 31, 2025 and 2024 and the related statement of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

**Note 1 - Description of the Fund**

***General and Eligibility***

The following description of Shopmen's Local Union No. 508 Health and Welfare Fund (the "Fund") provides only general information. A more complete description of the Fund's provisions is contained in its summary plan description.

The Fund is a multiemployer fund established as a result of collective bargaining agreements to provide life, disability, and accident insurance, as well as dental, vision, and hearing aid benefits. The Fund covers employees working under those agreements. For the plan years ended May 31, 2025 and 2024, the Fund includes fully insured coverage. Participating companies (the "Employers") contribute to the Fund on behalf of their union employees. Effective January 1, 2022, the Fund granted the Employers a 40 percent discount on the contribution rates stated in the collective bargaining agreement. The new discounted rates in effect require the Employers to contribute to the Fund at rates ranging from \$0.47 to \$0.81 per hour of compensation paid to eligible employees, depending on benefits provided per the collective bargaining agreement. Subsequent to year end, the trustees approved discontinuance of this discount effective June 1, 2026.

The Employers making contributions to the Fund (as described above) operate in the manufacturing industry in southeastern Michigan and Ohio.

**Note 2 - Summary of Significant Accounting Policies**

***Investment Valuation and Income Recognition***

The Fund's investments are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

***Contributions Receivable***

Contributions receivable principally represent amounts received from the Employers subsequent to year end as contributions related to employee earnings prior to May 31.

Contributions from employers are recognized in the plan year in which members provide services, except where collection is doubtful, in which case they are recorded at the net amount expected to be collected. If credit losses are recovered at a future date, they're recognized upon receipt of the contribution.

***Premium Payments***

Premium payments are expensed in the period they are incurred by the Fund.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

The Fund invests in negotiable certificates of deposit. These are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the changing nature of these assumptions, it is at least reasonably possible that changes in these assumptions and changes in the values of investment securities will occur in the near term and, due to the uncertainties inherent in setting assumptions, that effect of such changes could be material to the financial statements.

**Note 2 - Summary of Significant Accounting Policies (Continued)**

***Fund Termination***

Although there has been no expressed intent to do so, the trustees reserve the right to terminate the Fund at any time. In the event of termination, the trustees shall apply the fund assets to pay any and all obligations. Any further surplus remaining in the Fund shall be used at the discretion of the trustees to provide benefits for the employees covered at the time of the termination of the agreement to the extent that such fund assets remain. None of the surplus is to be distributed directly to the Employers or the participants.

***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including February 17, 2026, which is the date the financial statements were available to be issued.

**Note 3 - Tax Status**

The trust established under the Fund to hold the Fund's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code (the "Code"), and, accordingly, the trust's net investment income is generally exempt from income taxes. The trust has not obtained a favorable tax exemption letter from the Internal Revenue Service; however, the plan sponsor believes that the trust continues to qualify and to operate in accordance with applicable provisions of the Code.

**Note 4 - Transactions with Party in Interest**

The Fund reimburses Iron Workers Regional Shop Local 851, a participating employer, for operating expenses. Total reimbursable operating expenses were \$85,524 and \$82,542 for 2025 and 2024, respectively.

**Note 5 - Fair Value Measurements**

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Fund has the ability to access.

***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Fund's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

**Note 5 - Fair Value Measurements (Continued)**

The following valuation methodologies have been used to value the Fund's investments at May 31, 2025 and 2024:

**Negotiable Certificates of Deposit**

These investments are valued using quoted market prices and/or other market data for the same or comparable instruments and transactions in establishing the prices, discounted cash flow models, and other pricing models. These models are primarily industry-standard models that consider various assumptions, including time value and yield curve, as well as other relevant economic measures.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Fund believes its valuation methodologies are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6 - Certificates of Deposit**

The Fund holds negotiable certificates of deposit totaling \$1,625,812, maturing at various dates between July 24, 2026 and April 16, 2027 and bearing interest at rates ranging from 3.97 to 4.63 percent at May 31, 2025. The Fund held certificates of deposit with total balances of \$1,724,881 at May 31, 2024.

**Note 7 - Operating Leases**

The Fund entered into a noncancelable operating lease for office space during fiscal year 2017 that was renewed in fiscal year 2025. Total costs for the lease were \$19,006 and \$17,864 for fiscal years 2025 and 2024, respectively. The lease expires on November 30, 2027. Future lease commitments are as follows:
