### Notes to the Financial Statements

#### 1. Description of the Plan

The following description of the Jade Global Inc. 401(k) PSP (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### *General*

The Plan is a defined contribution 401(k) profit sharing Plan covering all the employees of Jade Global Inc. (the “Plan Sponsor”). Employees are eligible to participate in the Plan once they have attained age 18 and completed 1 month of service. Employees covered under a collective bargaining agreement and nonresident aliens are not eligible to participate in the Plan. Participants may begin making deferrals into the Plan immediately following eligibility. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and Section 401(a) of the Internal Revenue Code. The Plan administrator is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan’s investment offerings, monitors investment performance and reports to the Plan administrator.

##### *Contributions to the Plan*

Participants may contribute their compensation into the Plan subject to certain non-discrimination restrictions and an annual limitation of \$23,000 for 2024 (\$30,500 for those participants who are age 50 or over). Roth contributions are also permitted under the Plan.

The Plan permits the Plan Sponsor to make discretionary matching and profit sharing contributions. Eligibility for matching and profit sharing contributions are the same as for deferrals and participants must complete at least 500 hours of services. For 2024, the Plan sponsor matched 3% of compensation deferred up to \$4,000 per year and elected to forgo a profit sharing contribution.

##### *Participant Accounts*

All of the Plan’s assets are invested, as directed by the participant, as pooled funds. A participant’s account balance is derived through an allocation of these funds. Each participant's account is credited with the participant's contribution, Plan sponsor matching contributions, and related investment earnings and losses pursuant to the participant's investment allocations. Allocations of income are based strictly on the participant's selection of investments and timing of purchase. Participant accounts are also charged with an allocation of administrative expenses that are paid by the Plan.

##### *Vesting and Forfeitures*

Participants are immediately fully vested in their contributions and related earnings at all times. Participants vest in Plan sponsor matching contribution at the rate of 10% in the first year of service, 20% in the second year of service, 40% in the third year of service, 60% in the fourth year of service, 80% in the fifth year of service and 100% in the sixth year of service. Participants vest in employer profit sharing contribution in ratable installments of 20% in the second year of service. Participants are immediately 100% vested in the event of death, disability, or normal retirement. Forfeitures may be used to reduce Plan Sponsor contributions and to pay Plan expenses. At December 31, 2024 and 2023, forfeitures available to reduce employer contributions and to pay Plan expenses were \$152,865 and \$72,530, respectively. During the year ended December 31, 2024, forfeitures in the amount of \$55,455 were used to reduce employer contributions.

##### *Payment of Benefits*

The Plan provides for the payment of benefits to the participants (or, if applicable, the beneficiary) at normal retirement (age 59), death, disability, financial hardship, or termination of employment. In-service distributions are also available at any time for rollover contribution. Participants who qualify for retirement benefits and withdrawals will receive their benefits in the form of a lump sum payment or partial payments. The benefit to which a participant is entitled is the benefit that can be provided directly from the participant's vested account balance. Participants who separate from service and have vested account balances of \$1,000 or less are subject to an administrative lump sum distribution at the discretion of the Plan administrator. Retired participants must begin receiving distributions from the Plan no later than April 1 of the year following the year in which the participant attains age 73.

#### ***Notes Receivable from Participants***

Participants may obtain a loan from the Plan based on their vested account balance. Loans are limited to the lesser of \$50,000 or 50% of the participant's vested account balance. The minimum loan amount is \$1,000. Participants may only have one outstanding loan at a time. Loans bear an interest rate equal to the prime rate determined on the date of the advance by the Plan administrator. All loans have a term of not more than five years (unless the loan is used to acquire a principal residence) and are payable through regular payroll deductions. Loans are segregated investments, and to the extent a participant borrows, his or her account will not share in the earnings and gains in value attributable to other Plan investments. The interest that participants pay on their loans will be directly credited to their accounts. The loans are secured by the balance in the participant's account and in the event of default, the unpaid loan principal will be offset against the participant's vested account balance.

#### ***Plan Amendments***

The Plan was without amendment during 2024.

## **2. Summary of Significant Accounting Policies**

#### ***Basis of Accounting***

The accompanying financial statements have been prepared on the accrual basis of accounting and in accordance with ERISA. Contributions from participants are recorded when withheld from the participant. Plan sponsor contributions are recorded when approved by the Plan sponsor. Benefit payments are recorded when paid.

#### ***Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value as determined by the Plan custodian. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

#### ***Excess Contributions Payable***

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding increase to distributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from the participants are charged directly to

the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

#### ***Subsequent Events***

The Plan has evaluated subsequent events through February 23, 2026, the date the financial statements were available to be issued.

### **3. Certification of Assets**

Ascensus Trust Company ("Ascensus") serves as the trustee of the Plan's assets. In that capacity, Ascensus holds the Plan's assets and executes investment transactions. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA). As permitted under such election, the Plan administrator has obtained certifications from Ascensus as of December 31, 2024 and 2023 and for the year ended December 31, 2024 that all investment information supplied to the Plan is complete and accurate. Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and interest, dividends and net appreciation/depreciation in fair value of investments for the year ended December 31, 2024, was obtained or derived from the certified information.

The framework for measuring fair value provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements.) The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

#### ***Level 1***

Inputs to the valuation methodology are unadjusted quoted prices for identical assets and or liabilities in active markets that the Plan has the ability to access.

#### ***Level 2***

Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, inputs that are derived principally from or corroborated by observable

market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 inputs must be observable for substantially the full term of the asset or liability.

#### ***Level 3***

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level with the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money Market funds:* Valued at the quoted net asset value of shares held by the Plan at year-end

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net assets value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **5. Tax Status**

The Plan sponsor has adopted the Ascensus Non-Standardized Pre-Approved Profit Sharing plan. The Pre-Approved plan received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the Pre-Approved plan was designed in accordance with applicable sections of the Internal Revenue Code. Although the Plan has been amended since the opinion letter, the Plan sponsor and administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Accordingly, the Plan sponsor and administrator believe that the Plan is qualified and its related trust is exempt from tax.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor or Internal Revenue Service. Management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **6. Plan Termination**

Although it has not expressed any intent to do so, the Plan sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all non-vested account balances would become 100% vested.

#### 7. Related Party Transactions

Ascensus Trust Company (“Ascensus”) serves as the trustee of the Plan’s assets. All transactions with Ascensus qualify as party-in-interest transactions.

Fees incurred by the Plan for investment management services are included in net appreciation/depreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments totaling \$3,290 to the recordkeeper which were not covered by revenue sharing. The Plan Sponsor pays directly any other fees related to the Plan’s operations.

#### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with these securities and the level of uncertainty related to changes in the value, it is at least reasonably possible that changes in the various risk factors will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the accompanying financial statements.

These contributions are considered a nonexempt party-in-interest transaction subject to an excise tax that the company intends to pay.
