Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the SelectQuote Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO THE FINANCIAL STATEMENTS JUNE 30, 2025 AND 2024

1. DESCRIPTION OF THE PLAN

The following description of the SelectQuote Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan’s adoption agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan that covers substantially all employees of SelectQuote Insurance Services, Inside Response, LLC, and SelectQuote Auto and Home Insurance Services, LLC, (collectively, the “Company”) who meet eligibility requirements. Effective April 1, 2024, SQ Care Management, LLC was added as a participating employer. Charles Schwab Trust Bank (“Schwab”) is the Plan’s trustee, custodian, and recordkeeper. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility – Employees are eligible to make salary deferral contributions to the Plan beginning on the first day of the month after reaching 18 years old and completing 30 days of service. Leased employees, union employees, interns and non-resident aliens are not eligible for the Plan.

Contributions – Participants may elect to contribute up to 50% of their annual compensation subject to certain Internal Revenue Code (“IRC”) limitations. Participants age 50 or older may make additional catch-up contributions subject to IRC limitations. Participants may direct their contributions to various mutual funds or common collective trusts (“CCT”).

Effective July 1, 2024, the Plan added an automatic enrollment provision. Upon reaching the eligibility conditions, a participant will automatically be enrolled in the Plan to defer 6% of eligible compensation, unless another amount is elected in writing. Effective April 1, 2025, PRN employees are excluded from the automatic enrollment provision.

The Company matches the participants’ contributions at a discretionary rate every payroll period. The rate for the 2025 Plan year was 50% of the first 6% contributed. When adding the matching contribution to each participant’s account, the funds are allocated proportionately to the investment funds that each participant has selected.

The Company may also declare a discretionary profit-sharing contribution and/or a discretionary additional matching contribution. In order to receive either employer contribution, the employee must be employed on the last day of the year. However, employees who are not employed on the last day of the Plan year due to death, disability or termination due to reaching normal retirement age (as described in the adoption agreement) shall receive a profit-sharing contribution. During the 2025 Plan year, no profit-sharing contribution was declared. A matching contribution was declared during 2025 at 1% of eligible compensation totaling \$2,397,485.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and an allocation of (a) the Company’s contribution, (b) Plan earnings, and (c) administrative expenses. Distributions reduce the participants’ accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting – Participants’ contributions are fully vested at all times. Employer contributions vest in 25% increments, with 25% vested in the first year, 50% vested after the second year, etc. Employer contributions become fully vested after 4 years. In the event of permanent disability or death of a participant, the employer contributions will become fully vested.

Forfeitures – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. At June 30, 2025 and 2024, there were \$65,728 and \$69,698 in forfeitures, respectively, which may be used to pay Plan expenses or reduce employer contributions. For the year ended June 30, 2025, \$172,616 was used to pay Plan administrative fees and \$267,096 was used reduce employer contributions.

Payment of Benefits – Upon termination of employment, the participant, or in the case of death, the participant's beneficiary can elect to receive the participant's account balance in a single lump-sum or in the form of an annuity in accordance with the Plan document. Participants with an account balance less than \$7,000, at termination of service, are required to take a lump-sum distribution, or roll the balance of the account to an IRA or other qualified plan.

In-Service Distributions – Participants' who have reached the age of 59½ may withdraw all or a portion of their vested funds.

Notes Receivable from Participants – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan term is five years (or longer for the purchase of a primary residence). Participants may only have one loan outstanding at any time. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 2%. Principal and interest are paid ratably through payroll deductions.

Administrative Expenses – The Plan Sponsor or the Plan may pay the professional service fees of the Plan. During the year ended June 30, 2025, administrative and investment advisory fees of \$270,708 were paid from the Plan.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, participants' accounts would become fully vested, and all remaining Plan assets would be allocated to the participants as described in the full text of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

Investment Valuation and Income Recognition – The Plan's investments in the mutual funds and CCTs are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

Notes receivable from participants – Participant notes receivable are valued at their unpaid principal balance plus accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance is considered necessary.

Payment of Benefits – Benefit payments are reported in the year paid.

Excess Contributions Payable – Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Date of Management's Review – Subsequent events have been evaluated through February 27, 2026, which is the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2025 and 2024:

Mutual Funds – Valued at the published net asset value (“NAV”) of shares held by the Plan at year end.

Common Collective Trusts – The value of a separate account is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) Certain investments that were measured at net asset value per share (or its equivalent) have not been classified in the fair value hierarchy. 4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY THE TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Schwab, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate with respect to investments as of June 30, 2025 and 2024, and for the year ended June 30, 2025:

- Investments, at fair value
- Notes receivable from participants, and related interest income
- Net appreciation in fair value of investments
- Dividends and interest income
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

The Plan paid Schwab, the trustee of the Plan, administrative fees for the Plan year ended June 30, 2025. These transactions qualify as party-in-interest.

Additionally, notes receivable from participants are an exempt party-in-interest transaction.

7. TAX STATUS

The Prototype Non-Standardized Profit-Sharing Plan with CODA used by the Plan received a favorable Internal Revenue Service opinion letter dated September 21, 2020, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has since been amended; however, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of June 30, 2025. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. PROHIBITED TRANSACTIONS

During the year ended June 30, 2025, employee deferrals of \$810 were withheld from various payrolls and not remitted to the trust on a timely basis (as defined by the Department of Labor "DOL") by the Plan sponsor. The Plan Sponsor remitted all such deferrals to the trust along with the appropriate excise tax and lost earnings for these late contributions. These transactions are prohibited according to the provisions of the DOL.

During the year ended June 30, 2024, employee deferrals of \$6,380 were withheld from various payrolls and not remitted to the trust on a timely basis (as defined by the Department of Labor "DOL") by the Plan sponsor. The Plan Sponsor remitted all such deferrals to the trust along with the appropriate excise tax and lost earnings for these late contributions. These transactions are prohibited according to the provisions of the DOL.

Effective July 1, 2025, the Plan was amended to allow hardship distributions from vested account balances, excluding rollover accounts, with a minimum withdrawal of \$500. One hardship withdrawal may be made in a 12-month period.
