INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Management
Potluck Hospitality 401(k) Profit Sharing Plan and Trust

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Potluck Hospitality 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits (liquidation basis) as of April 16, 2024, and the related statement of changes in net assets available for benefits in liquidation for the period of January 1, 2024 through April 16, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Potluck Hospitality 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the period ended April 16, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

Opinion (continued)

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Potluck Hospitality 401(k) Profit Sharing Plan and Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Emphasis of Matter – Plan Termination and Use of Liquidation Basis of Accounting

As further discussed in Note 8 to the financial statements, Plan management made a decision to terminate the Potluck Hospitality 401(k) Profit Sharing Plan and Trust and determined that liquidation is imminent. As a result, in accordance with accounting principles generally accepted in the United States of America, Potluck Hospitality 401(k) Profit Sharing Plan and Trust has changed its basis of accounting from the going concern basis of accounting to the liquidation basis of accounting in presenting the Plan's 2024 and 2023 financial statements. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of Plan

The following brief description of the Potluck Hospitality 401(k) Profit Sharing Plan and Trust ("the Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, formed on January 1, 2023, covering substantially all employees of Potluck Hospitality, Wonderslice Pizza LLC, Carriqui LLC, Pearl Bottling Department LLC, Pearl FH Beverage Company LLC, and Howdy Child LLC (collectively, the "Company") meeting participation requirements described below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and qualifies under Section 401(a) of the Internal Revenue Code ("the Code"). The Plan is sponsored by Potluck Hospitality. Mid-Atlantic Trust Company ("MATC") serves as the custodian. The record-keeper and third-party administrator of the Plan is Paychex, Inc. for the period of January 1, 2024 through April 16, 2024 and for the year ended December 31, 2023. Paychex, Inc. provides administrative services to the Plan. The Plan was restated as of October 11, 2023.

Plan Merger

On September 27, 2023, management made the decision to merge the Plan into Silver Associates' Savings Plan. No contributions were allowed into the plan after December 8, 2023. The Plan was terminated on December 31, 2023, and was liquidated on April 16, 2024. As a result, all investments held at the liquidation date were transferred from the Plan into the Silver Associates' Savings Plan.

General Eligibility

Company employees hired prior to the Plan's adoption were automatically eligible to participate. All employees at least twenty-one (21) years of age are eligible to participate in the Plan after completing three months of service. The employees can enroll on the first day of the month after eligibility requirements are met. Eligible employees are automatically enrolled in the plan with a 5% deferral rate, unless otherwise elected by the participant. No automatic deferral percentage increases included in the Plan.

1. Description of Plan (Continued)

Contributions

Participants may elect to make both pre-tax and Roth salary reduction contributions, subject to an annual limit of the lesser of 92% of the eligible compensation or \$23,000 in a calendar year for 2024 and \$22,500 in a calendar year for 2023. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participant contributions may not exceed the limits established by the Internal Revenue Service. A participant's pre-tax and Roth deferrals will be separately accounted for, as will gains and losses attributable to each. Participants who are at least age 50 or will attain age 50 before the end of a calendar year are eligible to defer additional amounts ("catch-up contribution") to the Plan. The maximum catch-up contribution that eligible participants can make was \$7,500 if you are 50 years old or older in 2024 and 2023. Eligible employees may also contribute amounts representing distributions from other plans and certain IRAs. Participants direct the investment of their contributions into the various investment options offered by the Plan.

The Company will also make a safe-harbor matching contribution of 100% of the first 3% contributed by the employee, plus an additional 50% of the next 2% for a max of 5%. The company safe-harbor match is fully vested when contributed. There were no safe-harbor matching contributions for the period of January 1, 2024 through April 16, 2024. Safe-harbor matching contributions in the amount of \$193,103 were recorded for the year ended December 31, 2023.

The Plan provides for the employer to make a discretionary profit-sharing contribution every year; however, for the period of January 1, 2024 through April 16, 2024 and for the year ended December 31, 2023, no profit-sharing contribution was made.

Investment Options

Upon enrollment in the Plan, a participant directs both the participant and Company contributions in any or all of the investment options offered by the Plan. Participants may change their investment options at will.

Participant Accounts

Each participant's account is credited with the participant's contribution, safe-harbor matching contribution, profit-sharing contribution, and attributable Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. Description of Plan (Continued)

Funding Policy

It is the policy of the Plan sponsor to remit the employee contributions as soon as administratively possible, but no later than 7 business days after the date of payroll.

Vesting

Participants are immediately 100% vested in their elective deferral contributions, safe-harbor matching contributions, and profit-sharing contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 95% of one half of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest is paid ratably through monthly payroll deductions. There were no outstanding loan principal balances as of April 16, 2024. Outstanding loan principal balances amount to \$61,558 as of December 31, 2023.

Payment of Benefits

Vested benefits are paid to participants upon death, disability, retirement or termination of employment by either arranging for a rollover to another plan, lump sum payment, or installments. Hardship withdrawals are available and subject to certain limitations. Upon attaining age 59 1/2 a participant employed by the Company may elect certain in-service withdrawals from their vested account balance. Such distributions are subject to certain taxes, fees, and other restrictions. For terminated participants' account balances that are less than \$5,000, the plan administrator will automatically roll the amount into an IRA. If the participant's vested portion is greater than \$5,000, the participant may elect to maintain the vested portion in the Plan.

Forfeitures

Forfeitures occur when a participant terminates employment before becoming 100% vested with respect to the safe-harbor matching and profit-sharing contributions and earnings thereon. For the period of January 1, 2024 through April 16, 2024 and for the year ended December 31, 2023, there was no forfeitures as participants are immediately 100% vested in safe-harbor and profit-sharing contributions.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the liquidation basis of accounting in accordance with FASB ASC 962-40, Plan Accounting for Defined Contribution Pension Plans – Terminating Plans.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (“GAAP”) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The fair value of the above investments is disclosed further at Note 7.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of April 16, 2024 and December 31, 2023, no allowance for credit losses has been recorded.

If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions recognized for the period of January 1, 2024 through April 16, 2024 and for the year ended December 31, 2023.

Payment of Benefits

Benefits are recorded when paid.

Terminated Employees with Vested Benefits

As of April 16, 2024, there were no terminated participants with vested balances. As of December 31, 2023, there were four (4) terminated participants with vested balances in the amount of \$132,830 remaining in the Plan. The benefit payments are not reflected in the financial statements until benefit claims have been processed and approved for payment.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Distribution and loan fees are charged directly to the requesting participant's account. Investment related expenses are included in net appreciation of fair value of investments. For the period of January 1, 2024 through April 16, 2024, the Plan paid \$4,497 in administrative expenses. For the year ended December 31, 2023, the Plan paid \$11,152 in administrative expenses.

3. Information Prepared and Certified by the Trustee (Unaudited)

The following information, which Mid-Atlantic Trust Company certified as complete and accurate, has not been subjected to audit procedures:

- Investments in mutual funds and common collective trusts, net appreciation in investments, and other dividend income.

The Plan's independent auditors did not perform any auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements.

4. Tax Status

The Plan sponsor adopted the Paychex, Inc. Non-Standardized Pre-Approved Profit Sharing Plan with CODA, which received a favorable opinion letter, from the Internal Revenue Service dated August 31, 2020, which states that the Plan is designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of April 16, 2024 and December 31, 2023, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

5. Related-Party Transactions

Certain Plan investments are mutual funds managed by Paychex Retirement Services. Mid-Atlantic Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the custodial and record-keeping services amounted to \$4,497 for the period of January 1, 2024 through April 16, 2024 and \$11,152 for the year ended December 31, 2023. These party-in-interest transactions were not prohibited transactions.

6. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying Statements of Net Assets Available for Plan Benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

7. Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end based on quoted market prices.

Common Collective Trusts: Common collective trusts are valued at the net asset value (NAV) of units held by the Plan at year-end. The NAV is determined by the custodian of the fund and is based upon the fair value of the underlying assets held by the fund. NAV is used as a practical expedient to estimate fair value. There are no participant redemption restrictions for these investments; the redemption notice period is applicable only to the Plan.

8. Subsequent Events and Termination of the Plan Upon Merger

Management has conducted a review of subsequent events for possible disclosure in or correction of these financial statements through July 30, 2025, the date the financial statements were available to be issued.

On September 27, 2023, management made the decision to merge the Plan into Silver Associates' Savings Plan. No contributions were allowed into the plan after December 8, 2023. The Plan was terminated on December 31, 2023, and was liquidated on April 16, 2024. All participants were fully vested in their account balances. As a result, all investments held at the liquidation date were transferred from the Plan into the Silver Associates' Savings Plan. This had no impact on the values of the assets reported on the financial statements and there were no liabilities recognized in connection with the termination.
