## **INDEPENDENT AUDITORS' REPORT**

### **Opinion**

We have audited the accompanying financial statements of Consolidated Builders Benefits Trust Health and Welfare Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of Consolidated Builders Benefits Trust Health and Welfare Plan as of June 30, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Consolidated Builders Benefits Trust Health and Welfare Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

### **Responsibilities of the Board of Trustees for the Financial Statements**

The Plan's Board of Trustees is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Plan's Board of Trustees is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Consolidated Builders Benefits Trust Health and Welfare Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

The Plan's Board of Trustees is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTES TO FINANCIAL STATEMENTS

---

**1. ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Organization* - Consolidated Builders Benefits Trust Health and Welfare Plan (the "Plan"), formed on July 1, 1997, provides certain fully-insured benefits covering enrolled participants of participating employers. Eligible participating employers for the years ended June 30, 2025 and 2024 include members of the Indiana-Armstrong Builders Association, Builders Association of Metropolitan Pittsburgh and Pennsylvania Builders Association (collectively, the "Associations"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, and regulation under state law.

The Plan is a multiple employer welfare benefit association (MEWA) which utilizes a voluntary employee benefit association, a trust, as its operating vehicle. Medical, dental and vision as well as life insurance benefits are available to full-time employees of participating employers and to their covered spouses, dependents and domestic partners of the opposite sex. If coverage under the Plan ceases because of certain qualifying events, participants may have the right to purchase continuation coverage for a temporary period of time under the Consolidated Omnibus Budget Reconciliation Act of 1996 (COBRA).

Benefits (medical, hospital, surgical, major medical, vision, and dental) are provided under group insurance contracts between the Plan and Highmark Blue Cross/Blue Shield (Highmark), Davis Vision, and United Concordia. The arrangements with Highmark, Davis Vision, and United Concordia are for terms that extend through December 31, 2026, 2027, and 2029, respectively.

Eligibility of participants varies by employer, each of which maintains plan documents describing those Plan coverages that are available to their employees, retirees and dependents as well as any copay requirements. Premiums for monthly coverage, as well as a charge for the Plan's administrative costs, are billed and collected in the month prior to coverage. These premiums are remitted to the insurer in the middle of the month of coverage. All of the coverages are fully-insured.

The activities of the Plan are controlled by a five member Board of Trustees consisting of officials from the Associations. The Plan has no employees. My Benefit Advisor (see Note 2) serves as the Plan's third party administrator and consultant and uses AMCA Systems, LLC as a subcontractor.

*Basis of Accounting* - The accounts of the Plan are maintained on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

*Use of Estimates* - The preparation of financial statements in conformity with U.S. GAAP often involves estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of revenues and expenses during the reporting periods. However, these financial statements do not include estimates.

*Receivable from Highmark* - Effective January 1, 2025, the Plan entered into a renewal of its group insurance contract with Highmark, which extended the term of the contract through December 31, 2025. In conjunction with this renewal, the Plan received a loyalty credit in the amount of \$33,000, which represented a reduction to premiums for the period of January 1, 2024 through December 31, 2024, and which was applied against premiums for the month of January 2025. In the event that the Plan terminated its contract with Highmark prior to December 31, 2025, Highmark reserved the right to seek repayment of 50% of the loyalty credit, or \$16,500.

Accordingly, 50% of the loyalty credit was recognized as a reduction to premium expense on a systematic and rationale basis for the period from January 1, 2024 through December 31, 2024. The remaining 50% of the loyalty credit is being recognized as a reduction to premium expense on a systematic and rationale basis during the period of January 1, 2025 through December 31, 2025. The receivable from Highmark at June 30, 2024 represents the amount recognized as a reduction to premium expense during the year ended June 30, 2024. The deferred provider payment at June 30, 2025 represents the amount that will be recognized as a reduction to premium expense during the year ending June 30, 2026.

*Revenue Recognition* - Billings related to group insurance coverage provided under contracts between the Plan and the insurer as well as administrative charges and participation fees are recognized in the period to which the coverage and charges pertain.

It is the Plan's practice to bill in advance of the period to which the coverage pertains. Generally, participating entities must pay their billed amounts by the 20th day of the month preceding the month to which coverage pertains. If a participating employer does not pay their monthly billed amount, coverage can be terminated by the insurer. Advance payments represent payments received prior to the end of the current fiscal year for subsequent year coverage.

During the year ended June 30, 2024, the Board of Trustees determined that advance payments were understated by \$15,417 at June 30, 2023. Advance payments were corrected by reducing premium revenue during the year ended June 30, 2024.

*Subsequent Events* - The Board of Trustees and third party administrator evaluated subsequent events through February 17, 2026, the date which the financial statements were available to be issued.

## **2. ADMINISTRATION AND SERVICES AGREEMENT**

The Plan has contracted My Benefit Advisor to provide comprehensive administration and marketing services, whether directly or through the engagement of other professionals and consultants. The Plan's obligation to My Benefit Advisor for marketing and service fees is satisfied via standard commissions paid directly by Highmark. My Benefit Advisor contributed \$12,000 and \$9,000 of these commissions to the Plan during the years ended June 30, 2025 and 2024, respectively, of which \$3,000 and \$6,000 is included in the receivable from My Benefit Advisor at June 30, 2025 and 2024, respectively.

My Benefit Advisor provided billing, collection services and accounting services to the Plan. These services amounted to \$9,828 and \$11,475 for the years ended June 30, 2025 and 2024, respectively. The services are net of an agreed-upon reimbursement by My Benefit Advisor of approximately 50% of the billing and collection services.

The Plan collects participation fees of \$1 per month per covered employee from participating employers. The Plan remitted these fees to the respective Associations through September 2022. Beginning in October 2022, the Plan is no longer remitting these fees to the respective Associations.

COBRA administration fees are paid by the Plan and are reimbursed by My Benefit Advisor.

## **3. PLAN TERMINATION**

Although it has not expressed any intention to do so, the Board of Trustees has the right under the Plan to modify the benefits provided to active employees and to terminate the Plan subject to the provisions set forth in ERISA.

## **4. INCOME TAX STATUS**

The Plan requested and received tax-exempt status under Section 501(c)(9) of the Internal Revenue Code. The latest determination letter was received on January 23, 1999, in which the Internal Revenue Service stated that the trust, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes that the Plan has and continues to operate in compliance with the applicable provisions of the Internal Revenue Code.

U.S. GAAP prescribes a comprehensive model for the financial statement recognition, measurement, presentation, and disclosure of uncertain tax positions taken or expected to be taken in income tax returns. The Board of Trustees and third party administrator believe that there is no liability related to uncertain tax positions at June 30, 2025 or 2024. The Plan is no longer subject to tax examinations for years before June 30, 2022.

**5. CONCENTRATION**

The Plan had two participating employers that represented approximately 39% and 29% of total premiums for the years ended June 30, 2025 and 2024, respectively.

**6. RELATED PARTIES**

The Trustees of the Board involved in administering the Plan do not receive any compensation from the Plan.
