Notes to Financial Statements  
June 30, 2025 and 2024

1. Description of the Plan

The following description of the 403(b) Thrift Plan of The Arc Northern Chesapeake Region, Inc., (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Arc Northern Chesapeake Region, Inc. is the Plan Sponsor (the Sponsor).

- A. General - The Plan is a defined contribution plan covering substantially all employees of The Arc Northern Chesapeake Region, Inc. (The Arc). There is no age or service requirement to become eligible to make salary deferrals. Employees are required to be at least 18 years old and to have one year of service to be eligible for employer matching contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Sponsor oversees governance of the Plan, determines the appropriateness of investment offerings, and monitors investment performance. The Plan was most recently amended and restated effective June 1, 2024.
- B. Contributions - Each year, participants may contribute up to 100 percent of pre-tax annual compensation, as defined in the Plan. Effective April 1, 2017, participants may elect to make post-tax Roth contributions. Effective July 1, 2021, the Plan was amended to allow for automatic contributions whereas all new hires are enrolled at an employee contribution percentage of 1% with an automatic annual increase up of an additional 1% per year up to a maximum of 3%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Effective July 1, 2015, the Plan allows for discretionary employer matching contributions. The Employer made a matching contribution of \$1 for every \$1 contributed by the employee, up to a maximum of \$1,000 for the years ended June 30, 2025 and 2024. Participants direct the investment of their contributions and any employer contributions into various investment options offered by the Plan within its investment contracts with Lincoln National Life Insurance Company (Lincoln National) and Mutual of America Life Insurance Company (Mutual of America) under pooled separate accounts or guaranteed funds in the general account.
- C. Participant Accounts - Each participant's account is credited with the participant's contributions and allocations of (a) The Sponsor's contributions, and (b) plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- D. Vesting - Participants are immediately vested in their contributions, including designated Roth contributions and rollovers, plus actual earnings thereon. Participants are vested 33% per year in the portion of their accounts representing employer basic and matching contributions and are fully vested after three years of service.

- E. Notes Receivable from Participants - Participants may borrow from Mutual of America or Lincoln National based on their account balance at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates commensurate with the prevailing market rates. Principal and interest is paid ratably through payroll deduction to Mutual of America or Lincoln National, not the Plan.
  
- F. Payment of Benefits - On termination of service due to death, disability, or retirement, a participant or their beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, installments, or an annuity. Retirement benefits paid to married participants are subject to certain provisions and spousal consents. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If the balance of a participant's account is \$5,000 or less, the terminating participant's vesting balance can be distributed immediately with or without the taxpayer's consent. Hardship distributions are permitted in accordance with applicable federal laws. Upon taking a hardship distribution, the participant is not permitted to make contributions for a period of 6 months.
  
- G. Forfeited Accounts – As of June 30, 2025 and 2024, forfeited non-vested accounts totaled \$2,788 and \$853, respectively. On July 1, 2015, the Plan was amended whereby forfeitures will be allocated among participants following year-end based on the ratio of each participant's compensation to the total of all plan participants' compensation. During the years ended June 30, 2025 and 2024, the Plan allocated \$2,432 and \$504, respectively.

2. Significant Accounting Policies

Basis of Accounting - The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value, except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Sponsor determines the Plan's valuation policies. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are not carried as plan assets as they are loans provided to the participants from Mutual of America and Lincoln National secured by participant account balances.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

*Level 1 Fair Value Measurements*

The Mutual of America Interest Accumulation Account is considered to be comparable to a cash equivalent, as there are no front- or back-end charges (so investments in the account are completely liquid), the interest rate credited is the current rate and is not dependent on the length of time assets are invested, requests for withdrawal can be made at any time and are processed on the day that they are received, the insurance company does not have to liquidate securities in order to generate a payment, and the value shown is the redeemable value of the fund with no deferred sales charges, load assessments, or interest rate adjustments that would affect the value of a withdrawal request.

*Investments Measured at Net Asset Value*

Pooled separate accounts are valued at net asset value (NAV) of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Gains and losses included in the changes in net assets available for benefits for the years ended June 30, 2025 and 2024, are reported in net appreciation in fair value of investments.

The Plan's policy is to recognize transfers between Level 1 and Level 2 and into and out of Level 3 at the end of the reporting period. For the years ended June 30, 2025 and 2024, there were no significant transfers between Level 1 and Level 2 or into or out of Level 3.

5. Investment Contracts with Insurance Companies

Pooled Separate Accounts

The Plan entered into a variable group annuity contract with Lincoln National Life Insurance Company and Mutual of America Life Insurance Company. Both maintain the contributions in pooled separate accounts which are invested, at the direction of the participants, in various mutual funds of registered management investment companies. The accounts are credited with earnings on the underlying investments and charged for plan withdrawals and administrative expenses charged by the underlying mutual funds and by Lincoln National Life Insurance Company and Mutual of America Life Insurance Company. These assets are valued at the current value of the underlying mutual funds. These are measured by the number of units of participation held by the Plan.

Interest Accumulation Account

Participants may elect to invest in a general account (Interest Accumulation Account), which is maintained by Mutual of America, and backed by the general assets of Mutual of America. Amounts placed in the general account are credited with interest at a rate determined by Mutual of America from time to time, and Mutual of America reserves the right to change the interest rates applicable to amounts held in the Interest Accumulation Account at their discretion, but not below the minimum guaranteed interest rate of 2.85%. Participant's principal and previously credited interest is guaranteed. The general account assets are carried at amortized cost, or contract value, which is deemed to be fair value for an insurance company general account. The investment is not a guaranteed investment contract, and therefore, the concept of benefit responsiveness does not apply. As of June 30, 2025 and 2024, the Interest Accumulation Account average yields based on actual earnings and interest rate credited to participants was approximately 2.85% each year.

Fully Benefit-Responsive Investment Contract

The Plan entered into a fully benefit-responsive guaranteed investment contract with Lincoln National, which maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The investment balances are tracked in the Lincoln National Life Insurance Company Fixed Account.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at fair value which is equivalent to contract value. Contract value, as reported to the Plan by Lincoln National, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The fair value of the Lincoln National Life Insurance Company Fixed Account at June 30, 2025 and 2024 was \$129,974 and \$134,838, respectively. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with Lincoln National. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

6. Loans to Participants

Mutual of America and Lincoln National have reported to the Company that a total of \$38,234 and \$45,048 in loans to participants were outstanding at June 30, 2025 and 2024, respectively. As of June 30, 2025 and 2024, there were no defaulted loans.

The collateral for these loans is held by the Plan in each participant's respective account balance.

7. Plan Termination

Although it has not expressed any intention to do so, the Sponsor has the right under the Plan to discontinue its participation at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan terminations, participants would become 100% vested in their employer contributions.

8. Tax Status

The Plan is qualified under Section 403(b) of the Internal Revenue Code (IRC). The Organization has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated November 29, 2024, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan had been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax-exempt.

9. Related-Party and Party-in-Interest Transactions

Plan investments are pooled separate accounts (with underlying mutual funds) and insurance company general accounts managed by Lincoln National Life Insurance Company and Mutual of America Life Insurance Company, the Trustees, as of June 30, 2025 and 2024. Lincoln National and Mutual of America also serve as the Plan's record keepers. Lincoln National and Mutual of America are therefore considered to be parties-in-interest. As described in Note 2, the Sponsor pays certain plan expenses. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

11. Subsequent Events

Effective September 1, 2025 the plan was amended to elect to be a multiple employer plan. Participating employers may now modify all elections.

The Plan has evaluated subsequent events through February 10, 2026, the date the financial statements were available to be issued.
