#### *Opinion*

We have audited the financial statements of AMN Healthcare, Inc. Health and Welfare Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of AMN Healthcare, Inc. ## AMN Services, Inc. Health and Welfare Plan Notes to Financial Statements

---

### Note 1 – Description of Plan

The following description of the AMN Services, Inc., Health and Welfare Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of Plan provisions.

**General** – The Plan provides health and welfare benefits to substantially all full-time employees of American Mobile Healthcare (AMN) Services, Inc. (Plan Sponsor and Employer) who have at least 90 days of service and who are scheduled to work more than eight hours per week in San Francisco, and who are not (1) compensated shareholders, (2) employees that have waived or are exempt from the San Francisco Health Care Security Ordinance, or (3) employees enrolled in a group medical plan either through their employer or another employer's group plan, including their spouse's or parent's plan. Eligible participants (employees) enter the Plan on the first day of the month coinciding with or next following the date on which such requirements are satisfied.

The Plan was originated to be in compliance with Article 21: San Francisco Health Care Security Ordinance (SFHCSO) which requires employers with 20+ employees working in San Francisco (50+ for Not For Profits) at least eight hours a week to contribute a calculated amount per hour to the Plan to reimburse for covered expenditures submitted by plan participants.

**Contributions** – The Plan is funded solely through employer quarterly contributions for those employees who worked a minimum average of eight hours per week in San Francisco at an hourly rate of \$3.51 for 2024. The hourly rate will be adjusted in accordance with the SFHCSO every year. Each Participant will accrue a benefit for each week worked and the total accrued during each calendar quarter will be credited to the Participant's account within 30 days after the last day of the quarter. Participants are vested immediately in the employer contributions.

**Participant accounts** – Each participant's account is credited with the employer's contributions. Once an amount is credited, it will remain available to the participant for their benefits until such account balance has been depleted. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on flat amount each quarter for participants with account balances.

**Plan benefits** – The Plan provides for reimbursement to participants for qualifying expenses. The Plan allows participants to be reimbursed 100% for certain out-of-pocket dental and vision expenses which are incurred by the participant and their dependents subject to their available account balance. The expenses which qualify are those permitted by Federal Regulation 54.9831-1. Participants are also eligible for reimbursement for any other IRS allowed "excepted benefit" including dental and vision expenses and medical indemnity insurance premiums, long-term, nursing home, home health, community-based care, and coverage limited to a specific disease or illness.

**Plan termination** – The Trustees, as plan administrator, do not have the right to terminate the Plan. Participants shall continue to be eligible for reimbursement as irrevocable balances will remain available until depleted through eligible claims and account maintenance fees.

### Note 2 – Summary of Significant Accounting Policies

**Basis of accounting** – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Concentration of credit risk** – Plan assets are held by a financial institution. Deposits maintained in the Plan account are restricted for payments of Plan benefits and administrative expenses. Cash held in the account by the financial institution is insured by the Federal Deposit Insurance Corporation (FDIC) up to \$250,000. At times, the balance of the cash account may be in excess of federally insured limits.

**Contributions receivable** – Contributions due from the employer but not received at year-end are recorded as contributions receivable in the accompanying statements of net assets available for benefits.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Administrative expenses are paid by the participants for maintenance of participants' accounts and administration of the Plan on a quarterly basis.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through March 4, 2026, which is the date the financial statements were available to be issued.

### Note 3 – Tax Status

The Plan's trust does not qualify as a tax-exempt trust under the Internal Revenue Code. Accordingly, the trust is subject to federal and applicable state income taxes on any taxable income generated by trust assets. During the year ended December 31, 2024, the trust's assets were maintained exclusively in a non-interest-bearing cash account. As a result, the trust did not earn investment income during the year and did not incur federal or state income tax expense.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 4 – Party-in-Interest Transactions

The Plan sponsor has contracted with a third party for administrative services. Navia Benefits Solutions administers participant accounts and processes benefit reimbursements which are related to services provided by parties in interest.
