We have performed audits of the financial statements of the Institute for Supply Management 403(b) TDA Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of August 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended August 31, 2025, and the related notes to the financial statements.

## **Note 1. Plan Description**

### ***General***

The following description of the Institute for Supply Management 403(b) TDA Plan (Plan) provides only general information. Participants should refer to the plan document for a complete description of the Plan's provisions.

The Plan is a defined contribution plan covering substantially all employees of Institute for Supply Management (Company and Plan Administrator). Employees regularly scheduled to work more than 30 hours per week are eligible to participate in the Plan immediately upon hire. Employees regularly scheduled to work fewer than 30 hours per week are eligible to participate in the Plan after completing 12 months of service, during which the employee is credited with 1,000 hours, as defined by the plan document. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). TIAA-CREF serves as the issuer of the TIAA Traditional Annuity contract held by the Plan and is the record-keeper of the Plan. TIAA-CREF serves as plan trustee.

### ***Contributions***

Each year, participants may elect to defer a portion of their pretax compensation, as defined by the plan document. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Contributions are subject to certain limitations. Effective September 1, 2024, participants may elect to defer a portion of their compensation as Roth contributions, as defined by the plan document.

### ***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account balance.

### ***Vesting***

Participants are vested immediately in their contributions plus actual earnings thereon.

### ***Notes Receivable from Participants***

The plan document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan shall be \$1,000. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) to TIAA-CREF directly. Interest on the loans is based on local prevailing rates as determined by the Plan Administrator.

### ***Payment of Benefits***

Upon termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of their account or an annuity contract (if assets are held in a custodial account) or convert to an income option (if assets are invested in an annuity contract). A participant may elect to receive a

distribution of their rollover contributions at any time. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

## **Note 2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments.

The fair values of guaranteed investment contracts (excluding fully benefit-responsive investment contracts) are calculated by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes Receivable From Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

### ***Plan Loans***

TIAA and CREF issues loans to plan participants outside the scope of the Plan. Participants may borrow directly from funds held by TIAA and CREF, the issuer of the investments and the record-keeper for the Plan. The loans may be up to the lesser of \$50,000 or 45% of the participant's account balance. These loans are not funded with plan assets. At August 31, 2025, there are no outstanding policy plan loans issued by TIAA and CREF secured by the balance in the participant accounts. The loan interest rates for these policy loans may be fixed or variable and the initial rate is determined by the terms of the controlling contract, as are the rate adjustment details and frequency. Principal and interest are paid directly to TIAA and CREF, and each payment will reduce amounts collateralized by the borrowing participant's fixed annuity contract balance.

Adequate security is required, and a portion of the participant's account is reserved or held in collateral to cover 110% of the outstanding loan in case of default. The collateral is held in the fixed annuity contracts either as part

of a Group Supplemental Retirement Account contract or as a separate Retirement Loan contract. The Plan Administrator has concluded that these loans are not plan assets and that such arrangements are exempt transactions. As of August 31, 2025 and 2024, there are no outstanding policy plan loans nor related collateral.

In the event of default, such loans are reportable to plan participants as taxable income but remain outstanding and continue to accrue interest until repaid by the plan participant or the participant becomes eligible to receive a distribution under the terms of the Plan. During 2025 and 2024, no loans went into default.

The Employee Benefit Security Administration (EBSA) has expressed concern that the pledging of collateral of a participant's balance could be considered a prohibited transaction; however, formal guidance has yet to be issued by the EBSA.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of TIAA and CREF**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and CREF, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of August 31, 2025 and 2024
- Investment income and interest income on notes receivable from participants as shown in the accompanying statement of changes in net assets available for benefits for the year ended August 31, 2025
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of August 31, 2025

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the accompanying financial statements and ERISA-required supplemental schedule.

**Note 4. Related-Party and Party-In-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments are units of variable annuity accounts or a pooled separate account that is managed by an entity related to TIAA and CREF, which is the record-keeper for the Plan. The Plan's traditional annuity contract is maintained in TIAA and CREF's general account. Therefore, these investments and transactions in

these investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Fees paid to TIAA and CREF were approximately \$58,100. This amount reflects the application of plan credits that reduced total fees, which included a revenue credit of approximately \$9,000 for the year ended August 31, 2025. Additionally, the Plan paid approximately \$18,000 for professional fees during 2025.

**Note 5. Disclosures about Fair Value of Plan Assets and Liabilities**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and significant to the fair value of the assets or liabilities

The following table presents the fair value measurements of assets and liabilities recognized in the accompanying statements of net assets available for benefits measured at fair value on a recurring basis and the level within the fair value hierarchy in which the fair value measurements fall at August 31:

The following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the evaluation hierarchy. There have been no significant

changes in the valuation techniques during the years ended August 31, 2025 and 2024. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis. For assets classified within Level 3 of the fair value hierarchy, the process used to develop the reported fair value is described below.

***Variable Annuity Contracts***

These investments are primarily valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments, including matrix pricing. CREF Money Market Account holdings are generally valued at amortized cost, which approximates fair value.

***Pooled Separate Accounts***

The TIAA Real Estate Account value, which is the only pooled separate account in the Plan, is principally derived from the market value of the underlying real estate holdings or other real estate-related investments. Real estate holdings are valued principally using external appraisals, which are estimates of property values based on a professional's opinion. The TIAA Real Estate Account may also hold securities. These are generally priced using values obtained from independent pricing sources.

***Fixed Annuity Contracts***

The fixed annuity contracts in the Plan are guaranteed investment contracts, which are valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of TIAA and CREF.

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. See the table below for inputs and valuation techniques used for Level 3 securities.

**Note 6. Fixed Annuity Contracts**

The Plan has fixed annuity contracts with TIAA and CREF. Under these contracts are sub-contracts, some of which are fully benefit-responsive, while others are not. TIAA and CREF maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Each premium allocated to a fixed annuity contract buys a guaranteed minimum amount of lifetime income based on the rate schedule in effect at the time the premium is credited.

For fixed annuity contracts that are fully benefit-responsive, contract value is the relevant measurement attribute for the portion of the net assets available for benefits attributable to the fixed annuity contract. These contracts are included in the financial statements at contract value. TIAA and CREF has reported to the Plan that contract value approximates fair value for the fixed annuity contracts and approximated \$1,241,000 and \$1,263,000 at August 31, 2025 and 2024, respectively. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Fixed annuity contracts that are not fully benefit-responsive are included in the financial statements at fair value as reported by TIAA and CREF. TIAA and CREF has reported to the Plan that the fair value for the fixed annuity contracts that are not fully benefit-responsive was approximately \$1,354,000 and \$1,441,000 at August 31, 2025 and 2024, respectively.

Certain events limit the ability of the Plan to transact at contract value with TIAA and CREF. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes in the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Company does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**Note 8. Tax Status**

The Plan operates under a volume submitter agreement in connection with a volume submitter pension plan and custodial document sponsored by TIAA-CREF. This volume submitter plan document has obtained an advisory letter from the IRS stating that the volume submitter satisfies the requirements under Section 403(b) of the Internal Revenue Code. The Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

**Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Note 10. Subsequent Events**

Subsequent events have been evaluated through February 25, 2026, which is the date the financial statements were available to be issued.
