### Note 1: Description of Plan

The following description of the Learfield Communications Group Benefit Trust, Inc. (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan provides welfare benefits to eligible employees of Learfield Communications, LLC, and companies affiliated through common ownership and management (the Company). The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan began operations on January 1, 2015, with its activity recorded in a Plan bank account. Effective April 1, 2015, the Plan's activity was recorded through a trust account set up for the Plan. Previously, benefits were provided directly by the Company through self-insured coverage.

#### Benefits

The Plan provides health benefits (major medical, dental, vision, and prescription medicines), life insurance, and disability to eligible employees (those scheduled to work more than thirty hours per week and have been employed for more than thirty days of continuous employment) and to their covered dependents. The Plan also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA). There are no post-employment or post-retirement benefits provided by the Plan.

Dental, vision, life insurance, and disability benefits are fully insured through premium payments by the Plan to insurance carriers. The Plan provides health coverage under a partially self-insured welfare plan with a reinsurance policy to cover individual health claims over a set dollar limit (\$275,000 for 2024 and \$250,000 for 2023), subject to certain provisions. The Plan's reinsurance policy annual maximum balance was unlimited in 2024 and 2023. Claims are processed by a third party administrator, but responsibility for payment and providers is retained by the Plan.

In addition to deductibles and copayments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay the full cost of vision insurance and a portion of dental, life, and medical insurance based on the current group premium cost. The Company pays the full cost of long term disability and stop-loss insurance, and a portion of dental, life, and medical insurance.

#### Death Benefits

The Plan provides death benefits to the participant and the participant's covered dependents for any claims incurred through the end of the month in which the participant ceases to be eligible for the Plan due to death.

### **Note 1: Description of Plan (Continued)**

#### **Contributions**

The employees contribute a portion of the Plan's cost for employee and dependent coverage through a salary-reduction plan. These amounts are used to offset amounts contributed by the Company to fund the Plan's operations. These contributions are based on the amount necessary to provide the benefits outlined in the Plan and are determined annually by the Plan's Trustees.

The Company makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Company on a pay-as-you-go basis.

#### **Administrative Expenses**

The Company administers the Plan through the Trustees, who have hired a third party administrator to process claims and other providers and consultants to provide additional services to the Plan. The Plan pays administrative expenses that consist primarily of administrative fees paid to the third party claims administrators. All other administrative expenses, such as professional fees not directly related to the Plan, are paid by the Company on behalf of the Plan. In addition, certain administrative functions are performed by employees of the Company. Currently, the Plan is not charged for these services.

#### **Plan Termination**

Although it has not taken any steps to do so, the Trust's management has the right to amend and terminate the Trust with a written instrument and by vote of at least two-thirds of the member companies, subject to the provisions set forth in ERISA. In the event of the termination of the Trust, any remaining funds shall be used for the benefit of the covered employees on the basis of objective and reasonable standards. In no event shall any of the Trust's funds revert to or be recoverable by the participating member companies.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States ("GAAP").

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

### **Note 2: Summary of Significant Accounting Policies (Continued)**

#### **Payment of Benefits**

Premiums paid by the Plan are recorded as insurance premium payments in the accompanying statements of changes in net assets available for benefits. Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan are recorded as a payable in the accompanying statements of net assets available for benefits. These payments are recorded as claims paid in the accompanying statements of changes in net assets available for benefits.

#### **Stop Loss**

Premiums from stop loss insurance are included in insurance premium expense while stop loss reimbursements are netted with claims paid in the accompanying statements of changes in net assets available for benefits. During the year ended December 31, 2024, the Plan received notification from the provider regarding a premium adjustment totaling \$701,275. This amount was determined to be receivable by the Plan as of December 31, 2024, and is included in other receivables within the statement of net assets available for benefits.

#### **Concentration of Credit Risk Arising from Cash Deposits in Excess of Insured Limits**

Cash and cash equivalents include cash on hand and investments with original maturities of three months or less. No such short-term investments were held at December 31, 2024 or 2023. The Plan maintains its cash balances at one financial institution which provides insurance through the Federal Deposit Insurance Corporation on the first \$250,000 at December 31, 2024 and 2023. At various times throughout the years ended December 31, 2024 and 2023, the Plan had balances in excess of the federally insured limits. At December 31, 2024, the Plan's uninsured bank balance totaled approximately \$374,071. Management believes the Company is not exposed to any significant credit risks with this institution.

#### **Contributions Receivable**

Contributions are generally remitted weekly to the Plan. Contributions due for periods through the financial statement date are reflected in "contributions receivable" in the accompanying financial statements.

#### **Claims Incurred But Not Reported**

The Plan's actuaries calculate an estimate of health claims incurred but not reported (IBNR) in accordance with accepted actuarial principles based on historical claim information of the Plan, claims data provided by the Plan's third-party administrators, expected claim increases, and other factors. The amounts ultimately paid will likely differ from the amounts estimated.

#### **Subsequent Events**

Management has evaluated subsequent events through February 26, 2026, the date of the independent auditor's report, the date the financial statements were available to be issued.

### Note 2: Summary of Significant Accounting Policies (Continued)

#### Reclassification

Certain reclassifications have been made to the 2023 financial statements to conform to the 2024 presentation. The change had no effect on the 2023 results of operations.

### Note 3: Tax Status

The VEBA trust funding benefits of the Plan received an exemption letter from the Internal Revenue Service (IRS) dated June 6, 2016, and effective December 9, 2014, stating that Learfield Communications Group Benefit Trust, Inc. is tax-exempt under the provisions of Section 501 (c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan's funding policy, from time to time the trust may be subject to income taxes. No federal or state income taxes have been recorded in 2024 or 2023 for unrelated business taxable income.

In addition, the Plan and the trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The plan administrator and the plan's tax counsel believe that the Plan is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
