Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of International Brotherhood of Electrical Workers Local Union 305 Pension Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. DESCRIPTION OF THE PLAN:

The following description of the International Brotherhood of Electrical Workers Local Union 305 Pension Plan ("Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution, multi-employer plan for the benefit of employees covered by a Collective Bargaining Agreement ("the Agreement") or a Participation Agreement between the Central Indiana Chapter, NECA and International Brotherhood of Electrical Workers Local Union 305 (Local Union 305). Companies with employees covered by the Agreement ("Employer") remit contributions to the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan and is available for more detailed information.

Eligibility

Employees become eligible to participate in the Plan as of the first day of the month following completion of one hour of work for an Employer who is bound to a collective bargaining agreement or other written participation agreement with Local Union 305 requiring contributions to the Plan on the employees' behalf.

Employer contributions

For each active employee (journeyman and apprentices above the second period) covered by the Agreement, the Employer contributes, on a monthly basis, 10% of the total gross wages earned in the preceding month, except for employees who work under a telecommunications contract, for which the employer contributes \$1.85 per hour. Also, if an employee is working on a market recovery project, the Employer contributes an additional 25% of the total gross wages earned while working on the project.

Participant contributions

Participants may make voluntary, nondeductible contributions of up to 10% of the preceding year's gross wages, not to exceed the statutory dollar limit established by the Internal Revenue Code (IRC). Participants must apply for, and be approved by, the Board of Trustees prior to making a contribution. Applications for voluntary contributions are accepted from January 1st through March 1st of each year. Employees are not required to make elective contributions in order to participate in the Plan.

Participant accounts

Individual account balances are maintained for each participant. Each participant's account is credited with the participant's contribution, if any, the Employer's contribution, an allocation of Plan earnings and is charged with any withdrawals and an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant-directed investment options

Upon enrollment in the Plan, a participant may direct employee and employer contributions in whole percentages into various funds offered by the custodian of the Plan. All amounts in participant accounts are participant-directed and can be changed daily.

1. DESCRIPTION OF THE PLAN (CONTINUED):

Vesting

Participants are immediately vested in their elective (voluntary) contributions and income or loss thereon. Vesting in the Employer's contribution occurs in the first Plan year in which the employee receives contributions for 300 hours of service.

Forfeitures

Participants who terminate employment prior to becoming vested must forfeit the entire balance of their Employer contributions and any gain or loss thereon. If the participant resumes employment covered under the Plan before incurring five consecutive one year breaks in service, the portion of the account derived from Employer contributions is restored. Forfeitures are used to defray proper expenses of administering the Plan. During the years ending May 31, 2025 and 2024, forfeitures totaling \$0 were used to reduce plan expenses. At May 31, 2025 and 2024, there was approximately \$4,983 and \$4,758 in unused forfeitures, respectively.

Benefit payments

Vested participants who have satisfied the requirements for distribution of benefits through retirement, death, disability, or termination of employment may elect to receive a distribution from the Plan. Methods of distribution include lump sum payments and joint and survivor annuities.

Terminated participants who are eligible to receive benefits are entitled to receive a maximum of 100% of the nonforfeitable portion of their participant accounts accrued before January 1, 2010, provided they have not engaged in covered employment for twelve months prior to the payment or annuity starting date. Participants may receive a maximum of 35% of the nonforfeitable portion of their participant accounts that was accrued after December 31, 2009, if they have not engaged in covered employment for a period of twenty-four consecutive months prior to the payment or annuity starting date. Any remaining balances in a participant's account will be distributable upon attainment of normal retirement age.

Termination of the Plan

Although the Trustees of the Plan have not expressed any intent to terminate the Plan, they may do so at any time, subject to the provisions set forth in ERISA. In the event of termination, participants will become fully vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The financial statements of the plan are prepared on the accrual basis of accounting.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Benefits

Benefit payments to participants are recorded when paid.

Investment valuation and income recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Expense offset arrangement

Revenue is earned by the Plan from mutual fund providers and is used to pay Plan expenses. Revenue sharing contributions are recorded as other income and the expenses paid with the contributions are recorded as administrative fees.

Employer contributions receivable

Employer contributions receivable represents amounts due from employers that were received subsequent to year end. Therefore, the carrying amount of these receivables is not reduced by an allowance for amounts that will not be collected. In addition, it is impractical to estimate revenue recognition for amounts due but erroneously unreported by employers.

Reciprocity contributions

Participants of the Plan and participants of the benefit plans of other affiliated local unions may have temporary employment assignments outside the jurisdiction of their local union. Therefore, the Plan has entered into reciprocity agreements with other affiliated locals to ensure that employer contributions are forwarded to the benefit plans of the participant's local union. Reciprocal contributions received and reciprocal contributions paid are classified with employer contributions on the statements of changes in net assets available for benefits.

Subsequent events

The Plan has evaluated subsequent events through February 25, 2026, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY PLAN'S CUSTODIAN:

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Retirement, the custodian, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of May 31, 2025 and 2024 and the supplemental schedule of assets (held at end of year) as of May 31, 2025 and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended May 31, 2025 and 2024.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets' or liabilities' fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025 and 2024.

Money market fund: Valued at cost, which approximates fair value.

Mutual funds: Consists of mutual funds registered with the Securities and Exchange Commission. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds are required to publish their daily Net Asset Value (NAV) and to transact at that price at the end of each trading day. Mutual funds held by the Plan are deemed to be actively traded.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Administrative expenses for legal, accounting and other services are rendered by parties-in-interest and are paid by the Plan. The Plan incurred expenses totaling \$214,570 and \$238,178 for the Plan years ended May 31, 2025 and 2024, respectively. Trustee-approved administrative fees in the amount of \$5,400 for both years ended May 31 are paid to an International Brotherhood of Electrical Workers Local Union 305 employee, who is also a participant. Certain fees incurred by the Plan for investment management services are netted against other income, as they are paid through revenue sharing.

6. TAX STATUS:

The Plan obtained its latest determination letter dated September 22, 2015, in which the Internal Revenue Service stated the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan is required to operate in conformity with the Code and the Employee Retirement Income Securities Act of 1974 to maintain its tax exempt status. The Plan has been amended since receiving the determination letter. The Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.
