INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of
Machinery Movers, Riggers and Machinery Erectors
Local 136 Defined Contribution Retirement Trust Fund

Opinion

We have audited the accompanying financial statements of Machinery Movers, Riggers and Machinery Erectors Local 136 Defined Contribution Retirement Trust Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.


In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Plan as of June 30, 2025 and 2024, and the changes in its net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.



NOTES TO FINANCIAL STATEMENTS

YEARS ENDED JUNE 30, 2025 AND 2024

NOTE 1. DESCRIPTION OF THE PLAN

The following description of the Machinery Movers, Riggers and Machinery Erectors Local 136 Defined Contribution Retirement Trust Fund (the Plan) provides general information only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General - The Plan was established July 1, 1988, under collective bargaining agreements as a participant-directed defined contribution pension plan exclusively for the purpose of providing retirement income benefits to employees and their families and/or beneficiaries. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Employer Contributions - For the plan years ended June 30, 2025 and 2024, Street employers contributed at an hourly rate of \$13.02 and \$12.02, respectively, for each hour a participant has worked. For the plan years ended June 30, 2025 and 2024, Trade Show employers contributed at an hourly rate of \$15.41 and \$14.21, respectively, for each hour a participant has worked.

Participant Accounts - Each participant's account is credited with the employer contribution and investment earnings, net of administrative expenses. Participants select the investment accounts of their choosing. Earnings are credited to their account based on the performance of the accounts selected. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting - Prior to July 1, 2005, a participant is vested and shall have a non-forfeitable interest in his account after earning 500 hours of service in a plan year. Starting July 1, 2005, a participant is vested and shall have a non-forfeitable interest in his account after 3 consecutive years-of-service or 5 non-consecutive years-of-service, which are not interrupted by a permanent break in service. Any year with less than 800 hours in contributions will constitute a break in service.

Forfeitures - A member, who incurs a permanent break in service, will have his account forfeited. Forfeited accounts will be used to defray the cost of general and administrative expenses with the remainder, if any, allocated to active and vested participants on a pro-rata basis. There were \$-0- and \$124,762, respectively, in forfeitures during the years ended June 30, 2025 and 2024.



NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Payment of Benefits - Upon retirement or separation of service after 90 days, vested participants are entitled to receive a benefit at normal retirement age of 65 or elect an early retirement benefit with any of the following: completion of 20 years-of-service, attaining age 50 with completion of 3 years-of-service, or attaining age 62. Effective June 1, 2023, participants are eligible to receive an early distribution benefit after attaining 15 years-of-service and has not received employer contributions on their behalf for 6 consecutive months. Effective May 1, 2025, active participants are eligible to receive an in-service distribution every 24 months after attaining age 59 ½ subject to account balance limits.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared using the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Cash - Cash consists of a checking account.

Investment Valuation and Income Recognition - Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

The Plan's investment in the New York Life - Anchor Stable Value Account is a fully benefit-responsive investment and is reported at contract value. Contract value is calculated based on original cost plus accrued interest on investment contracts. See Note 6 for discussion of contract value measurements.

Purchases and sales of securities are reported on a trade-date basis. Interest income is reported on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation in fair value of self-directed investments include the Plan's gains and losses on investments bought and sold as well as held during the year. The Plan's investments are held by John Hancock Retirement Plan Services.

Employer Contributions Receivable - Contributions receivable at June 30, 2025 and 2024 represents amounts received subsequent to year end for work performed through June 30. Employer records are subject to audit and additional revenue, if any, that may arise as a result of these audits is recognized when received. Based on review of historical losses, current economic conditions and supportable and reasonable forecast assumptions, management has concluded that any expected credit losses on balances outstanding at year end will be immaterial.

Estimates - The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.



NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Payment of Benefits - Benefits are recorded when paid.

Expenses - The Plan's expenses are paid by the Plan as provided by the plan document. Expenses incurred in connection with the general administration of the Plan are reported as deductions in the accompanying statements of changes in net assets available for benefits. Recordkeeping fees are netted with revenue sharing credits received.

NOTE 3. TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Plan by letter dated September 2, 2015 that the Plan and related Trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan's administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As of June 30, 2025 and 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 4. PRIORITIES UPON TERMINATION

Although it has not expressed any intent to do so, the Board of Trustees has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, distribution of Plan assets will be made to the participants after all expenses incurred by the Plan are paid.

NOTE 5. FAIR VALUE MEASUREMENTS

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include other significant observable inputs including:

NOTE 5. FAIR VALUE MEASUREMENTS (CONTINUED)

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's and liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at June 30, 2025 and 2024.

Registered investment companies: Valued based on the closing price reported in the active market in which the funds are traded.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS

As discussed in Note 2, the New York Life - Anchor Stable Value Account is a group annuity contract. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan.

The group annuity contract provides for two distinct accounts:

1. The Anchor Stable Value Account is a book value record of the amounts deposited to and withdrawn from the pooled separate account. That is, the Anchor Stable Value account is at all times equal to the contributions made to the contract plus interest and dividends, if any, less expenses and withdrawals.
2. Pooled separate account is the underlying investment account in which all contributions are invested.

The Anchor Stable Value Account represents the guarantee that New York Life is making to the Plan sponsors participating in the group annuity contract.

The assets in the pooled separate account are invested primarily in fixed income securities, which are owned by New York Life Insurance Company. However, the assets in this account are maintained solely for the benefit of the contract holders participating in the separate account and are not chargeable with any other liabilities arising out of any other business of New York Life.

The assets in the pooled separate accounts are not marked-to-market to reflect changes in interest rates. Instead, they are valued on an amortized cost basis in accordance with Section 4240(a)(10) of the New York State Insurance Law.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to be tax-exempt under Section 501(a) of the IRC;
2. Premature termination of the contracts;
3. Plan termination or merger;
4. Changes to the Plan's prohibition on competing investment options; and
5. Bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.



NOTE 6. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACTS (CONTINUED)

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines;
2. A breach of material obligation under the contract;
3. A material misrepresentation; and
4. A material amendment to the agreements without the consent of the issuer.

NOTE 7. DUE FROM AFFILIATED FUND AND PARTY-IN-INTEREST TRANSACTIONS

As of June 30, 2024, the Plan has a \$6,250 payable to Machinery Movers, Riggers and Machinery Erectors Local 136 Supplemental Retirement Trust Fund (SRP Fund) (a related party) for Plan expenses paid by the SRP Fund. The balance owed was paid by the Plan during the year ended June 30, 2025.

The Plan pays certain investment and administrative fees directly to service providers. These transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that the values of investment securities could be different at the reporting date and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


