Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Retirement Plan for Clerical and Maintenance Employees of the University of Scranton, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Retirement Plan for Clerical and Maintenance Employees of the University of Scranton's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of May 31, 2025 and 2024, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the "Auditor's Responsibilities for the Audit of the Financial Statements" section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meet the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the “Auditor’s Responsibilities for the Audit of the Financial Statements” section of our report. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Note 1. Description of Plan

The following description of the Retirement Plan for Clerical and Maintenance Employees of the University of Scranton (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan is a defined-contribution plan covering clerical and maintenance employees of the University of Scranton (University) who have completed six months of service. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). The University of Scranton is the trustee of the Plan. Teachers Insurance and Annuity Association (TIAA), College Retirement Equities Fund (CREF), and TIAA Trust, N.A. (prior to July 14, 2023, TIAA, FSB) serve as Plan custodians.

Contributions

The Plan is funded solely by University contributions equal to eight percent of each participant's compensation, as defined, for the Plan year. A participant must complete at least 1,000 hours of service during the Plan year to be eligible for the contribution. Participants may also contribute amounts representing distributions from other qualified retirement plans. Contributions are subject to certain limitations.

Participant Investment Account Options

Investment account options available include various funds, separate accounts, annuity contracts, and a guaranteed investment contract. Each participant has the option of directing his or her contributions into any of the separate investment accounts and may change the allocation daily.

Participant Accounts

Each participant's account is credited with allocations of the University's contribution and Plan earnings and charged with an allocation of Plan expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in University contributions and earnings thereon.

Payment of Benefits

On termination of service, death, disability or retirement, a participant is eligible to receive a distribution equal to the value of the participant's vested interest in his or her account. The normal form of benefit payment is a lump-sum distribution.

The Plan allows automatic rollovers if the present value of the participant's vested account balance is greater than \$1,000. The participant must consent to the distribution if the present value is more than \$5,000.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value, which approximates fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from the University are recorded in the year in which participant compensation is earned.

Payment of Benefits

Benefits are recorded when paid.

Plan Tax Status

The Plan operates under a non-standardized adoption agreement in connection with a pre-approved prototype retirement plan document sponsored by TIAA. This prototype plan document has been filed with the appropriate agency and has obtained an opinion letter from the IRS stating that the prototype constitutes a qualified plan under Section 401 of the Internal Revenue Code. The Plan has been amended since the prototype received the opinion letter; however, the Plan Administrator believes that the Plan was qualified and tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Administrative Expenses

Administrative expenses may be paid by the University or the Plan, at the University's discretion.

Subsequent Events

Subsequent events have been evaluated through February 26, 2026, which is the date the financial statements were available to be issued.

Note 3. Contracts With Insurance Companies

The Plan has guaranteed investment contracts with New York Life Insurance Company and Teachers Insurance and Annuity Association (TIAA). The insurance companies maintain the contributions to the contracts in their general accounts which are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The insurance companies are contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

The Plan offers the option to invest in The New York Life Insurance Company Guaranteed Interest Account (GIA), which is a stable value product that guarantees the return of principal and accumulated interest. The GIA contract seeks to provide participants with competitive credit rates and limited volatility consistent with the preservation of capital. Contributions are directed to a broadly diversified fixed income portfolio within New York Life's general account. The crediting rate will be reset on January 1 and July 1 and guaranteed for a six-month period. The minimum guaranteed rate of interest for the GIA contract is subject to change every six months but will always be greater than 1.00%. The crediting interest at both May 31, 2025 and 2024 was 2.70%.

The Plan also offers the option to invest in the TIAA Traditional Annuity Account, a guaranteed annuity contract with TIAA, which invests in the Retirement Annuity (RA) account. The TIAA Traditional Annuity Account is a contractual obligation to repay the principal and a specified interest rate that is guaranteed to the Plan. The contract with TIAA is a nonbenefit-responsive contract and is valued based upon TIAA's quoted redemption value of the contract owned by the Plan participant at year end. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon by the issuer, which will not be less than zero percent. Such interest rates are reviewed on an annual basis for resetting. The crediting interest at May 31, 2025 and 2024 was 5.25% and 5.50%, respectively.

The TIAA Traditional Annuity Account is a single group annuity contract with a fixed rate of interest. Interest is credited to the account and accumulations include a guaranteed rate, plus discretionary additional amounts determined annually by the TIAA Board of Trustees. The additional amounts, when declared, remain in effect through the "declaration year," which begins each March 1. The guaranteed annual interest rate is 3.00% for all premiums remitted since 1979 under all TIAA Traditional Annuity accumulating contracts. They are not a portfolio of contracts whose yields are based on changes in fair value of underlying assets, therefore, the average yield earned by the Plan is the interest earned on the group annuity contract. The TIAA Traditional Annuity Account does not permit TIAA to terminate the agreement prior to the scheduled maturity date.

Effective June 2023, the Plan offers the option to invest in the TIAA Stable Value, a fixed-rate group annuity contract offered by TIAA. Contributions are deposited into a non-unitized separate account. The contract provides a guaranteed minimum rate of interest of between 1% and 3% before deduction for contract fees with the potential for crediting of additional interest above the guaranteed minimum. Additional interest, when declared by the TIAA Board of Trustees, remains in effect from January 1 through June 30 and from July 1 through December 31 and is not guaranteed for future periods. Transfers into TIAA Stable Value may not be made for 30 days following a transfer out. TIAA Stable Value is immediately liquid to participants and doesn't have participant-level withdrawal restrictions. The group annuity contract is fully benefit responsive; therefore, contract value is the relevant measurement because the contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by TIAA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against the contract value for credit risk of the contract issuer or otherwise. The group annuity contract does not permit TIAA to terminate the agreement prior to the scheduled maturity date.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash

provisions, (3) bankruptcy of the Sponsor or other events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

Note 4. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives of such persons.

The Plan's investments are managed by CAPFinancial Partners, LLC and TIAA and CREF, the Plan's custodians, therefore, these transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing, rather than a direct payment.

The Plan paid \$16,391 and \$22,379 of recordkeeping fees to TIAA during the years ended May 31, 2025 and 2024, respectively. The Plan held \$440 and \$420 in funds to pay future fees at May 31, 2025 and 2024, respectively. Certain administrative functions of the Plan are performed by officers or employees of the University. No such officer or employee receives compensation from the Plan. Certain administrative expenses are paid by the University.

Note 5. Plan Termination

Although it has not expressed any intent to do so, the University has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 6. Information Certified by Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, TIAA and CREF, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of May 31, 2025 and 2024.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended May 31, 2025 and 2024.
- Investment information included in the accompanying schedule of assets (held at end of year) as of May 31, 2025.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 7. Fair Value Measurements

The Plan measures its investments at fair value on a recurring basis in accordance with U.S. GAAP. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework that the authoritative guidance establishes for measuring fair value includes a hierarchy used to classify the inputs used in measuring fair value. The hierarchy prioritizes the inputs used in determining valuations into three levels. The level in the fair value hierarchy within which the fair value measurement falls is determined based on the lowest level input that is significant to the fair value measurement. The levels of the fair value hierarchy are as follows:

- Level 1** Fair value is based on unadjusted quoted prices in active markets that are accessible to the Plan for identical assets. These generally provide the most reliable evidence and are used to measure fair value whenever available.
- Level 2** Fair value is based on significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted market prices in active markets for similar assets or liabilities, quoted market prices in inactive markets for identical or similar assets or liabilities and other observable inputs.
- Level 3** Fair value would be based on significant unobservable inputs. Examples of valuation methodologies that would result in Level 3 classification include option pricing models, discounted cash flows, and similar techniques.

The investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies and inputs used for investments measured at fair value on a recurring basis. There have been no changes in methodologies used at May 31, 2025 and 2024.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 investments include registered investment companies. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. Level 2 investments include TIAA Real Estate Account and CREF separate accounts. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. Level 3 investments include TIAA Traditional Annuity Account and New York Life Guaranteed Interest Account. See the table below for inputs and valuation techniques used for Level 3 securities.
