Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Hughes Brothers Construction, Inc. 401(k) Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

DECEMBER 31, 2024 AND 2023

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Hughes Brothers Construction, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Hughes Brothers Construction, Inc. (the Company or Employer), which covers all employees except for union employees, nonresident aliens, leased employees, seasonal employees and temporary employees as defined by the Plan. The Plan was effective January 1, 2022, and provides eligible employees a means of regular and systematic savings with several investment options. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

Employees are eligible to participate in the Plan upon completing one year of service, obtaining age 18 and working a required 1,000 hours during the first year of employment or working at least 1,000 hours during any Plan year thereafter. Employees may elect to participate in the Plan on the first day of the quarter coinciding with or next following the date requirements are met.

Contributions

Each year, participants may elect to contribute pre-tax and/or Roth 401(k) contributions to the Plan between 1% and 100% of their qualified compensation, as defined by the Plan, subject to certain limitations under the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Any elective deferral contributions in excess of the statutory annual limits are refunded to the participant and are recognized as excess contributions payable as of year-end. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company provides a matching contribution equal to 50% of the participant's elective deferrals that do not exceed 6% of the participant's compensation.

The Company may make discretionary profit sharing contributions to the Plan in such an amount determined by the Plan Sponsor. Each employee that is employed on the last day of the year, are credited with at least 1,000 hours of service during the plan year, or an eligible employee that died, became subject to a disability during the plan year or termination of employment after normal retirement age is entitled to an allocation of the Company discretionary profit sharing contributions. During the year ended December 31, 2024, the Company did not make any discretionary profit sharing contributions.

Participant Accounts

Individual accounts are maintained for each of the Plan's participants to reflect the participant's contributions, the Company's matching contributions, Company discretionary profit sharing contributions, as well as the participant's share of the Plan's earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 – DESCRIPTION OF THE PLAN

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based on years of service. A participant is 100% vested upon normal retirement, permanent disability, or death of a participant. Otherwise, Company contributions vest as follows:

One year of service of vesting purposes consists of the attainment of at least 1,000 hours of service during the Plan year.

Notes Receivable from Participants

The Plan does not allow loans to participants.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant with a vested account balance that does not exceed \$5,000 will receive a lump sum amount equal to the value of the participant's vested interest in his or her account, while a participant with a vested account balance that exceeds \$5,000 may elect to receive a single lump sum payment or partial withdrawals. The non-vested portion will be forfeited, unless the employee returns to service with the Employer before incurring five consecutive one year breaks in service or the distribution of the entire vested portion of the participant's account, in which case the account balance will be restored unadjusted for any gains or losses. In-service distributions may be made to a participant who has not separated from the Company, is 100% vested and has reached age 59 ½.

Forfeited Accounts

At December 31, 2024 and 2023, there were \$17,352 and \$4,036, respectively of forfeited nonvested accounts. Forfeited accounts may be used to reduce future employer contributions. During 2024, there were no forfeited nonvested accounts utilized to reduce employer contributions.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for a further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the plan year.

Contributions

Contributions from Plan participants and the matching contribution from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

NOTE 3 – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are managed by Capital Group Retirement Plan Services (Capital Group). Capital Group is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. During the year ended December 31, 2024, the Plan made direct payments of \$6,234 to certain parties-in-interest for administration and investment advisory fees, as allowed by ERISA. The Plan sponsor pays directly any other fees related to the operation of the Plan.

NOTE 4 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

NOTE 5 – TAX STATUS

The Plan sponsor adopted a prototype non-standardized profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020, which states that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since receiving the determination letter, Plan management believes the Plan is being operated in compliance with the applicable requirements of the IRC and therefore believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not, based on the technical merits, would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Generally, the statute of limitations for the IRS to assess taxes on a plan expires three years from the due date of the return or the date on which it was filed, whichever is later.

NOTE 6 – CERTIFIED INVESTMENT INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Capital Bank and Trust Company (the custodian of the Plan). This information has not been audited by the Plan's independent auditors.

NOTE 7 – FAIR VALUE MEASUREMENTS

The Plan utilizes Accounting Standards Codification (ASC) 820, *Fair Value Measurements*. ASC 820 establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 7 – FAIR VALUE MEASUREMENTS

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3

Inputs to the valuation method are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 – PROHIBITED TRANSACTIONS

The Company identified the following prohibited transactions:

During 2024 and 2023, there were instances in which employee and employer contribution remittances were delayed. Participant contributions have been remitted to the Plan. Lost earnings have not been remitted to the Plan as of December 31, 2024 and 2023. Refer to Schedule H, Line 4a.

During 2024, it was discovered that employee and employer contribution remittances did not include all funds withheld from payroll. It was also discovered that one payroll remittance was remitted twice to the Plan. Corrective contributions and lost earnings have not been remitted to the Plan as of December 31, 2024.

During 2023, it was discovered that eligible compensation was improperly excluded from Plan deferrals. This resulted in missed contribution opportunities and related lost earnings for employees. As of the report date, the Company has not determined the corrective action needed. The Plan Sponsor is working with the Third Party Administrator for the calculation of the corrective amount to be funded.

NOTE 10 – SUBSEQUENT EVENTS

The Plan assessed events that have occurred subsequent to December 31, 2024 through October 15, 2025, the date the financial statements were available to be issued, for potential recognition and disclosure in the financial statements.

The Securing a Strong Retirement Act of 2022 (SECURE 2.0 Act) was signed into law on December 29, 2022, and includes mandatory and optional provisions with varying effective dates in 2025 and later. The Plan Administrator will determine the optional provisions to elect and amend the Plan document accordingly.

Subsequent to year end, effective July 1, 2025, the Plan Document was amended to exclude certain other compensation from the definition of compensation for deferral purposes. This compensation was previously included and then erroneously excluded in 2023 and 2024.

No other events have occurred that would require adjustment to or disclosure in the financial statement which were available to be issued on October 15, 2025.
