Opinion

Syntrio Solutions, LLC Health Benefits Plan Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Syntrio Solutions, LLC Health Benefits Plan (the Plan) provides only general information. Participants should refer to the Plan agreement, as amended, for a more complete description of Plan provisions.

General – The Plan was established in June 2005 and provides health and other benefits covering substantially all employees, certain retired individuals and their dependents of Syntrio Solutions, LLC (the Plan Sponsor or the Company). The Company established a Voluntary Employees' Beneficiary Association (the VEBA or Trust) to fund medical, dental, prescription drug and vision claims for eligible retirees. Medical, dental, prescription drug and vision claims for active employees and their dependents are paid by the Plan outside of the trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Eligibility –

Employees – Full-time employees of the Company and their qualified dependents are eligible to participate in the Plan upon completion of 90 days of regular employment in a covered position. Coverage begins on the first day following the date eligibility requirements are met and application forms are complete. Directors currently serving on the Board of Directors, and the Company's in house attorney are also eligible to participate in the Plan upon meeting the waiting requirement above.

Retirees – Former covered employees of the Company and their qualified dependents are eligible to participate in the Plan provided that the retiree's age and years of service with the Company total 85 years. Coverage remains in effect for the life of the retiree and their eligible dependents, until the retiree's death or surviving spouse's remarriage. Effective August 1, 2012, new retirees and their dependents are no longer eligible for coverage under the medical and prescription drug portion of the Plan. Retirees and their dependents continue to be eligible for the vision and dental plan portion of the Plan.

Contributions – The Plan allows for but does not currently require participant contributions. The Company contributes to the Trust the cash necessary to secure the benefits provided.

Benefits – The Plan provides health benefits including medical, hospital, surgical, major medical, pharmaceutical, dental and vision, to eligible employees who work full time 30 or more hours per week, directors currently serving on the Board of Directors, the Company's in house attorney and certain retirees and their dependents.

Self-insured benefits – Medical, dental, prescription drug and vision benefits are self-insured. The claims for self-insured benefits are processed by the Plan's third-party claims processor under an administrative services only (ASO) arrangement. The claims processor pays claims directly to or on behalf of participants and are then reimbursed by the Plan's VEBA trust or the general assets of the Company. The ultimate responsibility for the payments to participants and providers, rests with the Plan Sponsor.

Syntrio Solutions, LLC Health Benefits Plan Notes to Financial Statements

The Plan maintained individual insurance policies for stop loss and supplemental Medicare for medical benefits for the year ended May 31, 2025. The stop loss policy reimburses the Plan Sponsor for individual claims exceeding \$80,000 for the year ended May 31, 2025. Stop loss reimbursements totaling approximately \$971,000 for the year ended May 31, 2025, have been netted with claims paid in the accompanying statement of changes in net assets.

Tax status – The Trust established under the Plan to hold the Plan’s assets is a nonexempt VEBA trust that is designed to be tax-exempt under the provisions of Section 501(c)9 of the Internal Revenue Code (IRC). However, as a result of the Plan’s funding policy, from time to time the trust may be subject to income taxes. No federal income taxes have been recorded in 2025 for unrelated business taxable income.

In addition, the Plan and trust are required to operate in conformity with the IRC to maintain the tax-exempt status of the trust. The Plan administrator believes the Plan is in compliance with the applicable requirements of the IRC and, therefore, believes the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, Plan management has evaluated the Plan’s tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Plan termination – Although it has not expressed any intention to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to participants, to discontinue its contributions at any time, and to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Company or be used for purposes other than for the exclusive benefit of the Plan’s participants.

Note 2 – Summary of Significant Accounting Policies

Basis of accounting – The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

Use of estimates – The preparation of financial statements in conformity with GAAP requires the use of estimates and assumptions that may affect certain amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment valuation – Investments are stated at fair value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. The net appreciation in fair value of investments consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Notes to Financial Statements

Claims incurred but not reported (IBNR) obligations – Plan obligations at May 31, 2025 and 2024, for claims incurred but not reported, are estimated in accordance with accepted actuarial principles based on the claims data provided by the Plan’s third-party claims administrators and an analysis of the Plan’s lag time between the date of incurrence and the date the claim is paid. These amounts are paid by the Plan only if claims are submitted and approved for payment. Claims incurred but not reported are not reflected in the accompanying statements of net assets available for benefits or the statement of changes in net assets available for benefits but are included in the statement of benefit obligations and the statement of changes in benefit obligations.

Postretirement benefits – The amount reported as the postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employees’ service rendered to the date of the financial statements. Postretirement benefits include future premiums expected to be paid for, or reimbursements expected to be paid to, currently retired employees and their dependents, and active employees and their dependents, after retirement from service with the Company. The postretirement benefit obligation represents the amount that is to be funded by contributions from the Company and from existing plan assets.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results in applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The significant assumptions and methods used in the valuation as of May 31, 2025 and 2024, are as follows:

Mortality: 2025 and 2024 – Pri-2012 base tables projected forward to year end using generational Scale MP-2021 projection

Discount rate: 2025 – 5.50%
2024 – 4.75%

Retirement age: 2025 and 2024 – 100% of directors are assumed to retire at age 80. Percentage of non-director active population assumed to retire:

The foregoing assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligations.

The health care cost trend rate assumptions have a significant effect on the amounts reported in the accompanying financial statements. If the assumed rates increase by one percentage point in each year, the postretirement benefit obligation as of May 31, 2025 and 2024, would increase by approximately \$2,635,000 and \$2,117,000, respectively.

The change in actuarial assumptions reported in the statement of changes in plan benefit obligations is due to the increase in the discount rate from 4.75% to 5.50%.

Cash – Deposits maintained in the cash account are restricted for payment of plan expenses, claims, and premiums.

Payment of benefits – Premiums paid by either the Company or the VEBA trust are recorded as premium payments in the accompanying statement of changes in net assets available for benefits.

Claims payments are recorded when reimbursed to the third-party claims processor by the Company. These payments are recorded as claims paid in the accompanying statement of changes in net assets available for benefits.

Administrative expenses – Administrative expenses, as presented in the financial statements, are paid from the net assets of the Plan's trust accounts.

Rebates and credits receivable – Rebates and refunds contractually due from service providers are recorded as Plan assets when collection is probable, and amount is estimable. These amounts are recorded as an offset to benefit payments, as applicable.

Medicare subsidy – The Plan's postretirement benefit obligation does not reflect an amount associated with the Medicare subsidy allowed under the Medicare Prescription Drug Improvement and Modernization Act of 2003 because the Plan is not directly entitled to the Medicare subsidy.

Subsequent events – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued.

The Plan has evaluated subsequent events through March 4, 2026, which is the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at May 31, 2025 and 2024.

Exchange traded funds – Shares of exchange traded funds are valued using quoted prices from the active exchange in which they are traded.

The valuation methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. It is reasonably possible, given the level of risk associated with investment securities, that changes in the values of the investments in the near term could materially affect a participant's account balance and the amounts reported in the statements of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.

Note 5 – Party-in-Interest Transactions

The Plan administrator is an employee of the Plan Sponsor. There are no transactions between these parties other than contributions to the Plan and normal benefit payments. As described in Note 1, the Plan has several arrangements with service providers. These transactions are party in interest transactions under ERISA.

Certain other miscellaneous expenses, were paid from net assets of the Plan to various parties in interest. These miscellaneous expenses were immaterial during the year ended May 31, 2025.


