Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Associated Grocers, Inc. 401(K) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statements of changes in net assets available for benefits for the years ended May 31, 2025 and 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of May 31, 2025 and 2024 and for the years ended May 31, 2025 and 2024, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

NOTES TO FINANCIAL STATEMENTS

MAY 31, 2025 AND 2024

Note 1 - Description of Plan -

The following brief description of the Associated Grocers, Inc. 401(K) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

Description of Plan

Associated Grocers, Inc. and Subsidiaries (the Company) has a defined contribution profit sharing plan covering all non-bargaining unit employees who are 21 years old and have been employed for at least 90 days prior to the entry dates of June 1 and December 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The 401(K) Committee and management oversee the governance of the Plan, determine the appropriateness of the Plan's investment offerings, and monitor investment performance.

Contributions

Participants can elect to defer up to 90 percent of their compensation, which is contributed to the Plan on a pre-tax basis on the participants' behalf subject to statutory limits. The Plan also allows participants to make after-tax Roth 401(k) contributions. Roth 401(k) contributions are designated irrevocably by the participant at the time of the election, treated as includible in the participant's income at the time the compensation would have been received, and are maintained by the Plan in a separate sub-account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan implemented an automatic deferral provision absent the employee's instruction, which applies to employees who became eligible after June 1, 2008. An amount equal to 5 percent of compensation is withheld from each payroll period.

Employer matching contributions are discretionary and are determined annually by the Board of Directors of the Company. For the years ended May 31, 2025 and 2024, the Company matched 25 percent of the employees' contributions if employed as of the last day of the Plan year. For the years ended May 31, 2025 and 2024, employer matching contributions totaled \$430,336 and \$397,251, respectively. In addition to Employer matching contributions, the Company may also make a discretionary profit-sharing contribution. The profit-sharing contribution is allocated to each participant based upon the rate of Employer contributions for a Plan year. The rate of Employer contributions, which is determined by the participant's job classification, is either 1 or 2 times the base contribution rate. The base contribution rate is a percentage of eligible compensation, established each year by the Board of Directors of the Company, and is calculated in accordance with ERISA and federal income tax laws. For the years ended May 31, 2025 and 2024, employee profit sharing contributions totaled \$212,495 and \$298,772, respectively. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited or charged with the participant's contribution and allocations of (1) the Company's matching and profit-sharing contribution, if any, (2) Plan earnings (losses), and (3) administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions as defined. The benefit to which a participant is entitled is the benefit that can be provided from the vested participant's account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's matching and profit-sharing contribution portion of their accounts, plus actual earnings thereon, is based on years of service. The vesting schedule is as follows:

Payment of Benefits

Upon termination of service due to death, disability, retirement, or separation from service, a participant may elect to receive a lump sum amount, installment or partial payment in cash up to the value of the participant's vested balance in their account. The Plan also permits withdrawal of contributions under certain circumstances where financial hardship can be demonstrated and in-service distributions once a participant reaches the age of 59 1/2.

Forfeitures

Forfeited balances of nonvested accounts are used to reduce Plan expenses. There were \$23,091 and \$53,129 in forfeited non-vested accounts as of May 31, 2025 and 2024, respectively. During the plan years ended May 31, 2025 and 2024, Plan expenses were reduced by \$46,231 and \$14,125, respectively. Subsequent to the year ended May 31, 2025, the Plan utilized forfeitures totaling \$19,316 for Plan expenses.

Note 2 - Summary of Accounting Policies -

Basis of Accounting

The financial statements of the Plan are prepared in accordance with the accrual basis of accounting. At May 31, 2025 and 2024, all assets are participant directed.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measurement attribute for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 6 to these financial statements for discussion of fully benefit-responsive investment contracts.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates, and such differences may be material.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Management of the Plan Sponsor determines the Plan's valuation policies utilizing information provided by the Plan's custodian. See Note 5 to these financial statements for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis of accounting. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments sold during the year as well as appreciation and depreciation of the investments held at the end of the year. Benefits are recorded when paid.

Contributions

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which employee contributions are withheld from compensation.

Risks and Uncertainties

The Plan provides for various investment options in any combination of selected pooled separate accounts and a guaranteed interest account. Investment securities, in general, are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with investments, it is at least reasonably possible that changes in the values of these funds will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.

Expenses

Certain expenses of maintaining the Plan may be paid directly by the Company and excluded from these financial statements. Fees for certain transactions, such as withdrawals, are charged directly to the account of the participant reporting such a transaction and included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Reclassifications

Certain items in the prior year financial statements may have been reclassified for comparative purposes to conform with the presentation in the current year financial statements. The reclassifications had no effect on the net assets as previously reported.

Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through March 2, 2026, the date which the financial statements were available to be issued.

Note 3 - Plan Termination -

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 4 - Tax Status -

The Plan is a qualified cash or deferred arrangement established under Section 401(k) of the Internal Revenue Code (IRC) and is exempt from income taxes under Section 401(a) of the IRC. The Plan has executed an adoption agreement using the Standard Retirement Services, Inc. Volume Submitter Profit Sharing Plan with CODA and relies on the determination letter dated June 30, 2020, issued for the standard plan. The Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of May 31, 2025, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. With few exceptions, the Plan is no longer subject to income tax examinations for years prior to 2022.

Note 5 - Fair Value Measurements -

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels. Level 1 inputs to the valuation methodology are based on unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access. Level 2 inputs are based primarily on quoted prices for similar assets in active or inactive markets and/or based on inputs that are derived principally from or corroborated by observable market data by correlation or other means. Level 3 inputs are unobservable and are based on assumptions market participants would utilize in pricing the asset determined using model-based techniques that include option pricing models, discounted cash flow models, and similar techniques.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at May 31, 2025 and 2024.

Pooled Separate Accounts: The value of each pooled separate account is determined using various inputs, such as the net asset value (NAV) of the shares of the underlying mutual fund held at year end adjusted for administrative expenses and other charges.

Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The pooled separate accounts were measured at net asset value per share (NAV) practical expedient of the fund and have not been classified in the fair value hierarchy.

Gains and losses included in changes in net assets available for benefits for the years ended May 31, 2025 and 2024, are reported in Net Appreciation in Fair Value of Investments.

- (g) The objective of these funds is for long-term capital appreciation. The fund normally invests at least 80% of the sum of its net assets and the amount of any borrowings for investment purposes in income-producing common stocks of publicly traded companies engaged in the real estate industry. The fund may invest up to 15% of its total assets in non-dollar denominated equity securities of non-U.S. issuers. Up to 15% of the fund's total assets may be invested in equity securities of emerging market issuers.

Note 6 - Investment Contract with Insurance Company -

The Plan entered into a fully benefit-responsive guaranteed investment contract with the Standard Insurance Company (Standard) totaling \$9,910,415 and \$11,217,148 as of May 31, 2025 and 2024, respectively. The Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer which was 3.03% as of May 31, 2025 and 2024. The crediting rate is reviewed on a monthly basis for resetting.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events included the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without consent of the issuer.

Note 8 - Party-in-Interest Transactions -

The Plan invests in a guaranteed interest fund and pooled separate accounts which are managed by the custodian, the Standard Insurance Company (Standard). Since the Standard is the Plan custodian, transactions in such investments qualify as party-in-interest transactions. The Plan paid administrative fees to Standard Insurance Company which totaled \$52,293 and \$11,140 for the years ended May 31, 2025 and 2024, respectively, and are included in the Statements of Changes in Net Assets Available for Benefits. All of these party-in-interest transactions are exempt from the prohibited transactions rules of ERISA.

Note 9 - Delinquent Participant Contributions -

During the year ended May 31, 2024, participant deferrals totaling \$283,670 were not timely remitted to the Plan in accordance with the requirements of the Department of Labor. The employer computed lost earnings on these deposits and made corrective contributions for lost earnings to the Plan during fiscal year 2025.
