Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Fireline Corporation Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 1, 2025 and December 31, 2024, and the related statements of changes in net assets available for benefits for the period January 1, 2025 to June 1, 2025 and for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Fireline Corporation Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

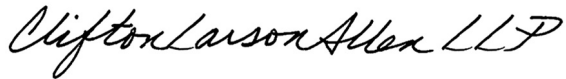

NOTE 1 DESCRIPTION OF PLAN

The following description of The Fireline Corporation Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Fireline Corporation (the Company). All employees of the Company who have completed 500 hours of service in a six-month period and are at least 21 years of age are eligible to participate in the Plan. Employees covered by a collective bargaining unit or who are nonresident aliens are exempt from participation in the Plan. Plan entry dates are quarterly. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Newly eligible participants will automatically be enrolled in the Plan at a deferral rate of 6%, unless they elect otherwise.

Effective June 1, 2025, the Plan merged into the Encore Holdings, LLC 401(k) Plan (Encore) and assets and liabilities of \$10,776,411 were transferred to Encore.

Contributions

Participants may elect to contribute an amount up to 100% of pre-tax annual compensation, as defined by the Plan, not-to-exceed limitations set by the IRS. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions up to annual limits set by the IRS. The Plan allows participants to make Roth contributions to the Plan, which are contributions of a percentage of after-tax compensation. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

Company matching, profit sharing, and qualified nonelective contributions may be made at the discretion of the Company. The Company made no discretionary matching contribution for the period January 1, 2025 to June 1, 2025. The Company made a discretionary matching contribution equal to 50% of participant elective deferrals if they are less than 1.958261% of eligible compensation and 0.00979131% of eligible compensation if participant elective deferrals exceed 1.958261% of eligible compensation for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company contributions, if any, (b) an allocation of the Plan's earnings or losses, and (c) administration expenses. Allocations are based on eligible compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled, is the benefit that can be provided from the participant's vested account. Accounts are participant directed.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of the vested portion of their fund account balance. Loans are treated as transfers from the investment funds to the participant loan funds. Loans must be repaid in five years, unless the proceeds are used to acquire a primary residence, in which case the maximum loan term is 30 years. The loans are collateralized by the balance in the participants' account and bear interest at the prime rate plus 1%. Loans are repaid through payroll deductions based upon an established amortization schedule. Loan fees are paid by the participant.

Vesting

Participants are immediately vested in their contributions and the Company qualified nonelective contribution plus actual earnings thereon. Vesting in the Company's matching and profit sharing contributions and earnings thereon is based on years of service, as defined, ranging from 0% for the first three years of service to 100% after three years. Participants also become fully vested in the Company's contributions upon death, total disability, or normal retirement of the participant.

Payment of Benefits

Participants or their beneficiaries are eligible for distribution upon the participant's termination, death, or retirement upon attainment of age 65. The Plan also allows for in-service withdrawals for participants who have reached the age of 59½. Participants may not withdraw Roth contributions during an in-service withdrawal. The Plan allows for hardship distributions. At all times, participants may withdraw in total or a portion of their rollover contributions. Distributions can be made in the form of lump-sum amounts equal to the vested value of the participant's account. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. Effective September 23, 2024, as a result of the SECURE 2.0 Act, if the balance of the terminated participant's account is between \$1,000 and \$7,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Forfeitures

Forfeitures can be used to offset Company contributions and plan expenses. No forfeitures were used for the period January 1, 2025 to June 1, 2025 and for the year ended December 31, 2024 to offset Company contributions. Forfeitures of \$3,623 and \$6,025 were used for the period January 1, 2025 to June 1, 2025 and for the year ended December 31, 2024 to offset Plan expenses, respectively. There were no Forfeited nonvested accounts at June 1, 2025 and December 31, 2024.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates in Preparing Financial Statements

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions

Contributions from participants and Company contributions are recorded in the year in which participant compensation is earned.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of benefit payments are charged directly to the participants' accounts and are included in administrative expenses. NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to participants' contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Subsequent Events

The Plan has evaluated subsequent events through February 26, 2026, the date the financial statements were available to be issued.

NOTE 3 CERTIFIED INVESTMENTS

Certain information related to investments as of June 1, 2025 and December 31, 2024, interest and dividends, and net appreciation in fair value of investments for the period January 1, 2025 to June 1, 2025 and for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company dba: Principal Trust Company, Principal Life Insurance Company, and Principal Life Insurance Company, on behalf of Principal Global Investors Trust Company, the qualified institutions as of June 1, 2025 and December 31, 2024 and for the period January 1, 2025 to June 1, 2025 and for the year ended December 31, 2024. Notes receivable from participants and related interest income are not covered by the certifications.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liabilities;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Collective Investment Trust Funds: Valued at the net asset value (NAV) of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective investment trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled Separate Accounts: Valued using the NAV of units. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their entire accounts. Assets were merged into the Encore Holdings, LLC 401(k) Plan effective June 1, 2025.

NOTE 6 RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares or units of a collective investment trust funds or pooled separate accounts managed by Principal Life Insurance Company, the recordkeeper and qualified institution of the Plan as of June 1, 2025 and December 31, 2024, and for the period January 1, 2025 to June 1, 2025 and for the year ended December 31, 2024. These investments qualify as party-in-interest investments/transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter from the IRS on the pre-approved plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

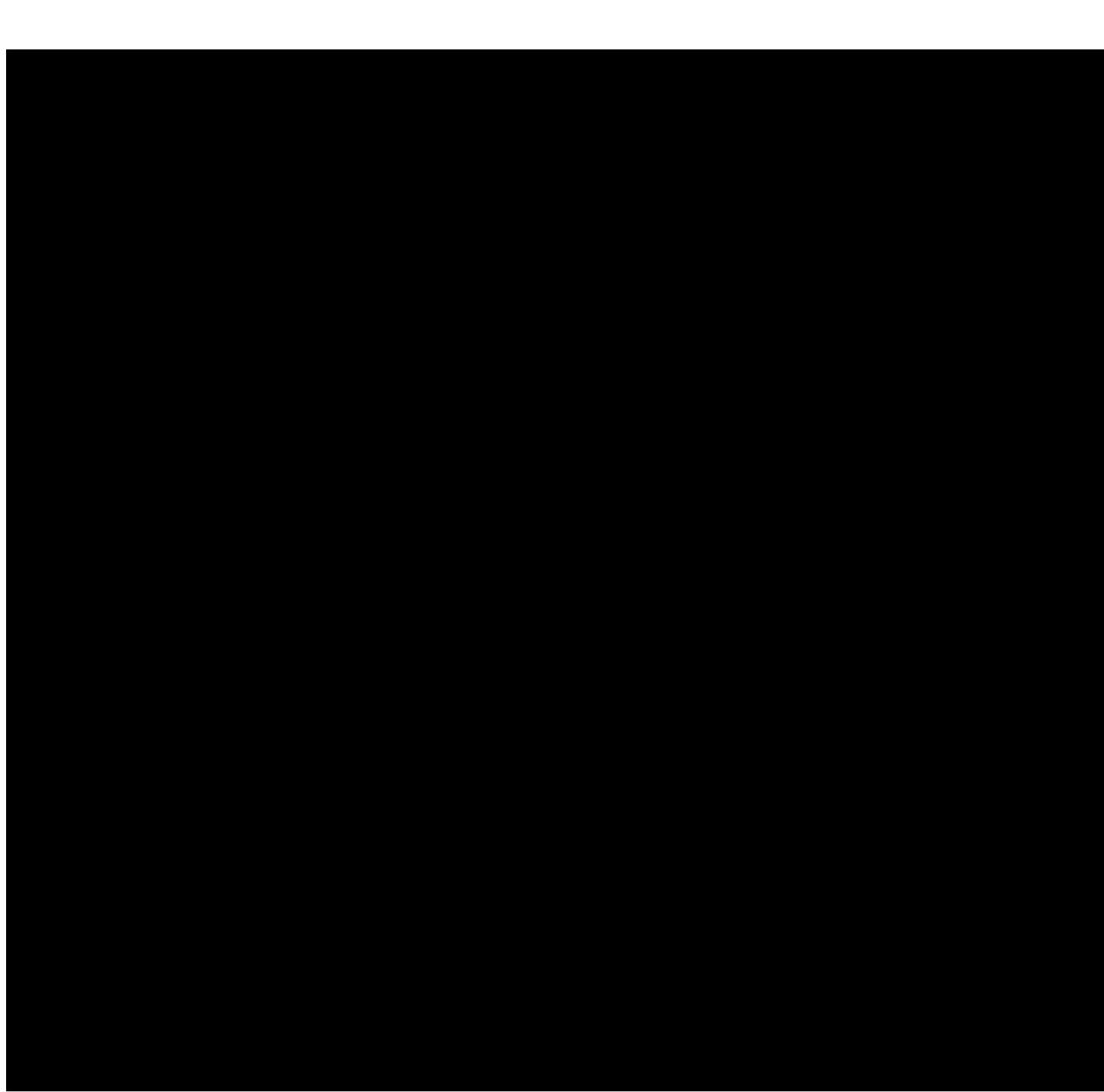

Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Fireline Corporation Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 1, 2025 and December 31, 2024, and the related statements of changes in net assets available for benefits for the period January 1, 2025 to June 1, 2025 and for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Fireline Corporation Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of The Fireline Corporation Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. 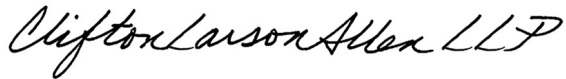

NOTE 1 DESCRIPTION OF PLAN

The following description of The Fireline Corporation Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by Fireline Corporation (the Company). All employees of the Company who have completed 500 hours of service in a six-month period and are at least 21 years of age are eligible to participate in the Plan. Employees covered by a collective bargaining unit or who are nonresident aliens are exempt from participation in the Plan. Plan entry dates are quarterly. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Newly eligible participants will automatically be enrolled in the Plan at a deferral rate of 6%, unless they elect otherwise.

Effective June 1, 2025, the Plan merged into the Encore Holdings, LLC 401(k) Plan (Encore) and assets and liabilities of \$10,776,411 were transferred to Encore.

Contributions

Participants may elect to contribute an amount up to 100% of pre-tax annual compensation, as defined by the Plan, not-to-exceed limitations set by the IRS. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions up to annual limits set by the IRS. The Plan allows participants to make Roth contributions to the Plan, which are contributions of a percentage of after-tax compensation. Participants may also contribute amounts representing distributions from other qualified defined contribution plans.

Company matching, profit sharing, and qualified nonelective contributions may be made at the discretion of the Company. The Company made no discretionary matching contribution for the period January 1, 2025 to June 1, 2025. The Company made a discretionary matching contribution equal to 50% of participant elective deferrals if they are less than 1.958261% of eligible compensation and 0.00979131% of eligible compensation if participant elective deferrals exceed 1.958261% of eligible compensation for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Company contributions, if any, (b) an allocation of the Plan's earnings or losses, and (c) administration expenses. Allocations are based on eligible compensation, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled, is the benefit that can be provided from the participant's vested account. Accounts are participant directed.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of the vested portion of their fund account balance. Loans are treated as transfers from the investment funds to the participant loan funds. Loans must be repaid in five years, unless the proceeds are used to acquire a primary residence, in which case the maximum loan term is 30 years. The loans are collateralized by the balance in the participants' account and bear interest at the prime rate plus 1%. Loans are repaid through payroll deductions based upon an established amortization schedule. Loan fees are paid by the participant.

Vesting

Participants are immediately vested in their contributions and the Company qualified nonelective contribution plus actual earnings thereon. Vesting in the Company's matching and profit sharing contributions and earnings thereon is based on years of service, as defined, ranging from 0% for the first three years of service to 100% after three years. Participants also become fully vested in the Company's contributions upon death, total disability, or normal retirement of the participant.

Payment of Benefits

Participants or their beneficiaries are eligible for distribution upon the participant's termination, death, or retirement upon attainment of age 65. The Plan also allows for in-service withdrawals for participants who have reached the age of 59½. Participants may not withdraw Roth contributions during an in-service withdrawal. The Plan allows for hardship distributions. At all times, participants may withdraw in total or a portion of their rollover contributions. Distributions can be made in the form of lump-sum amounts equal to the vested value of the participant's account. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. Effective September 23, 2024, as a result of the SECURE 2.0 Act, if the balance of the terminated participant's account is between \$1,000 and \$7,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

Forfeitures

Forfeitures can be used to offset Company contributions and plan expenses. No forfeitures were used for the period January 1, 2025 to June 1, 2025 and for the year ended December 31, 2024 to offset Company contributions. Forfeitures of \$3,623 and \$6,025 were used for the period January 1, 2025 to June 1, 2025 and for the year ended December 31, 2024 to offset Plan expenses, respectively. There were no Forfeited nonvested accounts at June 1, 2025 and December 31, 2024.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates in Preparing Financial Statements

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Contributions

Contributions from participants and Company contributions are recorded in the year in which participant compensation is earned.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of benefit payments are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to participants' contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Subsequent Events

The Plan has evaluated subsequent events through February 26, 2026, the date the financial statements were available to be issued.

NOTE 3 CERTIFIED INVESTMENTS

Certain information related to investments as of June 1, 2025 and December 31, 2024, interest and dividends, and net appreciation in fair value of investments for the period January 1, 2025 to June 1, 2025 and for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Delaware Charter Guarantee and Trust Company dba: Principal Trust Company, Principal Life Insurance Company, and Principal Life Insurance Company, on behalf of Principal Global Investors Trust Company, the qualified institutions as of June 1, 2025 and December 31, 2024 and for the period January 1, 2025 to June 1, 2025 and for the year ended December 31, 2024. Notes receivable from participants and related interest income are not covered by the certifications.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets.
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liabilities;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Collective Investment Trust Funds: Valued at the net asset value (NAV) of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective investment trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Pooled Separate Accounts: Valued using the NAV of units. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their entire accounts. Assets were merged into the Encore Holdings, LLC 401(k) Plan effective June 1, 2025.

NOTE 6 RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares or units of a collective investment trust funds or pooled separate accounts managed by Principal Life Insurance Company, the recordkeeper and qualified institution of the Plan as of June 1, 2025 and December 31, 2024, and for the period January 1, 2025 to June 1, 2025 and for the year ended December 31, 2024. These investments qualify as party-in-interest investments/transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter from the IRS on the pre-approved plan indicating that the Plan is designed in accordance with the applicable section of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 NONEXEMPT PROHIBITED TRANSACTIONS

The Company failed to remit loan repayments for two payroll period within the timeframe prescribed by the Department of Labor during the period January 1, 2025 to June 1, 2025. This is deemed a prohibited transaction in accordance with ERISA and the Internal Revenue Code. The Employer corrected the prohibited transaction by depositing the lost earnings, filing the required Form 5330 with the Internal Revenue Service and paying the appropriate excise tax in 2026.
