## Independent Auditor's Report

Board of Directors  
The Retirement Plan for the Employees of Buffalo Valley, Inc.

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Retirement Plan for the Employees of Buffalo Valley, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2025, and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (US GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with US GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with US GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Note 1. Description of Plan

The following description of The Retirement Plan for the Employees of Buffalo Valley, Inc. (the Plan) provides only general information. Participants should refer to the Plan document and the Summary Plan Description, copies of which are available from the plan administrator, for a more complete description of the Plan's provisions.

#### General

The Plan, as amended, was originally established on July 1, 1989. The Plan is an individual account profit sharing plan. An employee of Buffalo Valley, Inc. (the Employer) becomes a participant after reaching age 20 ½ or older and have completed one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Effective July 1, 2022, participants may defer a percentage of their pretax annual compensation as defined in the Plan agreement, not to exceed the maximum annual amount as determined by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan is a participant directed plan, whereby participants direct the investment of their contributions into various fund options offered by the Plan.

The Plan has a profit share that is discretionary by the Employer. For each Plan year in which a contribution is made, an allocation will be made to an eligible Participant's account in the ratio a Participant's compensation for the Plan year bears to the total compensation of all eligible Participants for the Plan year. This means that the amount allocated to each eligible Participant's account will, as a percentage of compensation, be the same.

Effective July 1, 2022, the Plan also has a safe harbor match which the Employer matches 100% of employee deferrals up to 3% of compensation, plus 50% of employee deferrals that exceed 3% up to 5% of compensation.

#### Participant Accounts

Each participant's account is credited with the participant's contribution, allocations of (a) the Company's contribution and (b) Plan earnings and is charged with an allocation of administrative expenses and Plan losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Vesting in the Employer's profit share contributions is based on years of continuous service as follows:

### Note 1. **Description of Plan**

#### **Forfeited Accounts**

Forfeitures are created when participants terminate employment prior to becoming fully vested in the Employer contribution portion of their accounts. Such forfeitures will be allocated to all participants based on a formula as described in the Plan document.

#### **Payment of Benefits**

Normal retirement age is the later of the date a participant reaches age 65 or the 5th anniversary of the date of becoming a participant. On termination of service due to death, disability, retirement, or termination before any of those events have occurred, a participant's vested interest will be distributed in a lump sum.

#### **Hardship Withdrawals**

Distributions may be made in the event of hardship, as defined by the Plan document. These distributions are taxable and may be subject to a tax penalty equal to 10% of the distribution amount.

#### **Participant Loans**

Participant loans are not permitted by the plan.

### Note 2. **Summary of Significant Accounting Policies**

#### **Basis of Presentation**

The accompanying financial statements are presented on the accrual basis of accounting in accordance with principles generally accepted in the United States of America (US GAAP).

#### **Use of Estimates**

The preparation of financial statements in accordance with US GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

Investments in the Plan are reported at fair value, except for fully benefit-responsive investments, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. See note 4 for discussion of fair value of investments. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive and investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. Net change in fair value of investments includes the Plan's realized and unrealized gains and losses on investments bought and sold, as well as held during the year.

#### **Payment of Benefits**

Benefits are recorded when paid.

### Note 3. **Certification**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following information included in the accompanying financial statements, notes, and supplemental schedules was obtained by management and agreed to or derived from information certified as complete and accurate by Transamerica Financial Life Insurance Company Inc. (Transamerica), the custodian of the Plan. The Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to this information.

- Participant-directed investments at fair value
- Participant-directed investments at contract value
- Participant-directed change in fair value of investments

### Note 4. **Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and that the Plan has the ability to access.

Level 2 inputs are based on observable inputs corroborated by market data but not quoted on active markets.

Level 3 inputs are based on unobservable inputs and include situations where there is little, if any, market activity for the assets or liabilities and have the lowest priority.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

*Interest-Bearing Cash and Cash Equivalents:* Money Market accounts are reported at carrying value, which, due to their liquidity, represents fair value.

*Pooled Separate Accounts:* Funds that include units of an insurance company's pooled accounts valued at the net asset value (NAV) of units of the accounts. The NAV, as provided by the custodians, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Pursuant to Financial Accounting Standards Board Accounting Standards Update 2015-07, *Fair Value Measurement*, the pooled separate accounts measured at NAV have not been classified in the fair value hierarchy.

### Note 4. Fair Value Measurements

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Trustee defers to Morgan Stanley for determining the Plan's valuation policies.

#### Note 6. Investment Contract with Insurance Company

The Stable Value Trust Fund is a fully benefit-responsive contract. The funds are maintained in an insurance company's general account. The fund is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan.

Because the contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contracts. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

#### Note 7. Tax Status

The Plan adopted a non-standardized pre-approved profit sharing plan sponsored by Access Retirement Services, LLC. The non-standardized pre-approved profit sharing plan practitioner has received an opinion letter from the Internal Revenue Service (IRS) as to the non-standardized pre-approved profit sharing plan's qualified status. The non-standardized pre-approved profit sharing plan's opinion letter has been relied upon by this Plan. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of June 30, 2025, no uncertain positions have been taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

#### **Note 7. Tax Status**

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is no longer subject to IRS examinations for the years prior to 2022.

#### **Note 8. Parties-in-interest Transactions**

Certain Plan investments are managed Transamerica. Transamerica are custodians of the Plan and, therefore, these transactions qualify as party-in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

#### **Note 9. Plan Termination**

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions and related earnings thereon.

#### **Note 10. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits

#### **Note 11. Subsequent Events**

Management has evaluated subsequent events through February 19, 2026, the date on which the financial statements were available for issuance.
