RE: Reasonable Cause - Request for Dismissing Penalties

Dear Sir or Madam:

I am writing to ask if you could dismiss the penalties for filing my 5500-SF forms late. I sold my business on March 28, 2023.

I relied on Paychex Retirement Services to handle all my compliance matters regarding my 401 K employee plan. I am not knowledgeable of what forms needed to be filed, that is why I relied on their professional services.

I received a letter from the IRS, that was the first time I heard of the 5500-SF forms that were delinquent. Due to Paychex oversight the forms were not filed.

I phoned Paychex on December 24, 2025, to find out what happened. They told me that I was responsible for filing them myself. I was never, ever told that before. Being a professional small business owner, I would have submitted the documents myself if I would have known. They forwarded completed forms from their files on December 24, 2025, and they were all filled out. It didn't make any sense to me why they didn't file them or inform me I needed to file them.

I immediately began working on submitting the 5500-SF and am taking steps to ensure future compliance.

Based on the reasonable cause described above and my good faith efforts to comply once I was aware of the requirements, I respectfully request that you please waive late filing penalties. As a new first-time small plan business owner, the circumstances were beyond my control.
