INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries of the Learning Ally 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Learning Ally 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.



- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

Supplemental Schedule Required by ERISA

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including the form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A - DESCRIPTION OF THE PLAN

The following description of the Learning Ally 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

[1] General:

The Plan is a defined contribution plan covering all employees, as defined by the Plan, of Learning Ally, Inc. (the "Organization"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The trustee of the Plan was Reliance Trust Company (from July 1, 2024 to December 31, 2024). Effective January 1, 2025 ADP Retirement Trust Services, LLC is the trustee of the Plan and Automatic Data Processing Inc., Retirement Services ("ADP") is the recordkeeper.

[2] Eligibility:

The Plan covers all employees of the Organization who are not members of a collective bargaining unit in which retirement benefits are the subject of good faith bargaining and nonresident aliens. Effective November 1, 2023, temporary employees are excluded as eligible. Any eligible employee who has completed two months of service can participate in the Plan. To be eligible to receive the Organization's contributions to the Plan (as described below), the employee must have completed one year of service with the Organization. An eligible employee will begin to receive employer contributions on the first day of the month coinciding with or next following the date the participant satisfies the Plan's eligibility requirement.

[3] Contributions:

Participants may contribute up to the maximum percentage of eligible pre-tax annual compensation allowable under the Internal Revenue Code ("IRC"). The Organization may make discretionary matching contributions equal to one of the following:

1. A percentage of the participant's elective deferrals.
2. A percentage of the participant's eligible compensation.

Discretionary profit-sharing contributions may be contributed at the option of the Organization's Board of Directors. Participants must be employed on the last day of the Plan year and have completed at least 1,000 hours of service during 12 consecutive months of service to be eligible to receive employer contributions. Certain eligible participants (age 50 and over) are permitted to contribute an additional amount as catch-up contributions.

A discretionary employer matching contribution of 1% of eligible participant's compensation, as defined by the Plan, was contributed for the Plan year ended June 30, 2025 in the net amount of \$81,974. For the Plan year ended June 30, 2024, the discretionary employer matching contribution was 2% of eligible participant's compensation, as defined by the Plan, in the net amount of \$188,885. These amounts are reflected as an employer contribution receivable on the statements of net assets available for benefits. There was no discretionary profit-sharing contribution for the Plan years ended June 30, 2025 or 2024.

Participants direct the investment of participant and employer contributions.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation. Effective January 1, 2021, the Plan also has an escalation feature whereby the deferral rate will increase each year by 1% up to a maximum of 6%.

NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

[4] Participant accounts:

Each participant's account is credited with the participant's contributions and allocations of (a) the Organization's contributions, (b) Plan earnings (losses), and may be charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

[5] Vesting:

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Organization's discretionary matching and discretionary profit-sharing contribution portion of their accounts, plus actual earnings thereon, is as follows:

<u>Years of Service</u>	<u>Vesting</u>
0 - 1 year	0%
1 year	33%
2 years	66%
3 years	100%

A participant will be 100% vested in the Organization's contributions if he or she attains normal retirement age of 65, incurs a total and permanent disability, or dies while employed by the Organization.

[6] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Interest rates on outstanding loan balances as of June 30, 2025 ranged from 4.25% to 8.75% and as of June 30, 2024 ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. Related fees are recorded as administrative expenses and are expensed when they are incurred.

[7] Payment of benefits:

Under the Plan, normal retirement age is 65. On termination of service due to death, disability, or retirement, a participant shall be considered 100% vested and may receive a lump-sum amount equal to the value of the participant's vested account balance. If the balance of the vested benefit exceeds \$5,000, the participant or beneficiary must consent to the distribution before it is made. If the balance of the vested benefit does not exceed \$5,000, the lump-sum distribution will be made as soon as practicable following the event. Prior to age 65, in-service withdrawals from the Plan are allowed for unusual hardship or upon attaining the age of 59½. In the event a participant's employment is terminated, the participant's accumulated vested benefits will be distributed to the participant in accordance with the terms of the Plan.

[8] Forfeitures:

Forfeited/other nonvested accounts may be used to reduce future Organization contributions, restore participant accounts, and pay Plan expenses. During the year ended June 30, 2025, approximately \$1,000 of forfeitures were utilized for employer contributions and approximately \$3,000 for restoring participant accounts. Forfeited/other nonvested accounts available at June 30, 2025 and 2024 were \$6,659 and \$1,066, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

[1] Basis of accounting:

The financial statements are prepared on the accrual method of accounting.

[2] Subsequent events:

The Plan has evaluated subsequent events through February 26, 2026, the date the financial statements were available to be issued.

[3] Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

[4] Payment of benefits:

Benefits are recorded when paid.

[5] Plan expenses:

Some expenses incurred in connection with the administration of the Plan are paid by the Plan, unless otherwise paid by the Organization. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Expenses that are paid by the Organization are excluded from these financial statements.

[6] Use of estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Reliance Trust Company, has certified to the completeness and accuracy of all investments, related investment activity and notes receivable from participants, and related activity in the accompanying statements of net assets available for benefits as of June 30, 2024, and the statement of changes in net assets available for benefits for the period July 1, 2024 through December 31, 2024. Also, as permitted under such election, ADP Retirement Trust Services, LLC, the trustee of the Plan, has certified to the completeness and accuracy of all investments, related investment activity and notes receivable from participants, and related activity in the accompanying statements of net assets available for benefits as of June 30, 2025, the statement of changes in net assets available for benefits for the period January 1, 2025 through June 30, 2025, and the accompanying supplemental schedule of assets (held at end of year) as of June 30, 2025.

NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation techniques are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation techniques include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation techniques are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for investment assets measured at fair value. There have been no changes in the techniques used as of June 30, 2025 and 2024.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded. There are several mutual funds that have restrictions as to when funds may be transferred in/out of the respective funds.

NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

Collective trust – A collective trust is comprised of a diversified portfolio of fixed income instruments which may include guaranteed investment contracts, synthetic guaranteed contracts, separate account contracts, and cash and cash equivalents and other commingled investment vehicles. It is valued at the NAV of units of the collective trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV, as provided, is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the trust will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. The trust's strategy is to seek current income while preserving the invested principal through the diversified portfolio. If the Plan were to initiate a full redemption of the collective trust, the issuer may require up to a 12-month notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

The preceding techniques described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation techniques are appropriate and consistent with other market participants, the use of different techniques or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(A) Certain investments that are measured at fair value using the NAV per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

Changes in Fair Value Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

NOTE E - TAX STATUS

The Plan has adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA (Cash or Deferred Arrangement), sponsored by ADP, LLC. On October 6, 2020, the IRS stated in an opinion letter that the prototype document adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC and, therefore, the related trust is exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified and the related trust is tax-exempt.

NOTE E - TAX STATUS (CONTINUED)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of June 30, 2025 and 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions. The Plan received an IRS examination notice dated June 9, 2025, indicating that the Plan for the year ended June 30, 2023, has been selected for review. Management is cooperating with the IRS, and the outcome of the examination is still in process.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain investments are managed by Reliance Trust Company and ADP Retirement Trust Services, LLC; and the recordkeeping is performed by ADP. Therefore, those transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan for recordkeeping, administrative and advisory services (Equity Services, Inc) were approximately \$59,000 and \$33,000, respectively.

Additionally, the Plan issues notes receivable from participants, which are secured by the participant's account balances. These transactions qualify as party-in-interest transactions.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments at June 30, 2025 may not necessarily be indicative of amounts that could be realized in a current market exchange.

NOTE H - MUTUAL FUND FEES

Certain investments in mutual funds are subject to sales charges in the form of front-end loads, back-end loads, or 12b-1 fees. 12b-1 fees are ongoing fees allowable under Section 12b-1 of the Investment Company Act of 1940. These annual fees are used to pay for marketing and distribution costs of the funds. These fees are deducted prior to the allocation of the Plan's investment earnings activity, and thus not separately identifiable as an expense.

NOTE I - PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
