Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of ENV Services, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements are comprised of the statements of net assets available for benefits as of May 31, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended May 31, 2025, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of ENV Services, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with U.S. generally accepted accounting principles.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with U.S. generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ENV Services, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE A: DESCRIPTION OF PLAN

The following description of the ENV Services, Inc. 401(k) Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 401(k) retirement plan covering all full-time employees of ENV Services, Inc. ("Company") who have completed three months of service and are age eighteen or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Plan management is responsible for oversight of the Plan. The Plan trustee determines the appropriateness of the Plan's investment offerings and monitors investment performance and discusses with the Plan sponsor any suggested changes.

Contributions

Each year, eligible participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan subject to the Federal dollar limitation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into the investment options offered by the Plan. The Plan currently offers mutual funds and a common trust fund. The Company contributes a matching contribution to each eligible participant's account in an amount equal to 50 percent of the participant's elective deferrals up to a maximum of 6 percent of compensation. Additional match or profit sharing amounts may be contributed at the option of the Company's owners. The Company did not make an additional match or discretionary profit sharing contribution in the current year. Contributions are subject to certain Internal Revenue Service limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's discretionary contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous service. Participants are vested 20% after two years of credited service and 20% per year thereafter, becoming 100% vested in the Company discretionary profit sharing after six years of credited service. Participants are vested 25% in the Company match after one year of credited service, becoming 100% vested in the Company match after three years of credited service.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Participants become 100% vested upon death, disability, or upon reaching normal retirement age of 65.

For termination of service due to other reasons, a participant will receive the value of the vested interest in his or her account as a lump sum distribution.

Due to timing differences there may be benefit payments payable for employees who terminated their employment and requested their distributions prior to the end of the Plan year but have not yet been paid. At May 31, 2025 and 2024 there were no amounts payable for these benefits.

NOTE A: DESCRIPTION OF PLAN (Continued)

The Plan was amended to reflect hardship withdrawal provisions which were included in the Bipartisan Budget Act of 2018.

Forfeited Accounts

Forfeited non-vested accounts may be used to pay administrative fees. At May 31, 2025 and 2024, forfeited non-vested accounts totaled \$12,779 and \$4,021, respectively.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. A participant may have only one loan outstanding at any one time. Loan terms range from one to five years. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% - 9.50% which are calculated at prime plus 1% as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the Plan trustee. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments is recorded net of fund expenses and includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of May 31, 2025 or 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions payable for the Plan year ending May 31, 2025 or 2024.

Benefit payments

Benefits are recorded when paid.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative fees. Investment related expenses are included in net appreciation of fair value of investments.

Cash and Cash Equivalents

The Plan considers all short-term securities purchased with a maturity of three months or less to be cash equivalents.

Subsequent Events

The Plan has evaluated subsequent events through February 27, 2026, the date the financial statements were available to be issued.

NOTE C: FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Common Trust Fund: The common trust fund is valued at fair value by the insurance company by using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end.

NOTE F: TRUSTEE CERTIFICATION

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for the Plan years ended May 31, 2025 and 2024. Accordingly, Bank of America, N.A., the trustee of the plan as of May 31, 2025, has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of May 31, 2025, and the supplemental Schedule H, Item 4(i) – Schedule of Assets (Held at End of Year) as of May 31, 2025, and the related investment activity reported in the statement of changes in net assets available for benefits for the year ended May 31, 2025. Charles Schwab Trust Bank, the trustee of the plan in fiscal year end 2024, has certified to the completeness and accuracy of the investments, with the exception of the participant notes receivable, reported in the accompanying statements of net assets available for benefits as of May 31, 2024 and earnings on the investments through the date of transfer during the fiscal year ended May 31, 2025.

NOTE G: RISKS AND UNCERTAINTIES

The Plan invests in investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE H: RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain plan investments are shares of mutual funds and a common trust fund managed by Charles Schwab Trust Bank and Bank of America, N.A. Charles Schwab Trust Bank was the trustee as defined by the Plan through November 2024 and Bank of America, N.A. is the trustee as defined by the Plan beginning in November 2024 and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation/depreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

If the revenue received by Bank of America, N.A. and Charles Schwab Trust Bank from such mutual fund service providers exceeds the amount owed under the agreement, the excess is remitted to the Plan on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses. During 2025 there were no excess amounts. The Plan may make a payment to Bank of America, N.A. and Charles Schwab Trust Bank for administrative expenses not covered by revenue sharing. In addition, as described in Note B, The Company pays certain expenses related to plan operations to other service providers. Such parties are also considered parties-in-interest under ERISA.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Plan audit fees are paid directly by the Company. The fee for the audit for the year ended May 31, 2025 was \$15,000.
