## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator, Participants and Beneficiaries  
of the BARC Developmental Services Money Purchase Pension Plan

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of BARC Developmental Services Money Purchase Pension Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of June 30, 2025 and 2024, and the related statement of changes in net assets available for benefits for the year ended June 30, 2025, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of June 30, 2025 and 2024, and for the year ended June 30, 2025, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit. ### ***Responsibilities of Management for the Financial Statements***

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

**NOTE A - DESCRIPTION OF THE PLAN**

The following description of the BARC Developmental Services Money Purchase Pension Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**[1] General:**

The Plan was established in 1970 by BARC Developmental Services (the "Company" or "employer") as a defined-contribution pension plan covering all nonexcluded employees who have attained the age of 18 and become eligible to participate following one year of service. The Plan was amended and restated as of July 1, 2018. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Plan entry dates are July 1 and January 1. Variable Annuity Life Insurance Company ("VALIC") is the recordkeeper of the Plan and the insurance company acting as custodian of the Plan's investments.

**[2] Contributions:**

On July 1, 2018, the Plan indefinitely suspended contributions in accordance with the Plan provisions. Rollover contributions were also suspended.

**[3] Participant accounts:**

Each participant's account is credited with an allocation of Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**[4] Vesting:**

Upon retirement, disability or death, a participant (or the beneficiary of the participant) is paid his or her entire account balance in the Plan. Upon distribution for any other reason, a participant receives only the vested portion of the account balance attributable to employer contributions and earnings thereon according to the participant's years of service as set forth in the following table:

**[5] Administration:**

The Company is the administrator of the Plan and is the Plan's sponsor. VALIC is the recordkeeper and insurance company of the Plan. VALIC allocates to each participant's account the proportionate share of the earnings on investments. VALIC is also the administrator of all policy loans.

### NOTE A - DESCRIPTION OF THE PLAN (CONTINUED)

#### [6] Policy loans:

In addition to participant notes receivable borrowing, a participant may borrow from VALIC, the insurance company, and use his or her Plan account balance invested in one of the fixed annuity contracts as collateral for the loan. The collateral must be 100% of the loan and payments on the loan are made outside of the Plan. As of June 30, 2025 and 2024, approximately \$84,400 and \$90,200, respectively, of Plan assets were pledged as collateral for such loans made by VALIC. A participant may borrow a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of the vested account balance. Loan terms range from one to five years; however, loans used for the purchase of a primary residence may extend up to a maximum term of 15 years. The borrowing limits noted below also apply to policy loans. Participants may have both types of loans. However, the total dollar amount cannot exceed the stated limits.

During the year ended June 30, 2025, \$2,848 of Plan assets were distributed from the Plan, included as distributions, representing payout of collateral for defaulted loans of this type, which consists of employer and rollover components of participants' accounts.

Principal and interest are paid quarterly directly by the participant. The interest rate charged is based on Moody's Corporate Bond Yield Average. While the loan is outstanding, the amount held as collateral earns interest at the contractual minimum of between 1.00% to 3.00% for the years ended June 30, 2025 and 2026. The difference, or "spread," between the rate established by Moody's Corporate Bond Yield Average and the contractual minimum is retained by VALIC.

#### [7] Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms range from one to five years; however, loans used for the purchase of a primary residence may extend up to a maximum term of 15 years. The loans are secured by the balance in the participant's account and bear interest at prime plus 1.00% as determined by the Plan administrator. The interest rates as of June 30, 2025 and 2024 on the outstanding loan balances ranged from 9.25% and 4.25% to 9.25%, respectively. Principal and interest are paid ratably through payroll deductions. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

#### [8] Payment of benefits:

A participant's vested benefits will normally be distributed to the participant or the participant's beneficiary upon the retirement, disability, death or termination of employment of the participant. Such distributions will be in one lump-sum cash payment upon termination or in the form of installment payments upon retirement, disability or death. In-service distributions of vested balances are permitted once a participant reaches 62 years of age.

#### [9] Forfeitures:

Forfeited nonvested accounts may be used to reduce future Company contributions and pay Plan expenses. During the year ended June 30, 2025, forfeitures of \$1,846 were used pay Plan expenses. Forfeited nonvested accounts available as of June 30, 2025 and 2024 were \$0 and \$0, respectively.

### NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### [1] Basis of accounting:

The accompanying financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

#### [2] Investment valuation and income recognition:

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net realized/unrealized appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### [3] Payment of benefits:

Benefits are recorded when paid.

#### [4] Plan expenses:

Certain administrative expenses are paid by the Plan unless paid by the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

#### [6] Use of estimates:

The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### NOTE C - INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, VALIC has certified to the completeness and accuracy of all investments and related investment activity and notes receivable from participants and related activity in the accompanying statements of net assets available for benefits as of June 30, 2025 and 2024, the statement of changes in net assets available for benefits for the year ended June 30, 2025, and the accompanying supplemental schedule of assets (held at end of year) as of June 30, 2025.

### NOTE D - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include: (1) quoted prices for similar assets or liabilities in active markets; (2) quoted prices for identical or similar assets or liabilities in inactive markets; (3) inputs other than quoted prices that are observable for the asset or liability; or (4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of June 30, 2025 or 2024.

*Fixed annuity contracts (VALIC General Accounts)* - The VALIC fixed funds, which include the Fixed Account Plus and Short-Term Fixed, are fixed annuity contracts that are fully and unconditionally guaranteed by VALIC. The fixed annuity contracts are valued using a discounted cash flow analysis. During the accumulation phase, they provide a guarantee of principal and a guaranteed minimum rate of interest. As of June 30, 2025 and 2024, this guaranteed minimum rate was 1%. Participants may withdraw up to 10% of the accumulated account value per contract year without charge. For any amount in excess of 10%, a surrender charge applies, generally 5% as specifically defined. The fixed annuity contracts can be redeemed daily. There is no redemption notice period.

*Fixed Account Plus and Short-Term Fixed* - The surrender value of the fixed interest options will never be less than the amount of the purchase payments allocated to the fixed interest options less any amounts transferred to the variable investment options or withdrawn.

*Fixed Account Plus* - Interest rates are declared monthly and apply separately to amounts accumulated in separate time periods. The average yield of the fund and the average yield credited to the participants as of June 30, 2025 and 2024 was 2.95% and 1.37%, respectively.

*Short-Term Fixed* - Interest is credited on a portfolio basis. On the portfolio basis, all amounts will be credited the same rate of interest for the current period regardless of the initial date of deposit. The average yield of the fund and the average yield credited to the participants as of both June 30, 2025 and 2024 was 1.00%.

#### NOTE D - FAIR VALUE MEASUREMENTS (CONTINUED)

*Variable Annuity Contracts* - Are separate accounts of VALIC and are variable annuities registered with the Securities and Exchange Commission ("SEC") as investment companies under the Investment Company Act of 1940. They operate as unit investment trusts that invest in shares of underlying mutual funds. Contributions buy accumulation units whose value is calculated daily. The accumulation units are valued at net asset value ("NAV") as a practical expedient to measure fair value. The value of a participant's investment rises and falls with the return on the underlying assets. The separate accounts invest primarily in equity, fixed income and money market mutual funds. There are no redemption notice periods or restrictions.

*Mutual Funds* - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### NOTE E - TAX STATUS

The Plan has adopted a Prototype Non-standardized Money Purchase Pension Plan sponsored by VALIC. On March 31, 2014, the Internal Revenue Service ("IRS") stated in an opinion letter that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("IRC") and, therefore, the related trust was exempt from taxation. The Plan has been amended since receiving the letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes that the Plan is qualified, and the related accounts are tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by a government authority. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of June 30, 2025 and 2024, there were no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan has all of its investments in units of Separate Accounts held by VALIC and in VALIC General Accounts, and transactions related to these investments qualify as party-in-interest transactions. Fees paid by the Plan were \$24,779 for the year ended June 30, 2025. These fees were paid for investment management services and professional fees.

### NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks, as well as risk related to the financial strength of the insurance company. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

Volatility in the financial markets may significantly impact the subsequent valuation of the Plan's investments. Accordingly, the valuation of investments as of June 30, 2025 may not necessarily be indicative of amounts that could be realized in a current market exchange.

**NOTE H - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company contributions.

**NOTE I - SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through February 12, 2026, which is the date the financial statements were available to be issued.
