## SUMMARY OF PLAN PROVISIONS

- Effective Date:** July 1, 1956.
- Eligibility:** Each employee becomes a participant on the first of the month coincident with or next following the attainment of age 21 and the completion of one year of service.
- Service:** One year of service is earned for vesting and benefit accrual purposes for each plan year in which an employee is credited with at least 1,000 hours.
- Compensation:** Wages and other amounts received from the employer for a calendar year, including amounts contributed pursuant to salary reduction agreements under Sections 401(k) and 125 of the Internal Revenue Code.
- Average Monthly Compensation:** Monthly average of Compensation for the five highest consecutive years in the last ten years.
- Normal Retirement:**
- Eligibility:** The later of the first day of the month coincident with or next following the participant's 65<sup>th</sup> birthday or the 5<sup>th</sup> anniversary of plan entry.
- Benefit:** Monthly benefit payable at normal retirement date is equal to 1.4% of average monthly compensation, plus 0.5% of average monthly compensation in excess of covered compensation, multiplied by years of benefit service (maximum of 30 years).
- Early Retirement:**
- Eligibility:** A participant may retire early if he has attained age 55 and has completed 5 years of service.
- Benefit:** Accrued benefit, reduced by 5/9<sup>th</sup> of 1% for each of the first 60 months and 5/18<sup>th</sup> of 1% for each of the next 60 months by which benefit start date precedes normal retirement date.
- For participants with 30 years of service, reductions from age 62 at 8/18<sup>th</sup> per month by which start date precedes normal retirement date.

**Vesting:** A participant who terminates employment after completing 5 or more years of service is 100% vested in his accrued benefit.

**Normal Form:** Life annuity.

**Pre-Retirement  
Death Benefit:** An active or terminated participant who vested in his or her accrued benefit is covered by a preretirement death benefit.

The surviving spouse will receive a monthly benefit based on the beneficiary's portion of a 50% joint survivor benefit, commencing the later of the first day of the month coincident with or next following the day the death occurred, or what would have been the participant's earliest retirement date.
