In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### **Auditors' Responsibilities for the Audit of the Financial Statements**

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **1. Description of Plan**

The following description of the Zeta Charter Schools 403(b) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

#### ***General and Eligibility***

The Plan is a defined contribution 403(b) plan established on July 1, 2018, for the benefit of all eligible employees of Zeta Charter Schools (the “Employer”). Eligible employees, who normally work more than 20 hours per week are eligible immediately to make elective deferrals. Eligible employees, who normally work more than 20 hours per week and have attained age 21 are eligible to start receiving the employer discretionary contribution on the first day of the Plan year and the first day of the fourth, seventh and tenth months of the Plan year. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### ***Contributions***

Eligible participants may defer voluntary contributions based on their eligible compensation on a per pay period basis, pre-tax or Roth basis, as defined in the Plan document, up to the statutorily permitted amount. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan includes an automatic enrollment feature whereby eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default rate set at 3% of their eligible compensation with automatic increase of 1% per year up to a maximum of 10%. The amount deducted will be deducted on a pre-tax basis.

In accordance with the Plan document, the Employer may make discretionary matching contributions on behalf of eligible Plan participants, in a manner that is determined annually by the Employer. During the 2025 plan year, discretionary matching contributions equal to one hundred percent of an individual’s first three percent of eligible compensation contributed to the Plan was made.

In accordance with the Plan document, the Employer may make a discretionary nonelective contribution on behalf of eligible Plan participants who are employed on the last day of the plan year. For the year ended June 30, 2025, no discretionary Employer nonelective contributions were made to the Plan.

#### ***Participant Accounts***

Each participant’s account is credited for participant contributions, discretionary matching contributions, discretionary nonelective contributions, investment earnings and charged for allocated administrative expenses. The contributions are allocated among the investment options according to the participant’s instructions. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### 1. Description of Plan (*continued*)

#### ***Vesting***

Participants are one hundred (100%) vested immediately in all elective contributions plus earnings thereon. Participants vest in Employer discretionary matching and nonelective contributions based on the following table:

#### ***Forfeitures***

At June 30, 2025 and 2024, forfeited non-vested accounts totaled \$191,533 and \$200,662. These accounts may be used to reduce future Employer contributions or Plan expenses. During 2025, \$42,526 was used to reduce Plan expenses and \$83,400 was used to reduce Employer contributions.

#### ***Notes Receivable from Participants***

The Plan offers a loan feature whereby a participant enrolled in the Plan may borrow a minimum of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). The loans are secured by the participant's vested account balance and bear interest at the prime rate plus 1%. A participant may only have one loan outstanding at any given time. Principal and interest are paid ratably through payroll deductions. The borrower also pays a loan origination and record-keeping fee. The loan must be repaid within a five year period, unless the loan is use for the purchase of a primary residence.

#### ***Payment of Benefits***

Upon termination of service due to death, disability, retirement or separation from service, a participant may elect to receive partial payments or a lump sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals from the Plan may also be granted based upon circumstances of financial hardship or after attaining age 59 1/2, in accordance with provisions specified in the Plan document.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### 2. Summary of Significant Accounting Policies *(continued)*

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. At June 30, 2025 and 2024, all of the Plan's investments were valued using level 1 inputs under the fair value hierarchy.

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. These funds are deemed actively traded.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded when a distributable event occurs.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Employer, as provided by the Plan's provisions. Expenses that are paid by the Employer are excluded from these financial statements. Investment related fees are included in the net appreciation in fair value of investments.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is March 5, 2026.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year), including investments and notes receivable from participants held at June 30, 2025 and 2024, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended June 30, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC as an authorized representative of Ascensus Trust Company, a qualified institution.

### 4. Party-in-Interest Transactions

Ascensus Trust Company is the custodian as defined by the Plan and, therefore, these transactions are exempt party-in-interest transactions under ERISA. Administrative fees paid by the Plan to the custodian amounted to \$51,346 for the year ended June 30, 2025.

Ascensus, LLC is the record-keeper for the Plan. All of the Plan's investments are managed by an affiliate of the record-keeper. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

### 5. Tax Status

The Internal Revenue Service ("IRS") has determined and informed the volume submitter plan document preparer by an opinion letter dated January 1, 2018, that the Plan document is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since the preparer received its opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 6. Plan Termination

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in all Employer contributions.

### **7. Non-exempt Party-in-Interest Transactions**

For the 2023 plan year, the Employer failed to transmit to the Plan contributions and loan repayments for participants totaling \$30,263 within the period prescribed by Department of Labor regulations. The Employer is in the process of making the necessary corrections.

### **8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
