Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Brown Health 403(b) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Brown Health 403(b) Retirement Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Disclaimer of Opinion on 2024 Financial Statements

We do not express an opinion on the accompanying financial statements of Brown Health 403(b) Retirement Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion on the 2024 Financial Statement section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

Basis for Disclaimer of Opinion on 2024 Financial Statements

Brown Health 403(b) Retirement Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the accompanying financial statements may have been affected by these conditions.

Further, as described in Note 2 to the financial statements, the Brown Health 403(b) Retirement Plan has excluded from investments in the accompanying statements of net assets available for benefits, certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, Annual Reporting Requirements for 403(b) Plans. The investment income and distributions related to such contracts and accounts also have been excluded in the accompanying statement of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these contracts and accounts and the related income and distributions be included in the accompanying financial statements.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Brown Health 403(b) Retirement Plan's ability to continue as a going concern for at least one year following the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the 2024 Financial Statements

Our responsibility is to conduct an audit of Brown Health 403(b) Retirement Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of Brown Health 403(b) Retirement Plan, and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audit.

Other Matters

Supplemental Schedule Required by ERISA

The supplemental schedule of Schedule H, line 4i – Schedule of Assets (Held at End of Year), as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion on the 2024 Financial Statement section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedule referred to above.

Auditors’ Report on the 2023 Financial Statements

The 2023 financial statements of the Plan were audited by Marcum LLP. In accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the DOL Rules and Regulations for Reporting and Disclosure under ERISA, the prior year audit did not extend to any statements or information related to assets held for investment of the plan that were certified by a qualified institution. Their report dated September 13, 2024, indicated that they did not express an opinion on the amounts and disclosures in the 2023 financial statements. Because of the significance of the matters described in the 2023 Basis for Disclaimer of Opinion of the report, they were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion, the report also did not express an opinion on the form and content of the 2023 supplemental schedule.

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Brown Health 403(b) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(A) GENERAL

The Plan, adopted January 1, 1996, is a defined contribution plan established under Section 403(b) of the Internal Revenue Code. All employees of Lifespan Corporation d/b/a Brown University Health and participating employers were eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Brown Health Corporation Retirement Plan Committee and Brown Health Corporation as Plan Administrator control and manage the operation and administration of the Plan.

Effective December 31, 2017, all future participation and contributions ceased for pay periods ending after December 23, 2017, for those employees whose terms and conditions of employment are not covered by a collective bargaining agreement. All previously eligible, as well as new employees whose terms and conditions of employment are not covered by a collective bargaining agreement, became eligible to participate prospectively in a newly formed defined contribution plan, the Brown Health 401(k) Retirement Savings Plan.

Effective January 1, 2019, United Nurses and Allied Professionals (UNAP) RIH employees who were hired, rehired, or transferred to a UNAP-covered position on or before September 30, 2018, and who made a one-time irrevocable election to discontinue participation in the Brown Health 403(b) Retirement Plan and commence participation in the Brown Health 401(k) Retirement Savings Plan, during the period which commenced November 15, 2018 and ended December 14, 2018 ("the 2018 Opt-Out Period"), became participants in the Brown Health 401(k) Retirement Savings Plan for purposes of elective contributions.

Effective October 1, 2019, UNAP RIH employees who were hired, rehired, or transferred to a UNAP-covered position on or after October 1, 2018, and on or before December 31, 2018, and who made a one-time irrevocable election to discontinue participation in the Brown Health Corporation 403(b) Retirement Plan and commence participation in the Brown Health 401(k) Retirement Savings Plan, during the period which commenced July 15, 2019 and ended August 11, 2019 ("the 2019 Opt-Out Period"), became participants in the Brown Health 401(k) Retirement Savings Plan for purposes of elective contributions.

From January 1, 2019, forward, newly hired, rehired, or transferred UNAP RIH employees are not eligible to participate in the Plan.

Effective January 1, 2020, International Brotherhood of Teamsters (IBT) RIH employees who were hired, rehired, or transferred to an IBT-covered position on or before August 31, 2019, and who made a one-time irrevocable election to discontinue participation in the Brown Health Corporation 403(b) Retirement Plan and commence participation in the Brown Health 401(k) Retirement Savings Plan, during the period which commenced October 15, 2019 and ended November 3, 2019 (“the 2019 Opt-Out Period for IBT employees”), became participants in the Brown Health 401(k) Retirement Savings Plan for purposes of elective contributions.

From September 1, 2019, forward, newly hired, rehired, or transferred IBT RIH employees are not eligible to participate in the Plan.

Effective October 15, 2024, the plan name has been amended from “Lifespan Corporation 403(b) Retirement Plan” to the “Brown Health 403(b) Retirement Plan”.

(B) EMPLOYEE CONTRIBUTIONS

Participants may contribute up to 100% of their wages, not to exceed the maximum annual contribution allowed by the Internal Revenue Service (IRS). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). See note 1(a) above for additional details.

(C) PARTICIPANT ACCOUNTS

Each participant’s account is credited with both the participant’s contributions and allocations of Plan earnings, which are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

(D) VESTING

Participants are immediately vested in all contributions plus earnings thereon.

(E) NOTES RECEIVABLE FROM PARTICIPANTS AND PLAN LOANS

(i) Notes Receivable from Participants

Under the terms of the Plan, participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Notes receivable from participants are secured by the balance in the participant’s account,

(E) NOTES RECEIVABLE FROM PARTICIPANTS AND PLAN LOANS (CONTINUED)

bear interest at the prime rate plus 2% and have terms ranging from one to five years. Principal and interest are repaid ratably through payroll deductions.

(ii) Plan Loans

Loans are also available to participants through Teachers Insurance and Annuity Association of America (TIAA), subject to certain limitations. Plan loans are issued directly from the funds owned by TIAA and loan proceeds are not removed from a participant's account balance. However, a portion of a participant's TIAA Traditional Annuity account balance is reserved, or held as collateral, to cover the outstanding loan amount for the period the loan is outstanding. See notes 1(h) and 4 for discussion of the TIAA Traditional Annuity. For active loans, investments equal to 110% of the outstanding loan amount are reflected in the statements of net assets available for benefits and serve as collateral for the loan. Investments underlying defaulted loan balances are reflected in the statements of net assets available for benefits until a distribution event occurs.

(F) PAYMENT OF BENEFITS

Upon termination of employment, participants may elect to receive their distributions equal to the value of their account in either a lump sum amount or in periodic installments. In addition, participants may elect to roll their account into another qualified plan.

(G) PLAN TERMINATION

Although it has not expressed any intention to do so, Brown Health has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

(H) TIAA TRADITIONAL ANNUITY

The TIAA Traditional Annuity is a guaranteed fixed annuity contract available as an investment option to Plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered to Plan participants through a variety of contract types, including Retirement Annuities (RA), Group Retirement Annuities (GRA), Retirement Choice (RC), Supplemental Retirement Annuities (SRA), and Group Supplemental Retirement Annuities (GSRA). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

(H) TIAA TRADITIONAL ANNUITY (CONTINUED)

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by TIAA's claims-paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate. For accumulating RA and GRA contracts, the crediting interest rate was 4.44% and 4.56% as of December 31, 2024 and 2023, respectively. For accumulating RC contracts, the crediting interest rates were 4.66% and 4.79% as of December 31, 2024 and 2023, respectively. For accumulating SRA and GSRA contracts, the crediting interest rates were 3.70% and 3.81% as of December 31, 2024 and 2023, respectively.

The RA contract does not allow lump sum cash withdrawals and transfers must be spread over ten annual installments. Under the GRA and RC contracts, lump sum withdrawals are available within 120 days of termination of employment and are subject to a 2.50% surrender charge. All withdrawals and transfers from RA and GRA contracts must be spread over ten annual installments (five annual installments for withdrawals after termination of employment). All withdrawals and transfers from RC contracts must be spread over eighty-four monthly installments. The SRA and GSRA contracts provide for full participant-directed liquidity. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a benefit paid directly to participants in the statements of changes in net assets available for benefits.

(I) NEW YORK LIFE GUARANTEED INTEREST ACCOUNT

The New York Life Guaranteed Interest Account (GIA) is a guaranteed fixed annuity contract available to Plan participants as an investment option. The GIA contract is fully and unconditionally guaranteed by New York Life Insurance Company.

When participants choose to allocate a portion of their retirement savings to the New York Life GIA during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by New York Life Insurance Company.

(D) NEW YORK LIFE GUARANTEED INTEREST ACCOUNT (CONTINUED)

When participants choose to allocate a portion of their retirement savings to the New York Life GIA during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, is guaranteed by New York Life Insurance Company. The crediting interest rates were 3.35% and 3.05% as of December 31, 2024, and 2023, respectively.

The GIA contract provides for full participant-directed liquidity. When a participant's accumulation in the New York Life GIA is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a benefit paid directly to participants in the statements of changes in net assets available for benefits.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(A) BASIS OF ACCOUNTING

The accompanying financial statements are prepared on the accrual basis of accounting.

The Plan, adopted January 1, 1996, was historically viewed as an amalgamation of individual annuity and custodial accounts, and the Plan Administrator and its service providers did not maintain financial information at a Plan level. Because historical records were not maintained or are not available at a Plan level, the Plan may have excluded from the accompanying statements of net assets available for benefits certain annuity and custodial accounts, and related activity, issued to current and former employees prior to January 1, 2009. In recognition of these recordkeeping matters, the Department of Labor released Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans* (FAB 2009-02), as transitional relief, to address situations where a Plan's management is not able to obtain historical records. If FAB 2009-02 is implemented, the DOL has indicated that they will not reject Form 5500 where contracts are excluded if certain conditions were met. Further, FAB 2009-02 suggests that plan administrators make good faith efforts to include known contracts. While the Plan Administrator has, in good faith, included all known contracts, because of certain incomplete records, there is uncertainty that all contracts have been included. However, the Plan Administrator believes that excluded annuities or custodial accounts, if any, would meet the conditions of FAB 2009-02. As discussed in Note 3, the Plan has received certified statements of completeness and accuracy from the Plan's custodians as of and for the years ended December 31, 2024 and 2023, respectively.

(A) BASIS OF ACCOUNTING (CONTINUED)

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for those contracts that are deemed to be fully benefit-responsive. Contract value is the relevant measurement attributed for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. Certain TIAA Traditional Annuity contract types, including SRA and GSRA, as well as the New York Life GIA, are considered fully benefit-responsive, and contract value approximates fair value for the years ended December 31, 2024 and 2023. See notes 1(h) and 1(i) for further discussion of the TIAA Traditional Annuity and the New York Life GIA, respectively.

(B) USE OF ESTIMATES

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingencies. Actual results could differ from those estimates.

(C) INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are reported at fair value, except for those deemed to be fully benefit-responsive, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

The Plan's investments in fully benefit-responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

(D) NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are carried at their outstanding balance plus unpaid accrued interest. As indicated in note 1(e), such loans bear interest at the prime rate plus 2% and have terms ranging from one to five years.

(E) PAYMENT OF BENEFITS

Benefit payments to participants are recorded upon distribution.

(F) ADMINISTRATIVE EXPENSES

Certain administrative expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by Brown Health. Expenses that are paid by Brown Health are excluded from these financial statements.

(G) OTHER INCOME

The Plan participates in the Fidelity Revenue Credit Program and the TIAA Revenue Credit Program. Through the Programs, the Plan has received credits which represent a return of Fidelity and TIAA fees, respectively.

NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S CUSTODIANS

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company (Fidelity) and Teachers Insurance and Annuity Association of America (TIAA), the Plan's custodians, have certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified as complete and accurate by the Plan's custodians for the respective periods.

NOTE 4 - INVESTMENTS

FAIR VALUE

Accounting Standards Codification 820, *Fair Value Measurements* (FASB ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Investment options available to participants include select mutual funds, Fidelity self-directed brokerage accounts, New York Life GIA, TIAA Traditional Annuity, TIAA Real Estate, and CREF Variable Annuities.

Mutual funds: Mutual funds invest principally in equity securities, fixed income instruments, and short-term instruments in accordance with each fund's investment objectives. Fidelity and TIAA mutual funds are registered mutual funds whose fair values are based on quoted prices and which are therefore classified in Level 1 of the fair value hierarchy at December 31, 2024 and 2023.

Self-directed brokerage accounts: Fidelity self-directed brokerage accounts allow participants to invest in a broad range of Fidelity and non-Fidelity mutual funds plus a range of individual securities.

Guaranteed Interest Account: The Plan offers the New York Life Guaranteed Interest Account (GIA), which is a benefit-responsive investment contract backed by New York Life Insurance Company's general account. The GIA provides a guarantee of principal and accumulated interest and credits interest at a rate set periodically under the contract. Participant transactions occur at contract value, which represents principal plus accrued interest. The GIA does not have a quoted market price and is therefore not classified in Level 1 of the fair value hierarchy.

Variable Annuities: TIAA offers eight CREF Variable Annuities. Unlike the TIAA Traditional Annuity, the variable accounts do not provide guaranteed returns. Participant returns depend entirely on the investment performance of each account. The accounts invest principally in equity securities, fixed income instruments, and short-term investments in accordance with each portfolio's investment objectives. The annuities reflect a structure similar to mutual funds and have a readily determinable fair value as reported by TIAA each day that current transactions are recorded.

In addition, TIAA offers the Real Estate Account which is a separate account of TIAA. This account is a variable account similar to the CREF Variable accounts; as such, its returns are not guaranteed, and its accumulations and returns fluctuate based on the performance of the underlying investments. The Real Estate Account generally invests in real estate properties and real estate-related investments, reflects a structure similar to mutual funds, and has a readily determinable fair value as reported by TIAA each day that current transactions are recorded.

Transfers out of the TIAA Real Estate Account to a TIAA or CREF account or into another investment option can be executed at any time but are limited to once per calendar quarter. Transfers out of TIAA Traditional Annuity contracts can only be executed over a period of time (up to ten years) and may be subject to other limitations. Transfers out of Fidelity or TIAA mutual funds into another investment option may be executed daily, with one-day notice.

Investments in TIAA Traditional Annuity contracts that are not benefit-responsive are reported at contract value, which approximates fair value. As these investments are contract-based, observable prices for identical or similar investments do not exist and, accordingly, these investments are valued using unobservable inputs (Level 3). Contract value is the aggregation of contributions, plus interest, less withdrawals, if any. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. Additionally, the discretionary rate applied to contributions received during a reporting period may vary from the discretionary rate applied to account balances at the end of the prior reporting period. Contract value approximates a discounted cash flow value calculated using an appropriate risk-adjusted market discount rate which correlates closely with TIAA

Traditional Annuity's historical credit rates. See also note 1(h) for discussion of the TIAA Traditional Annuity.

NOTE 5 - RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds or pooled separate accounts managed by Fidelity Investments and TIAA, respectively. Fidelity Management Trust Company (which is affiliated with Fidelity Investments) and TIAA are the custodians as defined by the Plan, and therefore, these investments and transactions in these investments qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE 6 - INCOME TAX STATUS

The Plan sponsor initially established the Plan effective January 1, 1996. The Plan has been amended over time. The Plan has been designed to qualify under Section 403(b) of the Code. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (IRS) in Revenue Procedure 2007-71. In recent guidance, the IRS stated that it does not intend to create a new determination letter program for 403(b) plans. This guidance, IRS Revenue Procedure 2013-22, established new procedures for IRS preapproval of the form of 403(b) plan documents. The sponsor restated the 403(b) plan on June 29, 2021 onto FIS Business Systems, LLC's (FIS) IRS-approved Volume Submitter document. The IRS provided an opinion letter for FIS's Volume Submitter document on March 31, 2017. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and, as such, is exempt from federal income taxes.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 8 - SUBSEQUENT EVENTS

The Plan Sponsor considers events and transactions that occur after the date of the statement of net assets available for benefits, but before the financial statements of the Plan are issued, to provide additional evidence relative to certain estimates or to identify matters that require additional disclosure. Subsequent events were evaluated through March 4, 2026, the date the financial statements were available to be issued.
