Dear Sir/Madam,

In response to the IRS Notice (CP-406, dated December 1, 2025) dealing with Thermalin Inc.'s failure to file a Form 5500 for the year ended December 31, 2023, I am providing you with the following reasons for the non-filing.

1. Thermalin Inc. ceased operations and was dissolved during midyear 2023. Accordingly, all employees/consultants were terminated during the period, and all funds were exhausted at the time Thermalin ceased operations.
2. I can confirm that all participants who had a balance in Thermalin's 401k Plan as of the prior year end (December 31, 2022) were paid out and there were no remaining participant funds in the 401k Plan when the Thermalin was dissolved.

As the Company is completely closed with no one remaining at Thermalin Inc., please accept our reasons for non-filing the Form 5500, otherwise provide us with further guidance.
