- the amounts and disclosures in the 2024 financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the 2024 financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the 2024 Financial Statements

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the 2024 Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the 2024 Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the 2024 Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

1. Description of Plan

African American Planning Commission Inc. (the "Employer") adopted the African American Planning Commission Inc. 403(b) Plan (the "Plan") as of August 1, 2007. The following description of the Plan provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General and Eligibility

The Plan is a defined contribution plan that covers substantially all eligible employees of the Employer. Participants are eligible for Employer contributions following the attainment of age 21 and three months of service. For participant contributions, eligibility commences immediately upon employment. Excluded employees include students and employees who normally work less than 20 hours per week. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Participants may elect to have pre-tax or Roth contributions made to the Plan from their annual compensation subject to statutory regulations under the Internal Revenue Code ("IRC"). The Employer may make a discretionary non-elective contribution based on an eligible participant's classification. The Plan accepts rollovers and transfers from other qualified plans.

Vesting

Participants are fully vested in their contributions and any allocated earnings or losses thereon. Participants are 100% in Employer non-elective contributions upon completing three years of service.

Forfeitures

If a participant terminates his or her employment with the Employer, the non-vested contributions plus allocated earnings thereon may be used to reduce future Employer contributions or pay administrative expenses. At June 30, 2024 and 2023, the forfeited non-vested account had a balance of \$6,580 and \$3,542. During 2024, no forfeitures were used to reduce Employer contributions or pay administrative expenses.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of Employer contributions, Plan earnings (losses) and administrative expenses. Allocations are based on a participant's earnings, account balances or specific participant transactions, as defined.

Notes Receivable from Participants

The Plan offers a loan feature whereby a participant (borrower) enrolled in the Plan may borrow a minimum amount of \$1,000 up to a maximum amount of 50% of their vested account balance or \$50,000 (whichever is less). Participants may only have one outstanding loan at a time. The interest rate is based on the prime rate plus 1%. Loans must be repaid within five years, unless the loan is used to purchase a participant's principal residence or the participant is on authorized leave for military service for a period which extends the maturity date of the loan beyond five years.

Loans to Participants/Collateralized Assets

The Plan offered a loan feature whereby a participant (borrower) enrolled in the Plan could borrow a minimum of \$1,000 up to a maximum of 50% of his/her vested balance or \$50,000 (whichever is less). Loans to the participant were made directly from Metropolitan Life Insurance Company ("MetLife"). The participant's account is not reduced by the loan amount, but serves as security for the loan, the loan amount is moved into a fixed income collateral account within the borrower's account. The loan must be repaid directly to MetLife within a five-year period in substantially equal payments (not less frequently than quarterly). The five-year repayment period will not apply to a loan that is used to acquire a principal residence of the borrower.

If the borrower does not repay the loan and related interest due in accordance with the schedule set forth in the promissory note or other writing permitted by applicable law representing the loan, their loan will be deemed in default and the borrower is not eligible to take out any new loans. Defaults in loans are treated as a distribution at the time of default against the participant's account.

At June 30, 2024 and 2023, there were 2 and 3 loans outstanding with principal balances due of \$38,568 and \$50,591 which represent a collateralization of participant accounts. Of these loan balances, none were in default as of June 30, 2024 and 2023.

Payment of Benefits

Upon termination of service due to death, disability, retirement, age 59 1/2 or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's interest in his or her account. In the event of an approved hardship distribution, any rollovers or contributions and applicable earnings are available to satisfy the immediate and heavy financial need of a participant.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”), which requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurement and Disclosure

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. The Plan’s investments, that were valued at fair value, were valued using level 1 inputs.

Investment Valuation and Income Recognition

All of the Plan’s investments are stated at fair value except for the guaranteed investment contract, which is valued at contract value since it is fully benefit-responsive. The guaranteed investment contract is valued by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the credit worthiness of the issuer. Mutual funds held by the Plan are valued at fair value based on the daily closing price as reported by the funds. All of the mutual funds are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily net asset value and to transact at that price.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and a distributable event occurs (retirement, termination, death), the participant loan balance is reduced and a benefit payment is recorded. Until a distributable event occurs, the loan will continue to have a balance and accrue interest.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Fees related to the administration of the Plan are paid directly by the Plan and are included in these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Reclassifications

Certain 2023 amounts were reclassified to conform with the 2024 presentation.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is February 26, 2026.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at June 30, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended June 30, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Metropolitan Life Insurance Company and Capital Bank and Trust Company (“Capital Bank”), qualified institutions.

4. Investments

MetLife Guaranteed Fixed Account, at Contract Value

The guaranteed fixed account (the “Fixed Account”) is guaranteed by MetLife and is backed by the full faith and credit of MetLife’s general account. The general account invests primarily in bonds, commercial, agriculture and real estate mortgages, real estate and corporate equities. MetLife will declare and guarantee an interest rate for each new contribution or premium. Upon renewal, MetLife will declare a new interest rate for that contribution or premium and its accumulated earnings. The Fixed Account is a fully benefit-responsive contract and is reported at contract value on the statements of net assets available for benefits. Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: amendments to the Plan documents, changes to the Plan’s prohibition on completing investment options or deletion of equity wash provisions, bankruptcy of the Plan sponsor other Plan sponsor events, the failure of the trust to qualify for exemption from federal income taxes or any required prohibited exemption under ERISA or premature termination of the contract. The plan administrator does not believe that any events would limit the Plan’s ability to transact at contract value.

5. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in Employer contributions.

6. Tax Status

The Plan has adopted a volume submitter plan document effective January 1, 2018 which is intended to satisfy the Internal Revenue Service's final 403(b) regulations. The volume submitter document preparer received an opinion letter dated March 31, 2017 from the Internal Revenue Service. The Employer believes that the Plan is designed and currently being operated in accordance with applicable sections of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Party-in-Interest

Certain Plan investments are managed by MetLife and Capital Bank. MetLife and Capital Bank are the custodian and trustee for the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA and are reflected in the statements of net assets available for benefits.

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

8. Prohibited Transactions

During the 2024 Plan year, the Employer failed to transmit to the Plan certain participant's contributions totaling \$3,900 within the period described by Department of Labor regulations. Delays in remitting these amounts to the Plan were due to an administrative oversight. The Employer is in the process of calculating and remitting lost earnings.

9. Risks and Uncertainties

The Plan's investments include investment securities that, in general, are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
