**Note 1 – Description of Plan**

The following description of the Hammill Manufacturing Company 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan sponsored by the Hammill Manufacturing Company (the Plan Administrator and Company). Generally, all employees who have completed three months of service and have attained the age of 18 are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, an allocation of the Plan's earnings (losses) based upon participant account balances, and is charged with an allocation of administrative expenses (if any). Participants direct the investment of their contributions among the investment funds offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the vested value of the participant's account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms of the loan are based on the terms of the individual promissory note. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest are paid through payroll deductions over a term not exceeding five years unless for loans issued for the purchase of a principal residence.

Contributions

Participants may elect to make pre-tax or Roth contributions, not to exceed Internal Revenue Code (IRC) limitations. Upon satisfying the eligibility requirements, participants that do not otherwise make an election will be automatically enrolled in the Plan with a pre-tax deferral rate of 6%. Participants over age 50 may make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Company provides a safe harbor matching contribution equal to 100% of participant contributions up to 1% of eligible compensation plus 50% of participant contributions exceeding 1% up to 6% of eligible compensation.

Payment of Benefits

On termination of service, death, disability, or retirement, a participant's vested account balance is payable as a lump sum distribution, as further defined in the Plan document. In-service distributions are permitted upon attainment of age 59 ½. The Plan provides for normal retirement at age 65.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Safe harbor matching contributions (plus related earnings (losses)) are 100% vested after two years of service. Company contributions prior to July 1, 2021, (plus related earnings (losses)) are fully vested after completing six years of service as follows:

Forfeitures

Forfeitures may be used to reduce future Company contributions or pay plan expenses, as further defined within the Plan document. Employer contributions were reduced by \$9,416 and \$3,187 from forfeited nonvested accounts during 2025 and 2024, respectively.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their accounts.

**Note 2 – Significant Accounting Policies**

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In contrast, contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. There have been no changes in the valuation methods used. The Plan's investments are held by Transamerica Trust Company and Transamerica Financial Life Insurance Company Inc. (TFLIC) for the 2025 plan year (Reliance Trust Company and TFLIC for the 2024 plan year), the Custodians.

Mutual funds represent investments with various investment managers. The fair values of these investments are determined by reference to the fund's underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are valued at net asset value.

The Transamerica Stable Value Strategy Account is a fully benefit-responsive investment contract valued at contract value, which represents deposits and transfers made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent outstanding loans and are measured at their unpaid principal balance plus accrued interest.

Administrative Expenses

Administrative expenses are paid by the Company or by the Plan, as permitted in the Plan document. Expenses related to a loan or distribution withdrawal is paid from the respective participant's account. The services are rendered by parties-in-interest to the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that could affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through March 4, 2026, the date the financial statements were available to be issued.

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at June 30, 2025 and 2024, net appreciation (depreciation) of investments, and dividends and interest for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Custodians.

**Note 4 – Investment Contract**

The Plan holds a traditional investment contract that meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract issuer declares a guaranteed interest rate that applies for a six month period, after which it is reviewed for resetting. There is no stated minimum or maximum interest rate.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value without adjustment. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer. The contract permits the issuer or the Plan to terminate the agreement as defined in the contract.

**Note 5 – Fair Value Measurements**

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels within the fair value hierarchy. The three levels are described below:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

**Note 5 – Fair Value Measurements (continued)**

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments valued at fair value in the statements of net assets available for benefits as of June 30, 2025 and 2024 are all mutual funds, which are Level 1 investments within the fair value hierarchy.

**Note 6 – Income Tax Status**

The Internal Revenue Service ruled on November 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan With CODA document (the underlying document upon which the Plan is based) qualifies under Section 401 of the IRC and the related trust is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 7 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.



