Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

(1) Description of Plan

The following description of the Target RWE, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution profit-sharing plan covering all employees of Target RWE, LLC (the Company), who had attained the age of 21 and had completed three months of service, except employees who were nonresident aliens or residents of Puerto Rico. The Plan was subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The 401(k) plan committee was responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective March 1, 2025, the Plan was amended and renamed from Target PharmaSolutions, Inc. 401(k) Plan to Target RWE, LLC 401(k) Plan.

Plan Merger

Effective July 15, 2025, the Plan merged with and into the SuccessWise Pooled Employer Plan (the SuccessWise PEP). All participants and their surviving beneficiaries in the Plan immediately prior to the effective date (the Transferred Participants) will become participants of the SuccessWise PEP as of the effective date and the Transferred Participants will no longer be eligible to participate in the Plan. As a result of the merger to the SuccessWise PEP, during the period ended July 31, 2025, \$8,600,568 of plan assets were transferred to another trust for the benefit of the Transferred Participants.

Contributions

Participants could contribute up to 90% of eligible compensation, as defined by the Plan. Annual salary deferrals (pre-tax and Roth) were limited to the maximum allowable amount under the Internal Revenue Code (IRC) (\$23,500 in 2025). Participants who had attained age 50 before the end of the year were eligible to make catch-up contributions (a maximum of an additional \$7,500 during 2025). Participants could also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Additionally, the plan permitted certain rollover contributions from traditional IRAs that were eligible and would otherwise be includible in gross income. Participants directed the investment of their contributions into various investment options offered by the Plan. The Company included safe harbor matching provisions whereby safe harbor matching contributions were made in an amount equal to equal to 100% of participant elective deferrals up to 3% of the participant's compensation plus 50% of participant elective deferrals between 3% and 5% of the participant's compensation.

Participants' Accounts

Each participant's account was credited with the participant's contributions and Company safe harbor matching contributions, as well as an allocation of plan earnings. Participant accounts were charged with an allocation of administrative expenses that were paid by the Plan. Allocations were based on specific participant transactions, as defined. The benefit to which a participant was entitled was the benefit that could be provided from the participant's vested account.

Vesting

Participants were immediately vested in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans were secured by the balance in the participant's account. The loan interest rate, determined monthly, was set at 2% above the prime rate, as defined. Principal and interest were paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant with an account balance in excess of \$5,000 could elect to receive either a lump-sum amount equal to the value of his or her account, or payments of agreed upon installments. A terminated participant with an account balance less than \$5,000, without respect to rollover balances, would receive a lump-sum payment of the balance. The Plan allowed for in-service distributions if a participant reached age 59 ½ and hardship distributions subject to Plan provisions. Distributions that did not represent distributions of the participant's full account balance had to be greater than \$500.

Forfeitures

At December 31, 2024, forfeited non-vested accounts totaled \$172. Forfeitures could be used to restore participants' accounts, pay plan expenses, and reduce employer contributions. There were no forfeitures used during the period from January 1, 2025, through July 31, 2025. Remaining forfeitures at the time of the plan merger of \$175 were transferred to the SuccessWise PEP.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan were prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America required the plan management to make estimates and assumptions that affected the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could have differed from those estimates.

Investment Valuation and Income Recognition

Investments were reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determined the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from the Company were recorded in the year in which the employee contributions were withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income was recorded on the accrual basis. Related fees were recorded as administrative expenses and were expensed when they were incurred.

Payment of Benefits

Benefits were recorded when paid.

Expenses

Certain administrative expenses of the Plan were paid by the Company and were excluded from these financial statements. Participant transaction fees were charged directly to the participant's account and were included in administrative expenses. Investment related expenses were included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through February 17, 2026, the date the financial statements were available to be issued.

(3) Investment Information Certified by the Qualified Institutions

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (Reliance), a qualified institution.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements, including investments and notes receivable from participants held at July 31, 2025, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the period from January 1, 2025 through July 31, 2025, was obtained by management and agreed to or derived from information certified as complete and accurate by ADP Retirement Trust Services, LLC (ADP Trust), a qualified institution.

Reliance held the Plan's investments as of December 31, 2024. ADP Trust held the Plan's investments until the assets were transferred to the SuccessWise PEP on July 31, 2025, as a result of the merger described in Note 1, and executed investment transactions for the period from January 1, 2025, through July 31, 2025.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the NAV of units of a common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

There were no significant transfers among investment levels during the period January 1, 2025 through July 31, 2025, and the year ended December 31, 2024.

(5) Related Party and Party-In-Interest Transactions

Automatic Data Processing (ADP) was the record keeper. Reliance was the plan trustee as of December 31, 2024, and ADP Trust was the plan trustee for the period from January 1, 2025, through July 31, 2025. Transactions with these entities qualified as party-in-interest transactions. Fees paid to ADP for recordkeeping services totaled \$1,742 for the period January 1, 2025, through July 31, 2025.

(6) Tax Status

The Plan used a non-standardized pre-approved prototype plan document sponsored by ADP, LLC. The IRS had determined and informed ADP, LLC by a letter dated October 6, 2020, that the Plan and related trust were designed in accordance with applicable sections of the IRC. Although the Plan had been amended since receiving the opinion letter, the Plan administrator believed that the Plan was designed and was operated in compliance with the applicable requirements of the IRC and therefore believed that the Plan was qualified and the related trust was tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan was subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
