Notes to Financial Statements

1. Description of Plan

The following description of the Scientific Systems Company, Inc. Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan that covers all employees, of Scientific Systems Company, Inc. (the "Employer"), excluding union employees, nonresident aliens, and employees whose employment classification would meet the requirements of an intern. Employees of Scientific Systems Company, Inc. who have completed 1 month of service and are age 21 or older are eligible to participate in the Plan (the "Participants"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"). The Employer is responsible for oversight of the Plan. The Plan's management determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Employer. All investments are participant directed.

Fidelity Management Trust Company ("FMTC" or the "Custodian") provides asset custodian services. Fidelity Workplace Services, LLC ("FWS" or the "Recordkeeper"), an affiliate of FMTC, provides recordkeeping services and executes investment transactions. Fidelity Investments, an affiliate of FMTC, manages the investments in the Plan.

Plan administration

The Employer is the plan administrator and has the authority to appoint person(s) or entities to carry out the operation of the Plan. One of the officers of the Employer serves at the Plan's Trustee. Individual participant accounts may be charged directly with an allocation of administrative expenses, if not paid by the Employer. Individual participant accounts are charged directly for loan recording, if applicable.

Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined in the plan document on a pre-tax or roth basis not to exceed a dollar limit established under the Internal Revenue Code (the "IRC"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans ("Rollover").

The Employer, at its discretion, may elect to make matching contributions as determined by its Board of Directors. To be eligible for the employer matching contribution, Participants must be contributing to the Plan. For the year ended May 31, 2025, the Employer elected to make matching contributions equal to 50% of each participant's elective deferral up to 6% of the participant's eligible compensation. For the year ended May 31, 2025, the Employer made matching contributions of \$509,864.

The Employer, at its discretion, may elect to make an Employer non-elective contribution to the Plan as determined by the Board of Directors. Employer non-elective contributions are allocated based on participants' compensation. Participants must be employed on the last day of the plan year and must have completed one year of service with 1,000 hours during the Plan year. For the year ended May 31, 2025, the Employer elected to not make any Employer non-elective contributions.

1. Description of Plan (continued)

Participant accounts

Each participant's account is credited with the participant's contributions, Employer matching contributions, allocations of the Employer's non-elective contributions and an allocation of the Plan's earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and employer matching contributions plus actual earnings thereon. Vesting in the Employer's non-elective contribution is based on years of continuous service as follows:

1 year	20%

3 years	70%
4 years	100%

Notes receivable from participants

Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear a reasonable interest rate, determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions or by check if the employee has terminated employment. Terms range up to 5 years or greater for the purchase of a primary residence. Loans to Participants are reported as notes receivable from participants at the unpaid principal balance plus any accrued but unpaid interest.

Interest rates for outstanding loans range from 3.25% to 9.50% at May 31, 2025 and 2024, and mature through December 2031.

Payment of benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. The payment can either be a cash distribution to the participant, subject to income tax withholdings, or a cash rollover into an individual retirement account or another qualified plan as defined. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of lump sum cash payment or into an individual retirement account.

In service withdrawals are permitted upon reaching age 59 1/2 or out of a participant's rollover account balance. In addition, the Plan allows for hardship distributions if certain criteria are met. Hardship withdrawals may be taken from the Participant's deferral contribution account.

Forfeited accounts

A Participant who leaves the Employer will forfeit any non-vested balance at the earlier of 1) the last day of the plan year in which the Participant has been separated from the Employer for five years or 2) the day in which the Participant requests a full distribution of their vested account balance. At the Employer's discretion, forfeited balances may be used to pay administrative expenses and to reduce Employer contributions in the year of forfeiture. At May 31, 2025 and 2024, forfeited nonvested accounts totaled \$89,557 and \$71,623, respectively.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

The Plan's group annuity contract is reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive contracts because contract value is the amount participants would received if they were to initiate permitted transaction under the terms of the Plan. See Note 5 for information on the group annuity contracts.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded as soon as a distributable event occurs.

Payment of Benefits

Benefits are recorded when paid.

2. Summary of Accounting Policies (continued)

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which is January 29, 2026.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at May 31, 2025 and 2024.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

4. Information Certified by Custodian (Unaudited)

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for the years ended May 31, 2025 and 2024. Accordingly, Fidelity Management Trust Company, the Custodian of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of May 31, 2025 and 2024, and the supplemental Schedule H, Part IV, Line 4(i) - Schedule of Assets (Held at End of Year) as of May 31, 2025, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended May 31, 2025.

5. Group Annuity Contract

The Plan holds a fully benefit-responsive group annuity contract, issued by Lincoln National Life Insurance Company ("Lincoln National") called the Lincoln Stable Value Fund (the "Lincoln Investment Contract"), for which contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The Lincoln Investment Contract issuer is contractually obligated to repay the principal and as a specified interest rate to the Plan, subject to the claims paying ability of Lincoln National. Participants invested in the Lincoln Investment Contract through the Lincoln Stable Value Fund.

As the Lincoln Investment Contract is fully benefit-responsive, contract value is the relevant measurement for the portion of net assets available for benefits attributable to the Lincoln Investment Contract. Contract value, as reported to the Plan by Lincoln National represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. Participants may have requested a lump sum distribution with a market value adjustment determined by Lincoln National.

The Lincoln Investment Contract is maintained under a group annuity contract which guarantees minimum interest rates and may credit interest that exceeds the minimum guaranteed rate. The crediting interest rate is based on several factors determined by Lincoln National including mortality and expense risks, interest rate guarantees, investment income earned on invested assets and amortization of any capital gains or losses from the sale of invested assets. Such interest rates are reviewed on a quarterly basis for resetting. During 2025, the average yield earned by the Plan was equal to the yield earned (i.e. interest credited) on the group annuity contract, which was 2.94%. The crediting interest rate may not be less than 1.00%. There were no reserves against contract value for credit risk of the contract issuer or otherwise.

5. Group Annuity Contract (continued)

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Such events include:

1. amendments to the Plan documents (including complete or partial Plan termination or merger with another plan);
2. changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions;
3. bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan;
4. the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or,
5. premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Such events include:

1. an uncured violation of the Plan's investment guidelines;
2. a breach of material obligation under the contract;
3. a material misrepresentation; or,
4. a material amendment to the agreement without the consent of the issuer.

6. Related-Party and Party In Interest Transactions

Plan investments include funds that have been managed by an affiliate of FMTC. Therefore, these transactions qualify as exempt party-in-interest transactions. Administrative fees of \$96,111 were paid to FMTC during 2025. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their employer contributions. Any unallocated assets of the Plan will be allocated to participant accounts and distributed in such a manner as the Employer may determine.

8. Tax Status

The underlying volume submitter profit sharing plan has received its latest opinion letter from the Internal Revenue Service ("IRS"), dated June 30, 2020, stating that the form of the Plan is qualified under section 401(a) of the IRC and that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Any employer adopting this form of the Plan will be considered to have a plan qualified under section 401(a) of the IRC. The Plan has been amended since receiving the opinion letter; however, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan is qualified and the related trust is tax-exempt as of the date of this report.

8. Tax Status (continued)

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. It is the Plan's policy to account for any uncertainties as described under the income tax laws. Under the income tax laws, the tax-exempt status of the Plan is considered to be a tax position. No such uncertain tax positions have been recognized by the Plan.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for the years prior to May 31, 2022.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
