## INDEPENDENT AUDITOR'S REPORT

To the Independent Fiduciary of the  
UFCW Local 174 Pension Fund

### Qualified Opinion

We have audited the financial statements of the UFCW Local 174 Pension Fund (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (liquidation basis of accounting) as of June 30, 2025 and 2024, and the related statements of changes in net assets available for benefits (liquidation basis of accounting) for the years then ended, and the related notes to the financial statements.

In our opinion, except for the possible effects of the matter discussed in the Basis for Qualified Opinion section of our report, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits (in liquidation) of the Plan as of June 30, 2025 and 2024, and the changes in its net assets available for benefits (in liquidation) for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

### Basis for Qualified Opinion

As more fully described in Note 6 to the financial statements, the future collectability of the withdrawal liability receivables is uncertain. Due to this uncertainty, an allowance for credit losses for the entire withdrawal liability receivables totaling \$5,449,678 and \$5,869,555 were recorded as of June 30, 2025 and 2024, respectively.

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our qualified audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

## **Auditor's Responsibilities for the Audit of the Financial Statements**

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### **Report on Supplemental Information**

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The Schedules of Administrative Expenses are presented for the purpose of additional analysis and are not a required part of the financial statements. Such information is the responsibility of the Plan's management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. In our opinion, the information in the accompanying schedules is fairly stated, in all material respects, in relation to the financial statements as a whole.

## NOTES TO FINANCIAL STATEMENTS

JUNE 30, 2025 AND 2024

### NOTE 1. DESCRIPTION OF THE PLAN

The following brief description of the UFCW Local 174 Pension Fund (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description for more complete information.

The Plan was established February 1, 1953, pursuant to collective bargaining agreements between individual employers and the United Food and Commercial Workers Local Union 174 (Local 174), which subsequently merged with United Food and Commercial Workers Local Union 342 (Local 342), and predecessor labor unions to provide retirement, death, and disability benefits for eligible participants. The Plan is a multiemployer defined benefit pension plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was originally financed primarily by employer contributions as specified in individual collective bargaining agreements between Local 342 and employers. As discussed in Note 3, the employers' obligation to continue to contribute under the collective bargaining agreements ceased for periods after June 30, 2007. As of July 1, 2007, the Plan is financed by withdrawal liability contributions. During the year ended June 30, 2016, the Plan also began receiving quarterly contributions from the Pension Benefit Guarantee Corporation (PBGC).

Effective June 30, 2007, the accrual of all future service under the Plan ceased. All participants meeting the vesting requirements at that time maintain the right to receive benefits at their existing level of benefits in all existing forms. Those participants not meeting the vesting requirements of the Plan at such date forfeited rights to receive any benefits under the Plan.

### NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Method of Accounting** - The financial statements are prepared using the liquidation basis of accounting. Accounting principles generally accepted in the United States of America require financial statements be prepared on the liquidation basis of accounting when an entity is in liquidation or when liquidation is imminent.

**Actuarial Present Value of Accumulate Vested Benefits** - Accrued vested benefits are those future periodic payments, including lump-sum distributions, that are attributable under the Plan's provisions to the service which employees have earned through the date of termination. Accrued vested benefits include benefits expected to be paid to (a) participants and beneficiaries eligible for benefits and (b) vested participants or beneficiaries eligible for benefits. The Plan was frozen as of July 1, 2007. Participants will receive no additional service credits after June 30, 2007. Benefits earned prior to that date are payable to those currently receiving benefits and to vested participants when they reach retirement age.

## **NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)**

**Funding Policy and Revenue Recognition** - Income is recognized when withdrawal liability payments are received from employers due to the uncertainty that the assessments will be paid in full. Withdrawal liability payments are accounted for as exchange transactions. A withdrawal liability receivable will be recorded if an employer remits a required payment due during the year, subsequent to the end of the year.

**Payment of Benefits** - Benefit payments to participants are recorded upon distribution.

**Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

## **NOTE 3. TERMINATION**

On June 30, 2007, the Plan was terminated by mass withdrawal as defined by ERISA Section 4041A(a)(2). The Trustees have exercised their right to terminate the Plan. Termination shall not permit any part of the Plan assets to be used for or diverted to purposes other than the exclusive benefit of the pensioners, beneficiaries, and participants. The net assets of the Plan will be allocated to pay benefits in priorities as prescribed by ERISA and its related regulations. Whether or not a particular participant will receive full benefits at some future time will depend on the sufficiency of the Plan's net assets at the time and the priority of those benefits.

The Trustees of the Plan notified the Pension Benefit Guarantee Corporation (PBGC) that the Plan had terminated by mass withdrawal on June 30, 2007. On February 29, 2016, the Plan issued a notice of insolvency to the PBGC. In connection with this notice, the Plan submitted an application for financial assistance requesting that the PBGC provide supplemental funding for payment of benefits and reasonable administrative expenses incurred by the Plan after the depletion of existing plan assets.

In addition, certain benefits under the Plan are insured by the Pension Benefit Guaranty Corporation (PBGC). Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. The PBGC does not guarantee all types of benefits and the amount of any individual participant's benefit protection is subject to certain limitations. Some benefits may be fully or partially provided for while other benefits may not be provided at all.

During the year ended June 30, 2016, the Plan began receiving quarterly contributions from the PBGC so that the Plan could continue to operate and pay benefits. The PBGC considers its funding to be a promissory note but they do not expect repayment as the Plan is insolvent. Based on the present PBGC regulations, the Plan expects each participant's pension benefits to be guaranteed by the PBGC.

The Plan became insolvent effective July 1, 2016.

#### NOTE 4. TAX STATUS

The Plan obtained its latest determination letter on October 2, 2015, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements under Section 401(a) and was, therefore, exempt from Federal income taxes under the provisions of Section 501(a). The Plan Trustees and Plan Counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances of the Plan.

#### NOTE 5. ACTUARIAL INFORMATION

Actuarial valuations of the Plan were made by the consulting actuary as of July 1, 2024. Information shown in the reports included the following:

The Plan's present value of accrued vested benefits as of June 30, 2024 totaled \$94,226,060. The net assets available for benefits as of the same date amounted to \$1,753,829. The value of nonforfeitable benefits exceeds the value of Plan assets by \$92,472,231 at June 30, 2024.

The Trustees of the Plan are required under Section 4281(b) of the Employee Retirement Income Security Act of 1974 (ERISA), as amended, to determine annually whether the value of nonforfeitable benefits exceed the value of Plan assets, including claims for withdrawal liability owed to the Plan. When the value of the benefits exceeds the value of assets, the Plan shall be amended to reduce benefits to the extent necessary to ensure that the Plan's assets are sufficient to discharge, when due, all of the Plan's obligations, with respect to nonforfeitable benefits.

**NOTE 5. ACTUARIAL INFORMATION (continued)**

Benefits are computed in accordance with the terms and provisions of the Plan on the date the participant left employment of the participating employer. At June 30, 2007 (date of termination), the normal retirement benefit was \$20.00 per month per year of past service (i.e., service earned prior to January 1, 1987), plus \$30.00 per year of service between January 1, 1987, and December 31, 1995, plus \$33.50 per year of service between January 1, 1996, and December 31, 1998, plus \$40.00 per year of benefit service after January 1, 1999, with no maximum. No benefits accrue after June 30, 2007. Since the Plan became insolvent, the monthly benefit is limited to the PBGC maximum guaranteed benefit.

The Plan's present value of accrued vested benefits was determined as of June 30, 2007, in accordance with Pension Benefit Guaranty Corporation (PBGC) Regulation Part 4281, Subpart B-Valuation of Plan Benefits and Plan Assets Following Mass Withdrawal. The interest rates, mortality tables, and loading assumptions are set out in that regulation. For the valuation as of June 30, 2024, the interest rate used was 5.50% per annum for the first 20 years and 4.83% per annum thereafter. The mortality assumption is prescribed by Appendix A of PBGC regulation 4044 at June 30, 2024.

The Plan became insolvent effective July 1, 2016.

**NOTE 6. WITHDRAWAL LIABILITY**

On June 30, 2007, the Plan was terminated by mass withdrawal. The Plan is currently financed by withdrawal liability contributions and PBGC funding. Withdrawal liability for each employer was calculated by the Plan's actuary. As employers settle to pay their liability in lump sum payment, a large portion of original assessment might be written off. Employers have been and continue to make quarterly withdrawal liability payments to the Plan. Since the Plan is in mass withdrawal, quarterly withdrawal payments are due in perpetuity. Due to the perpetual duration of the payment schedules it is uncertain that all payments will be collected. Due to the uncertainty in the future collectability of the withdrawal liability assessments, an allowance for credit losses is provided for the entire balance of withdrawal liabilities receivable as of June 30, 2025.

**NOTE 7. RISKS AND UNCERTAINTIES**

Plan withdrawal liability payments are determined and the actuarial valuation after mass withdrawal of accrued vested benefits are reported, based on certain assumptions pertaining to interest rates, inflation rates, and participant demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

**NOTE 8. CASH CONCENTRATIONS**

The Plan places its cash with financial institutions deemed to be credit worthy. Cash balances may at times exceed the insured deposit limits of \$250,000.

**NOTE 9. SUBSEQUENT EVENTS**

The Plan has evaluated subsequent events through March 3, 2026, the date the financial statements were available to be issued, and they have been evaluated in accordance with relevant accounting standards.
