INDEPENDENT AUDITOR'S REPORT

Board of Trustees

Opinion

We have audited the financial statements of Maritime Industry Welfare Benefit Trust (the "Plan", "Trust"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTES TO THE FINANCIAL STATEMENTS

NOTE 1 – DESCRIPTION OF THE TRUST

The following description of the Maritime Industry Welfare Benefit Trust (the “Plan”, “Trust”) is provided for general information purposes only. Participants should refer to the Trust agreement for a complete description of the Trust's provisions.

General

The Trust was established on February 7, 1997, by Embarcadero Systems Corporation, now amended and restated as of December 1, 2019, by the Board of Directors for Ports America Group, Inc. (the “Company”, “Plan Sponsor”, “Plan Administrator” or “Ports America”). The Plan Sponsor adopted a defined benefit health and welfare plan (the “Plan”) on January 1, 2009 for the benefit of eligible employees, and their dependents, of the Company and certain participating affiliates (collectively, the “Employers”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan Sponsor administers the collection of premium payments from the Employers and remits them to Alliant Insurance Services, Inc. (“Alliant”), a third-party administrator (“TPA”) responsible for disbursing funds to insurance carriers and service providers for coverage under the Plan. Alliant also provides accounting and various benefits administration services. An employee of the Plan Sponsor serves as the Plan Trustee.

Health and Welfare Benefits

The Plan provides fully insured benefits through group insurance arrangements to eligible participants, and their dependents, of the Employers. Benefits include a variety of options such as long-term care, accidental death and dismemberment, child life insurance, legal assistance, long term disability, medical, commuter, supplemental life, short term disability, vision, and paid family leave coverage. Premiums for these benefits are paid from the assets of the Trust.

Eligibility

Employees are required to meet their specific Employer requirements to be eligible to participate in benefit plans offered. Participants will receive coverage for any month in which they remain eligible for the Plan and for which the Employers make contributions to the Plan on their behalf. Coverage will end at midnight on the last day of the month in which eligibility ceases. In the event that a participant or his/her dependents’ benefits are terminated, a continuation of coverage is made available as required under the Consolidated Omnibus Budget Reconciliation Act (COBRA). The participant may continue to receive benefits by making cost of coverage contributions under the employee self-payment program.

Contributions

The Plan Sponsor makes monthly contributions to the Trust on behalf of eligible employees who have enrolled in coverages offered by the Employers. Participants may be required to contribute towards premium costs through payroll deductions.

Administrative Expenses

Administrative expenses reported in the financial statements were funded by the Plan Sponsor. The funds remitted by the Plan Sponsor have been recorded as Employer contributions.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Trust have been prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and net assets available for plan benefits and changes therein and, when applicable, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Payment of Benefits

Fully insured benefits are recorded as incurred and are reflected as group insurance premiums in the accompanying statement of changes in net assets available for plan benefits.

NOTE 3 – PARTY-IN-INTEREST TRANSACTIONS

As described in Note 1, the Trust has a service provider arrangement with Alliant. Fees paid by the Trust to Alliant amounted to \$11,562 for the year ended December 31, 2024 and qualify as exempt party-in-interest transactions.

NOTE 4 – INCOME TAX STATUS

The Trust operates as a group insurance arrangement within the meaning of Department of Labor Regulation Section 2520.104a-6. The Trust has not applied for tax exemption. Management is not aware of activities that would generate taxable income.

NOTE 4 – INCOME TAX STATUS (Continued)

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken on an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. Plan management has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability, asset, or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to the participants and/or terminate the Plan or Trust at any time. Upon termination, further contributions to the Trust shall cease, and Plan assets will be used to pay premiums and administrative expenses. Any remaining surplus would be refunded to the participating Employers.

NOTE 6 – SUBSEQUENT EVENTS

The Plan Administrator has evaluated all activity through February 27, 2026, the date on which the financial statements were available to be issued.
