Note 1 - Plan Description

The following description of Wipfli LLP 401(k) Profit Sharing Plan (the "Plan") provides general information regarding the Plan. Participants should refer to the plan agreement for a more complete description of specific plan provisions.

General

The Plan was effective as of January 1, 1978 for all employees of Wipfli LLP (the "Partnership"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

To be eligible to make employee deferrals and to receive the employer match, a participant must have attained age 21. Partners and principals, other than contract partners and principals, are not eligible for matching contributions. To be eligible for an allocation of the employer discretionary nonelective contribution, the participant must have attained age 21, worked 600 hours during the plan year, and be employed on the last day of the plan year.

Contributions

Employees may defer their compensation, as defined in the Plan, up to the maximum allowed under the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. The Partnership may make discretionary nonelective contributions to those participants. When acquisitions and mergers occur, new employees may roll their balances into the Plan, which are reported as rollovers within the statement of changes in net assets available for benefits.

The Plan requires the Partnership to make matching contributions to eligible participants of 25 percent of the first 4 percent of elective deferrals contributed by the participant up to a maximum matching contribution of 1 percent of a participant's compensation.

The Plan provides for an automatic enrollment feature that includes an initial deferral contribution rate equal to 4 percent of eligible compensation, with annual increases of 1 percent per year until a maximum of 15 percent is attained.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balances. The participant notes receivable are secured by the balance in the participant's account and bear a market rate of interest.

Participant Accounts

Each participant's account is credited with the participant's contribution and the participant's share of the Partnership's contribution. Allocation of the plan earnings and expenses to participants' accounts is based on participants' proportionate shares of funds in each of the investment accounts. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

For nonelective contributions, participants receive 20 percent vesting per year beginning after one year of service. An employee must work 600 hours to be credited with a year of service. Employees are 100 percent vested at all times in their deferral and matching contributions.

Note 1 - Plan Description (Continued)

Payment of Benefits

Prior to December 1, 2016, all distributions were subject to the joint and survivor annuity requirements. Upon termination of service, the participant could elect a life annuity, a 50 percent joint and survivor annuity, a 75 percent joint and survivor annuity, a lump-sum distribution, or installment payments. Effective December 1, 2016, the Plan was amended to offer participants either a lump-sum distribution or installment payments. The joint and survivor annuity option remains for prior contribution sources that are required to offer that form of benefit until the distribution occurs. Effective January 1, 2019, the Plan was amended to offer participants who have obtained age 59½ in-service distributions.

Forfeitures

Forfeitures are used to reduce the Partnership's nonelective contribution. The forfeitures balance at May 31, 2025 and 2024 was approximately \$604,000 and \$360,000, respectively. Forfeitures were used to offset the employer contribution receivable at May 31, 2025 and 2024 for each respective year.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared based on the accrual method of accounting.

Investment Valuation

The Plan's investments are stated at fair value.

The common collective trust funds are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. The money market fund, interest-bearing cash, and other similar investments are valued at fair value based on the outstanding balances. All other investments are valued based on quoted market prices reported in active markets.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Additionally, the Plan allows participants to invest in self-directed brokerage accounts. The self-directed brokerage accounts primarily include investments in mutual funds, interest-bearing cash, and common stock investments.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

All nonsettlor administrative expenses may be paid out of the Plan, unless paid by the Partnership. During the years ended May 31, 2025 and 2024, the Partnership paid the investment advisory and audit fees, with the remaining administrative expenses paid by the Plan.

Note 2 - Summary of Significant Accounting Policies (Continued)

Administrative expenses of approximately \$713,000 and \$499,000 for the years ended May 31, 2025 and 2024, respectively, were paid by the Partnership.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including February 6, 2026, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Vanguard Fiduciary Trust Company (the "Trustee") holds the Plan's investments and participant notes receivable and executes all related transactions. The investment and participant notes receivable balances and related income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

Note 4 - Fair Value Measurements (Continued)

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 5 - Tax Status

The Plan, as adopted, is a preapproved plan, which does not require an application for a determination letter from the Internal Revenue Service (IRS). The preapproved plan has received a favorable opinion letter from the IRS dated June 30, 2020. The Plan has not individually sought its own determination letter.

Note 6 - Plan Termination

Although it has not expressed any intent to do so, the Partnership has the right under the Plan to discontinue its contributions and to terminate or partially terminate the Plan subject to the provisions of ERISA. On the effective date of termination, participants will become fully vested in any funds that have been allocated to them. If only a partial termination occurs, a participant will become fully vested only if he or she is a member of the group of employees who are affected by the partial termination.

Note 7 - Subsequent Events

Effective December 1, 2025, the plan name, plan sponsor, and employer identification number were changed as a result of an ownership change with the Partnership. The new plan name is Wipfli Advisory LLC 401(k) Profit Sharing Plan, and the new plan sponsor is Wipfli Advisory LLC. Wipfli LLP, the former plan sponsor, remains a participating employer in the Plan.
